As mentioned in the notice to the extraordinary general meeting issued by the Company (the "EGM Notice"), the Circular No.CIR/CFD/POLICY CELL/7/2014 dated September 15, 2014 issued by the Securities and Exchange Board of India ("SEBI") requires all entities falling under the definition of related parties to abstain from voting irrespective of whether the entity is a party to the particular transaction or not. Accordingly, the EGM Notice provided that, amongst others, all the promoters of the Company, comprising Relay B.V.. (holding 54.78% of the share capital of the Company) and United Breweries (Holdings) Limited ("UBHL"), Kingfisher Finvest India Limited ("KFIL") and others (holding in aggregate 4.09% of the share capital of the Company), should abstain from voting on the special resolution.

However, United Breweries (Holdings) Limited (UBHL) (holding 2.90 % shares of the share capital of the Company) and Kingfisher Finvest India Limited (KFIL) (holding 1.14% of the share capital of the Company) have exercised their votes in favour of the Special resolution. Pursuant to the terms of the EGM Notice, the scrutinizer has invalidated the votes exercised by these entities.
