Notes to the financial results:

The Company has adopted Indian Accounting Standards ("Ind AS") from April 1, 2017 and accordingly, these financial results have been prepared in accordance with the relevant rules issued thereunder and the other accounting principles generally accepted in India. Consequently, results for the quarter and six months ended September 30, 2016 have been prepared to comply with Ind AS to make them comparable. The Ind AS adjustment, pertaining to quarter and six months ended September 30, 2016 have been prepared by the management and reviewed by the auditors.

This Statement has been reviewed by the Audit Committee and approved by the Board of Directors at its meeting held on December 9, 2017 and has been subjected to a limited review by Statutory Auditors of the Company.

3) The Company has opted to submit and publish Standalone financial results for the quarter ended September 30, 2017.

4) The Statement does not include ind AS compliant results and statement of assets and liabilities for the previous year ended March 31, 2017 as it is not mandatory as per Securities and Exchange Board of India ("SEBI") vide circular no. CIR/CFD/FAC/62/2016 dated July 5, 2016.







5) Revenue from operations for the period upto June 30, 2017 includes excise duty, which is discontinued effective July 1, 2017 upon implementation of Goods and Service Tax ("GST") in India. In accordance with Ind A5 18- "Revenue", GST is not included in Revenue from operations. In view of the aforesaid change, Revenue from operations for the quarter and six months ended September 30, 2017 are not comparable with previous periods. The following information is provided to facilitate such comparison:

7) The Board of Directors at it's meeting held on July 24, 2017 and Shareholders through Postal Ballot on Monday, September 4, 2017 has approved separation of Flexible Intermediate Bulk Containers' business at Pithampur ("Pithampur division") into a wholly owned subsidiary company. This would be done through process of slump sale of Pithampur division including assets, liabilities/ obligations of whatsoever nature and employees which are specific to the Pithampur division on a going concern basis to a wholly owned subsidiary company. The management is contemplating various options for the same.

8) The Company is engaged in only one Segment viz. Technical Textile. As such there is no separate reportable segment as per Ind AS 108 'Operating Segments'.

9) Previous period's figures have been regrouped / reclassified wherever necessary to correspond with the current period's classification / disclosure.

Limited Review Report

Review Report to The Board of Directors Flexituff International Limited

1. We have reviewed the accompanying statement of unaudited standalone financial results for the quarter and six months ended September 30, 2017 and financial position as on September 30, 2017 ('the Statement') of Flexituff International Limited ('the Company'), being submitted by the Company pursuant to the requirements of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 as modified by Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016 (Listing Regulations). Attention is drawn to the fact that the figures relating to corresponding quarter and six months ended September 30, 2016 between the previous GAAP and Indian Accounting Standards ("Ind AS"), as reported in these financial results have been approved by the Company's Board of Directors and reviewed by us.
