In terms of clause 41.1 of Instruction to Bidders, you shall deposit Performance Security for INR 14,05,21,150/- Indian Rupees Fourteen Crore Five Lakh Twenty-one Thousand One hundred Fifty Only) @ 10% of the Accepted Contract Amount of INR 1,405,211,498.55 (Indian Rupees One Hundred Forty Crore Fifty-two Lakh Eleven Thousand Four Hundred Ninety-eight & Fifty-five paisa Only) in shape of Bank Guarantee within 28 (twenty-eight) days of receipt of this Notification of Award in accordance with the Conditions of Contract, using for that purpose the Performance Security Form No. COF/3 included in Section 8 (Contract Forms) of the Bidding Documents. The validity of the above Bank Guarantee should cover completion period of 15 (fifteen) months plus defect liability period 6 (six) months and 28 (twenty-eight) days beyond the issue of "PERFORMANCE CERTIFICATE" from the date of issue of this letter of acceptance. - 3. The work shall be completed in all respect within the stipulated period (15 months + 06 months defect liability period) from the date of commencement of the work.
- 4. The contract agreement shall be sent to you shortly, which you shall sign with date and return to RVNL office within 28 (twenty-eight) days of your receipt. Till such time that a formal contract agreement is prepared and executed, this Notification of Award along with the documents mentioned under reference shall constitute a binding contract.
- 5. Failure to submit the above mentioned Performance Security as per Para-2 above or to sign the contract agreement shall constitute sufficient ground for the annulment of the award and forfeiture of the Bid Security.

- 6. Herein after this notification of award shall be called the "LETTER OF ACCEPTANCE".
- 7. Bonds, guarantees, undertakings, warrantees and insurances as stipulated in the bid documents as per the contract forms should be furnished.
- 8. It is also requested to ensure full compliance with the tax laws of India with regard to this contract and you shall be solely responsible for the same and submit copies of acknowledgements evidencing filing of returns every year and shall keep the Employer fully indemnify against your liability of tax, interest, penalty etc. in respect, thereof, which may arise.
- 9. It is requested to undertake not to use information, gained in the execution of the contract for any purpose without obtaining the prior approval of RVNL and shall not make any public announcement or divulge and materials related to the project either in India or Overseas without the prior consent of RVNL.
- 10. The rates quoted against Bill No. 2C (Bridge work: Supply of Steel items), Bill No. 9 (Site Facility), Bill No. 11(A) (Electronic Interlocking supply), Bill No. 11(B) (Underground Signalling Cables) and Bill No.19 (OHE-Ferrous other than Steel Structures and SPS) shall be banned for comparison.
