### Scrutinizer's Report

Sub.: Scrutinizer's Report for voting by the equity shareholders through remote e-voting and postal ballot forms in respect of passing of the resolution setout in the notice dated 14<sup>th</sup> December, 2022.

The Board of Directors of Zodiac-Jrd-Mkj Limited (hereinafter referred to as "the Company") at its Meeting held on 14th December, 2022 has appointed me as the Scrutinizer for the postal ballot / remote electronic voting ("e-voting") pursuant to Sections 108 and 110 of the Companies Act, 2013 read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, and other applicable provisions, if any, and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, for the resolution in respect of the matter as set out in the Notice of Postal Ballot proposed to be transacted by way of postal ballot / e-voting.

#### Management's Responsibility

The management of the Company is responsible to ensure compliance with the requirements of the relevant provisions of (i) the Companies Act, 2013 and the rules made thereunder; and (ii) the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, relating to postal ballot voting including voting by electronic means for the resolution stated in the Postal Ballot Notice. The management of the Company is also responsible for ensuring a secured framework and robustness of the voting systems.

#### Scrutinizer's Responsibility

My responsibility as a scrutinizer for e-voting process and postal ballot is restricted to making a Scrutinizer's report of the *votes* cast "in favour" or "against" by the members in respect of the resolution contained in the Postal Ballot Notice. My report is based on verification of data provided by Central Depository Services (India) Limited ("CDSL"), from the e-voting system and postal ballot forms received through post till the time fixed for closing of the voting process i.e. till 05:00 p.m. on 20th January, 2023.

#### Cut-off date

The Members of the Company as on the "cut-off" date as set out in the Notice i.e. Friday, 16<sup>th</sup> December, 2022 were entitled to *vote* on the resolution set out in the Notice and their voting rights were in proportion to their shareholding in the paid-up equity share capital of the Company as on the cut-off date.

#### Remote e-voting process / voting by postal ballot forms

- i. The remote e-voting period / voting by postal ballot forms remained open from Thursday, 22<sup>nd</sup> December, 2022 (09:00 a.m. IST) to Friday, 20<sup>th</sup> January, 2023 (05:00 p.m. IST).
- ii. The *votes* casted during the remote e-voting and votes casted through postal ballot forms were unblocked on Friday, 20th January, 2023 after the conclusion of voting period for Postal Ballot and was witnessed by two witnesses, Ms. Bhagyashree Kamble and Ms. Kavita Mishra, who are not in the employment of the Company and / or CDSL. - iii. Thereafter, the details containing, *inter alia*, the list of Members who voted "in favour" or "against" on the resolution were generated from the remote e-voting website of CDSL, i.e., at www.evotingindia.com. Based on the report generated by CDSL and relied upon by me, data regarding the remote e-voting was scrutinized on test check basis.
- iv. The postal ballot forms received by the post by the Registrar and Share Transfer Agent till the time fixed for closing of postal ballot, i.e., 05:00 p.m. on 20<sup>th</sup> January, 2023, were scrutinized and reconciled with the records maintained by the Registrar and Share Transfer Agent of the Company and authorisations lodged with the Registrar and Share Transfer Agent on test check basis.
