Sub.: TDS Certificate in respect of tax deducted at source on Final Dividend - FY 2022-23

As you are aware, Navin Fluorine International Limited ('the Company') has paid Final Dividend for the Financial Year 2022-23 on August 04, 2023 as recommended by the Board of Directors of the Company at its Meeting held on May 13, 2023 and declared at the 25th Annual General Meeting held on July 31, 2023.

Pursuant to the Income-tax Act, 1961, as amended by the Finance Act, 2020 and our communication dated June 09, 2023, the Company has deducted tax at source ('TDS') while making payment of the aforesaid Final Dividend at the prescribed rates only in respect of those shareholders whose dividend income exceeded the threshold limit during the said Financial Year and upon non-receipt of the valid exemption Form.
