Mumbai - May 17, 2017

Trigyn Technologies Limited on consolidated basis achieved a 9% growth YOY and the EBIDTA has been maintained at 10%. The Company achieved a growth rate of 14% QonQ on consolidated basis. On standalone basis, the Company saw a growth of 4% in revenue QonQ. The low EAT in standalone is due to weakening dollar forex rate. The company is in the process of expanding its domestic business and has made investment in various projects. The standalone YOY shows lower EAT due to onetime expenses that the company incurred on feasibility study for new project, Internal restructuring and operation cost of new office.

Trigyn's subsidiary in the US has been predominately hiring local talent and thus the current political condition will not affect the company's operation. The company sees a positive and fruitful year ahead due to expansion in the domestic market along with the current international contracts. Contrary to the current domestic trend, the company plans to increase hiring to meet the future plans in domestic market.
