Nature of complaint: The Complainant has filed a complaint with District Consumer forum Jhansi stating that he has not received refund of Rs. 47488/- towards SCI FPO.

Facts of the case:

The matter Mr Ashok Kumar Dubey had applied for SCI equity shares under SCI FPO 2010 through ASBA application and the application money was Rs. 56000/-. He was allotted 64 equity shares for Rs 8512/- . On allotment, he was advised by Karvy to contact his banker viz. SBI to find out the unblocking status of the remaining amount i.e. Rs. 47488/-. However, the complainant has approached District Consumer Forum Jhansi stating that he has not received the said refund amount from SCI.

It should be noted that under ASBA system, the application money remains blocked in the bank account of the applicant. If there is part allotment, the remaining amount gets unblocked on the basis of intimation from the Registrar to the Issue. The question of refund from the issuer does not arise.

Status as on date

Matter was listed for hearing in the District Consumer Forum Jhansi on 03.08.2016 and was adjourned to 13.09.2016 however the complainant was not present due to which hearing is adjourned to 03.11.2016. Since the hearing did not take place till date, next hearing is scheduled on 04.05.2017.
