### LIMITED REVIEW REPORT

To

1. We have reviewed the accompanying statement of unaudited financial results for the quarter ended 30<sup>th</sup> September, 2017 (the Statement) of AGRI-TECH (INDIA) LIMITED (the Company). 

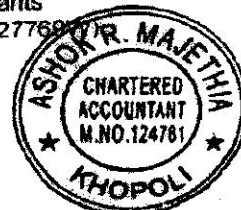
