Mumbai, April 11, 2017 - Palred Technologies Limited, a public listed company on NSE & BSE had earlier announced its board & shareholder approval for the preferential allotment of INR 22 crores.

PTL today announced that its Board, in the Meeting held on 11th April 2017, approved investment of INR 30 crores in its subsidiary Palred Online Technologies Private Limited which owns and operates LatestOne.com - India's largest e-tailer for mobile accessories. Post this investment, LatestOne.com will be valued at INR 225 crores.
