alleged misconduct by the ATS in connection with the disappearance of a witness. The NIA also alleged that an unnamed person appeared as an ATS man and planted explosives on premises being searched.

Sources in the ATS told the New Agency they had taken legal advice and would soon file the court they stood by their investigation in the case. The ATS had filed a chargesheet in 2008. Subsequently, the probe was handed over to the NIA.

"We have decided to file an affidavit in court stating that we stand by our investigations and that the charges against our officers are false. We had enough evidence against Sadhvi and other accused, and we will stand by the conduct of our officials and their

probe as we find them to have dispensed their duties honestly," said a senior ATS officer.

The NIA, in its chargesheet, had mentioned that they could not gather any evidence against Sadhvi, suggesting her direct involvement both in the conspiracy as well as execution of the blasts. It had stated that though the LML Freedom bike on which the bomb was planted belonged to Sadhvi, it was used by Ramsingh Kalsangra for some time, for which they had statements of three witnesses. "While the NIA gave a clean chit to three of the accused arrested by us, it chargesheeted 10 accused who we have arrested. How can it be that the evidence against some accused.

## U'khand govt in a fix over granting extension to Power Corp MD

Uttarakhand government is in a dilemma over granting extension to Power Corporation Managing Director S S Yadav who is embroiled in a sting controversy. Yadav's tenure as the head of state power corporation comes to an end on July 24. Considered close to the corridors of power, Yadav is keen on an extension but with a sting CD purportedly showing the official allegedly taking money from someone in public domain, the state government finds itself in a fix over his extension. The sting video was shown by many channels and it also went viral on the social media last month prompting Congress to ask Chief Minister Harish Rawat to send the official on forced leave till his name is cleared in the controversy. Though PCC chief Kishore Upadhyay's demand was not conceded, the CM instituted an inquiry headed by Additional Secretary Niraj Khairwal into the controversial CD.

However, official sources on request of anonymity here said the probe had made no progress till date. Main opposition BJP and Aam Aadmi Party (AAP) have been strongly opposing extension to Yadav and also demanding a CBI probe into his functioning as the state power corporation MD.

When asked whether or not Yadav will be given an extension, Chief Minister's media adviser Surendra Kumar evaded a direct reply saying "an appropriate decision will be taken when the time comes.
