- PAT-loss for H1 FY 2016 is Rs 16.9 Crs against PAT-loss of Rs 28.7 Crs in H1 FY 2015

- Revenues for Q2 FY 2016 are at Rs 211.5 Crs from Rs 222.4 Crs in Q2 FY 2015

- PAT-loss for Q2 FY 2016 is Rs 17.0 Crs against PAT-loss of Rs 9.2 Crs in Q2 FY 2015
