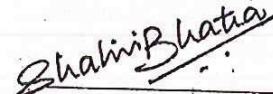

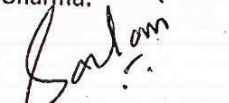

**Sub:** Scrutinizer's Report (Combined) on E-voting, Postal ballot and Poll conducted in the Twenty Fourth Annual General Meeting of the Company in terms of provisions of the Companies Act, 2013 and rules made there under.

1. The Board of Directors of Innoventive Industries Limited (the Company) have appointed me as a Scrutinizer for the process of e-voting held between 20<sup>th</sup> November, 2015 (9:00 a.m. IST) to 22<sup>nd</sup> November, 2015 (5:00 p.m. IST) and of the ballots received by post from shareholders. Further, the Chairman of the 24<sup>th</sup> Annual General Meeting (AGM) has appointed me as the Scrutinizer for the poll conducted at the aforesaid AGM held on 23<sup>rd</sup> November, 2015 at 9:30 a.m.
2. The Company had appointed Karvy Computershare Private Limited (Karvy) as the service provider for extending the e-voting facility to the shareholders of the Company and Karvy is also the Registrar and Share Transfer Agent of the Company. The e-voting results were unblocked by me on 23<sup>rd</sup> November, 2015 in the presence of two witnesses viz. CS Shalini Bhatia and CS Saloni Sharma.

3. The Company had also extended the option of voting through ballot for shareholders who could not participate in e-voting or who could not be present for the meeting.
  4. At the 24<sup>th</sup> AGM of the Company held on 23<sup>rd</sup> November, 2015, the Chairman of the Company had, as statutorily required, called for a poll to facilitate members present in the meeting who could not participate in e-voting and postal ballot to record their votes through the poll process.
  5. The management of the Company is responsible to ensure the compliance with the provisions of the Companies Act, 2013 and rules relating to voting through electronic means and poll on the resolutions contained in the notice of the 24<sup>th</sup> AGM of the members of the Company.
- My Responsibility as a Scrutinizer for the e-voting process, ballot by post and for the poll at the AGM is restricted to make a Scrutinizer Report for the votes cast "in favour" or "against" the resolutions contained in the notice of the 24<sup>th</sup> AGM, based on the reports generated from the e-voting system provided by Karvy.
6. I have issued separate Scrutinizer Report dated 24<sup>th</sup> November, 2015 on the Poll conducted during the 24<sup>th</sup> AGM.
