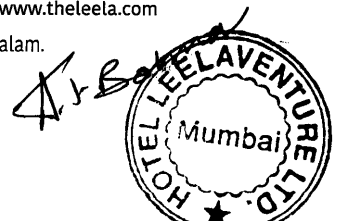

Sub: Result of Postal Ballot conducted by Hotel Leelaventure Limited, (the Company), under Section 110 of the Companies Act, 2013 ("the Act") read with the Rule 22 of the Companies (Management and Administration) Rules, 2014.

1. The Board of Directors of the Company at its meeting held on 19<sup>th</sup> September, 2015 had appointed me as a Scrutinizer for conducting the postal ballot voting process under provisions of Section 110 of the Companies Act, 2013 ("the Act") read with the Rule 22 of the Companies (Management and Administration) Rules, 2014, in respect of Postal Ballot Notice dated 19<sup>th</sup> September, 2015 for the below mentioned Resolution:

My responsibility as a scrutinizer for the voting process is restricted to make a Scrutinizer's report of the votes cast "In favour" or "against" the resolution stated above, based on the physical ballot paper received from the members and report generated from the e-voting system provided by the NSDL, the Authorized agency engaged by the Company to provide e-voting facilities.

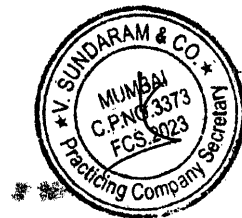


