INDEPENDENT AUDITORS' REVIEW REPORT

To
The Board of Directors

We have reviewed the accompanying statement of unaudited financial results of **Abhayam Trading Limited** ("the Company") for the Quarter ended 30th September, 2016 which are included in the accompanying "statement of standalone unaudited results for the Quarter ended 30th September, 2016" (the "Statement"). The statement has been prepared by the company pursuant to regulation 33 the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "Listing Regulations, 2015"). This statement is the responsibility of the Company's Management and has been approved by the Board of Directors/ committee of Board of Directors. Our responsibility is to issue a report on these financial statements based on our review.

We conducted our review in accordance with the Standard on Review Engagement (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.

We report that the Company has not been carrying on any business operations, hence, we are unable to comment whether adopting the going concern assumption is appropriate or not, for the preparation of financial results for the Quarter, this is a matter of qualification even in our audit report dt. 30.05.2016, on the financial statements for the year ended 31st March 2016.

Except for the possible effects of the matter described in the preceding paragraph, based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying statement has not been prepared in accordance with applicable accounting standards prescribed under Section 133 of the Companies Act, 2013 read with Rule 7 of the Company (Accounts) Rules, 2014 and other recognized accounting practices and policies, and has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI Listing Regulations, 2015 including the manner in which it is to be disclosed, or that it contains any material misstatement.
