Pursuant to the Resolution passed by the Board of Directors of Anna Infrastructures Limited (herein after referred as "Anna") on 12th Day of November, 2014, I have been appointed as Scrutinizer to receive, process and scrutinize the Postal Ballot in respect of the following Special Resolution as circulated (more detailed) in the Postal Ballot Notice dated 12th November, 2014.

1. SHIFTING OF REGISTERED OFFICE FROM STATE OF DELHI TO STATE TO UTTAR PRADESH

To enable wider participation of shareholders pursuant to provision of Section 108 and 110 of the Companies Act, 2013 and the rules made thereunder vide Companies (Management and Administration) Rules, 2014 and pursuant to clause 35B (i) of the Listing Agreement, Anna has provided e-voting facility to its Shareholders in respect of shareholders resolutions to be passed at the General Meetings or through Postal Ballot.

Accordingly, Anna has made arrangement with the system provider viz. Central Depository Services (India) Limited (CDSL) for providing a system of recording votes of the Shareholders electronically through evoting.
