## LIMITED REVIEW REPORT



1	The provision for current /deferred tax, if any will be made at the end of the year.
2	Punjab State Power Corporation Limited has raised a demand of Rs.145957/- on 05.12.2011 under section 126 of the Electricity Act, 2003 and the company had already paid said demand and the matter was closed. They had revised demand to Rs. 4.15 Crs on 13.12.2013 which was challenged before the Hon'ble High Court of Punjab & Haryana and the court had already issued an Interim order that the electricity connection of the company shall not be discontinued.
3	The company has only one segment of 'Yarns' and accordingly the figures of 'Segment Reporting' as per Accounting Standard 17 Issued by the Institute of Chartered Accountants of India, is not separately given.
4	Corresponding previous period figures have been regrouped / rearranged wherever considered necessary
5	A major part of the revenue of the company comes from export sales and as such company has foreign currency exposure against firm commitments and /or highly probable-forecastable transactions. The opportunity Profit of Rs. 0.49 Crs on account of export forward contracts / Packing Credit Foreign Currency Limits as per Accounting Standard-11 on "the effects of changes in foreign exchange rates" has not been accounted for in view of significant currency fluctuation associated with the exchange rate as on 30th September 2016 which will be provided on settlement.
6	The above Unaudited results for the quarter/half year ended 30th September, 2016 were reviewed by the Audit Committee at their meeting held on 14th November 2016 and approved by the Board of Directors at their meeting held on 14th November 2016.
