NOTES ON PRESS RELEASE

SKM Egg Products Export India Limited, Erode based 100% Export Oriented Unit (EOU) –Egg Processing Unit has touched a new height in export turnover and profitability.

SKM produces processed egg products like different varieties of egg powder and liquid egg, supplies to various international markets including European Union and Japan. SKM is one of the largest egg processors in Asia with a capacity to process 1.8 million eggs daily and to produce 6900 tonnes of egg powder annually. The company becomes No:1 in Egg Powder Industry in Asia and Agricultural & Processed Food Products Export Development Authority (APEDA) has recognized our company's exports and awarded Golden Trophy many times.

SKM Shree Shivkumar, CEO and MD of the company informed that the Company has robust performance during the year 2014-15, showing "All time high" in key performance indicators. The net sales has gone up at Rs.269.20 cr. as against Rs.237.10 cr. in last year, registering a growth of 13.53%. The current year EBIDTA is Rs.53.17 cr. as against Rs.30.72 cr. and the margin is 19% as against 13% during the previous year 2013-14.

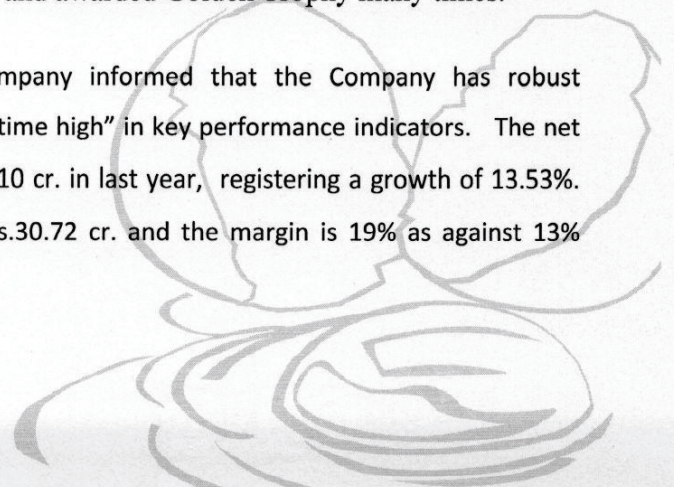

Further, the company has earned net profit before tax of Rs.34.83 cr. during the year 2014-15 as against Rs.9.74 cr. during the previous year (i.e) increase in profitability by **258%** which is the highest in the history of the company since inception 1997. After deducting deferred tax and provision for taxation, the Net Profit is Rs.25.19 cr. as against Rs.6.81 cr. during the previous year.

As far as 4th quarter of 2014-15 is concerned, the company has net sales of Rs.65.37 cr. as against the turnover of Rs.68.07 cr. during the same period in 2013-14. The EBIDTA is Rs.15.15 cr as against Rs. 10.74 cr. and the margin is 20% for this 4th quarter of 2014-15 as against 15%.The Net Profit before tax of Rs.10.11 cr. as against Rs.5.58 cr.duringthe corresponding sameperiod of the previous year.

SKM Egg Products Export (India) Limited has exported two consignments to Russia and touched a new milestone in the export sales in addition to the exports already with Japan, Europe and middle east countries. This success was achieved due to the continuous efforts taken by the CEO & MD and employees of the company for the past many years. The Company forecasts significant growth in the Russian market in the coming years ahead and the expected potential is very high.

The company has also won the "TOP Tax payer award" and certification by the Central Excise Department on 24th Feb,2015 (Central Excise day) at Salem by the Joint Commissioner of Central Excise for the period 2013-14.

The Company has become a " DEBT FREE COMPANY " in Long Term Loans by foreclosing entire Term Loans in SBI. The CRISIL has upgraded the ratings of the Company at BBB-/Stable from earlier ratings of BB/Stable for long term debts.

As the Company's robust performance, their share price has rallied since Jan 2015 and touched all time high at Rs.193/- in April 2015 and the market capitalization at Rs.510 Cr. The Board of Directors approved 10% dividend for the year 2014-15 in the board meeting held on 20th May 2015.

The Company has got in principal approval for re-commencing their share trading in BSE also thereby their shares will be traded very soon in BSE.

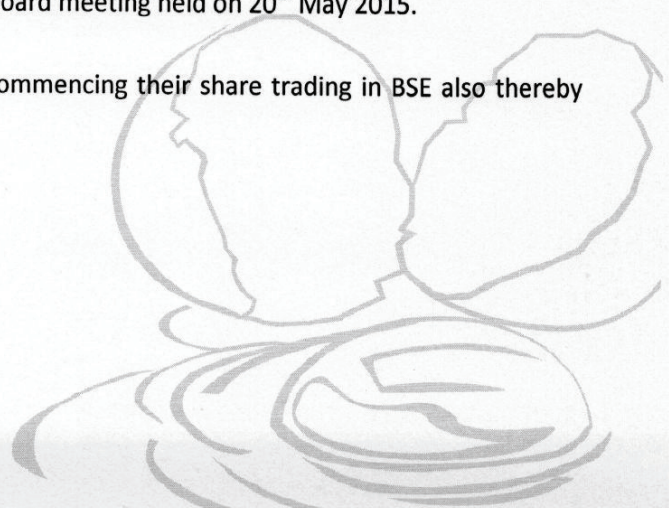
