- The Board of Directors of the company at its meeting held on January 22,
 2015 appointed me as a Scrutinizer for scrutinizing the postal ballot voting including e-voting process.
- 2. I submit my report as under:
- 2.1 The Company has completed the dispatch of postal ballot forms along with postage prepaid business reply envelope by Registered Post / Air Mail on February 06, 2015 through Prompt Services, Mumbai and by Courier on February 07, 2015 through Aitco Express Cargo, Mumbai to 9,923 members who have not registered their e-mail ids with the company. The company has sent the notice of postal ballot by email through Karvy Computershare Pvt. Ltd. on February 07, 2015 to 3,863 members who have registered their email ids with the company. The notice of postal ballot (physical and by

- email) were sent to the members whose name(s) appeared on the Register of Members/list of beneficiaries as on January 23, 2015.
- 2.2 Particulars of all the postal ballot forms received from the Members and votes cast through electronic means have been entered in the register separately maintained for the purpose.
- 2.3 The postal ballot forms were kept under my safe custody before commencing the scrutiny of such postal ballot forms and votes cast through electronic means.
- 2.4 The ballots were opened and votes cast through electronic means were unblocked on March 11, 2015 at 2.40 P.M in my presence.
- 2.5 The postal ballot forms and votes cast through electronic means were scrutinized and the shareholding was matched / confirmed with the Register of Members of the company / list of beneficiaries as on January 23, 2015.
- 2.6 All postal ballot forms and votes cast through electronic means received up to March 10, 2015 being the last date fixed by the company for receipt of the forms and votes cast through electronic means were considered for my scrutiny.
- 2.7 No envelope containing postal ballot forms was received on or after March 10, 2015 up to the date of this report.

- 2.8 **38** (Thirty Eight) envelopes containing postal ballot forms were returned undelivered up to the date of this report.
- 2.9 I did not find any defaced or mutilated ballot paper.
- 3. A summary of the postal ballot forms received and votes cast through electronic means is given in **Annexure I**.
- 4. I have handed over the postal ballot forms and other related papers/registers and records for safe custody to the Company Secretary.
