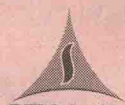

राजनीतिक कार्यकर्ताओं पर मामले वापस लेने के लिए महाराष्ट्र में पैनल का गठन

मुंबई, 25 मार्च (भाषा)। महाराष्ट्र सरकार ने बुधवार को कहा कि सामाजिक आंदोलन चला रहे राजनीतिक कार्यकर्ताओं के खिलाफ मामले वापस लिया जाना तय करने के लिए राज्य के सभी जिलों में समितियों का गठन किया जा रहा है। महाराष्ट्र के मुख्यमंत्री देवेंद्र फडणवीस ने विधानपरिषद को बताया कि कैबिनेट के फैसले के बाद राजनीतिक आंदोलन में शामिल लोगों के खिलाफ मामले वापस लिए जाएं। इसके लिए हमने पुलिसकर्मियों और संबंधित अधिकारियों को इस बारे में सूचित किया है।

उन्होंने कहा कि राज्य सरकार समय-समय पर ऐसी समितियों के संपर्क में रही है और हर महीने उन्हें इस पर स्थिति रिपोर्ट पेश करने को कहा है। प्रश्नकाल के दौरान फडणवीस ने कहा-हमने ऐसी समितियों को हमें हर महीने एक खास महीने में कितनी बैठकें हुईं और

विचार के बाद कितने लोगों को रिहा किया गया, इस संबंध में उन्हें स्थिति रिपोर्ट पेश करने को कहा है। राज्य कैबिनेट ने जनवरी में गृह विभाग के एक प्रस्ताव को पारित किया था जिसमें मई

2005 से एक नवंबर 2015 तक राजनीतिक और सामाजिक आंदोलन चला रहे हजारों राजनीतिक कार्यकर्ताओं के खिलाफ पुलिस में दर्ज मामलों को वापस लेने का प्रस्ताव था।
