## 3. DIVIDEND:

On account of the Loss After Tax reported by the Company during the Financial Year 2021-22, the Board of Directors do not recommend any dividend (previous year Nil).

# 4. RESULTS OF OPERATIONS AND THE STATE OF COMPANY'S AFFAIRS:

## (a) The Highlights of the Company's Performance (Standalone) for the Financial Year Ended 31st March, 2022 are as under:

Total sales of the Company increased by 91.44% to ₹7,150.91 crore from ₹3,735.31 crore in the previous year.

Domestic sales increased by 96.22% to ₹5,451.37 crore from ₹2,778.11 crore in the previous year.

Export sales increased by 77.55% to ₹1,699.54 crore from ₹957.20 crore in previous year.

Operating EBITDA (before exceptional items) was positive at ₹611.61 crore as compared to negative EBITDA (before exceptional items) of ₹432.63 crore in the previous year.

Operating Profit Before Tax (PBT) (before exceptional items) was negative at ₹184.18 crore as compared to negative PBT (before exceptional items) of ₹1,190.78 crore in the previous year.

The reported Loss After Tax (after exceptional item) for the year was ₹184.18 crore as compared to Loss After Tax (after exceptional item) of ₹5,854.99 crore.

## (b) The Highlights of the Company's Performance (Consolidated) for the Financial Year Ended 31st March, 2022 are as under:

The Company achieved a consolidated revenue of ₹7,309.50 crore higher by 89.98% as compared to consolidated revenue of ₹3,847.59 crore in the previous year.

Operating EBITDA (before exceptional items) was ₹609.92 crore as compared to EBITDA (before exceptional items) of ₹223.25 crore in the previous year. Operating Profit Before Tax (PBT) (before exceptional items) was negative at ₹209.42 crore as compared to negative PBT (before exceptional items) of ₹562.18 crore in the previous year.

The reported consolidated Loss After Tax (after exceptional item) for the year was ₹208.60 crore as compared to Loss After Tax (after exceptional item) of ₹5,673.32 crore in the previous year.

A detailed analysis of financial results is given in the Management Discussion and Analysis Report, which forms part of this Annual Report.

## 5. CONSOLIDATED FINANCIAL STATEMENTS:

In accordance with the provisions of the Act and Listing Regulations read with relevant Accounting Standards issued by the Institute of Chartered Accountants of India, the consolidated financial statements forms part of this Annual Report. The audited financial statements, including the consolidated financial statements and related information of the Company and audited accounts of each of its subsidiaries are available on Company's website and can be accessed through the link: https:// www.alokind.com/shareholder.html. These documents are also available for inspection by the Members at the Registered Office of the Company during business hours on all working days, except Saturdays, Sundays and National Holidays up to the date of the 35th AGM of the Company.

## 6. EROSION OF NETWORTH:

Net worth as at 31st March, 2022 was negative at ₹16,450.05 crore. Accumulated losses have resulted in the erosion of over 53.90% of peak net worth of negative ₹10,688.68 crore during the immediately preceding four Financial Years.

# 7. PARTICULARS OF LOANS, GUARANTEES AND INVESTMENTS:

Particulars of loans given, investments made, guarantees given and securities provided along with the purpose for which the loan or guarantee or security provided is proposed to be utilised by the recipient are provided in the standalone financial statements (Refer Note 17 and 19 to the standalone financial statements).

## 10. SHARE CAPITAL:

The paid-up Share Capital of the Company as on 31st March, 2022 was ₹746.52 crore consisting of 496.52 crore Equity Shares of ₹1/- each and 250.00 crore fully paid-up 9% Optionally Convertible Preference Shares of ₹1/- each.

As a part of the Resolution Plan approved by the National Company Law Tribunal, Ahmedabad Bench, the Company had on 28th February, 2020, allotted on preferential basis to Reliance Industries Limited ("RIL"), 250,00,00,000 - 9% Optionally Convertible Preference Shares ("OCPS") of ₹1 each for cash at par, for a total consideration of ₹250 crore.

During the year, the OCPS were due for conversion at the option of RIL. Since RIL did not exercise its option to convert OCPS into equity shares, as per the terms and conditions of the OCPS, the Company will redeem the same on 27th February, 2030, i.e. the last day of the 10th anniversary of the date of allotment, by paying an amount at least equal to the outstanding OCPS subscription amount and there shall be no impact on Equity Share Capital of the Company.

The Company has an elaborate Risk Management Framework, which is designed to enable risks to be identified, assessed and mitigated appropriately. The Board of Directors of the Company has constituted Risk Management Committee which has, *inter-alia*, been entrusted with the responsibility of overseeing implementation/ monitoring of Risk Management Plan and Policy; and continually obtaining reasonable assurance from management that all known and emerging risks have been identified and mitigated or managed.

The current constitution and role of the Risk Management Committee is in compliance with the requirements of Regulation 21 of the Listing Regulations. Pursuant to the Resolution Plan approved by the National Company Law Tribunal, Ahmedabad Bench, JM Financial Asset Reconstruction Company Limited (acting in its capacity as trustee of JMFARC – March 2018 – Trust) ("JMFARC"), one of the resolution applicants and a Member holding 173,73,11,844 (34.99%) Equity Shares of the Company had nominated Mr. Samir Chawla (DIN: 03499851) as its nominee on the Board of the Company. Accordingly, Mr. Samir Chawla was appointed as a Nominee Director (Non-Executive) representing JMFARC with effect from 14th September, 2020.

JMFARC vide letter dated 28th January, 2022, had withdrawn the nomination of Mr. Samir Chawla from the Board of the Company with effect from the said date on account of his resignation from the services of JMFARC and nominated Mr. Nirav Parekh (DIN: 09505075) as its nominee on the Board of the Company.

Accordingly, the Board of Directors of the Company at its meeting held on 3rd March, 2022, based on the recommendation of the Nomination and Remuneration Committee and pursuant to the provisions of Section 161(1) of the Act read with the Articles of Association of the Company, had approved the appointment of Mr. Nirav Parekh as Nominee Director (Non-Executive) representing JMFARC, with effect from 3rd March, 2022. Further, the said appointment was approved by the Members of the Company by way of Postal Ballot on 6th April, 2022.

- (iii) the Whole-Time Director;
- (iv) the Chief Financial Officer; and
- (v) such other officer as may be prescribed under the Companies Act, 2013 ("the Act").
- **3.3 "Nomination and Remuneration Committee"** means the Committee constituted by Alok's Board in accordance with the provisions of Section 178 of the Act and Regulation 19 of the Securities and Exchange Board of India (Listing Obligations

and Disclosure Requirements) Regulations, 2015 ("Listing Regulations").

## 4. Policy:

## 4.1 Remuneration to Executive Directors and Key Managerial Personnel

- 4.1.1 The Board, on the recommendation of the Nomination and Remuneration ("NR") Committee, shall review and approve the remuneration payable to the Executive Directors of the Company within the overall limits approved by the Members.

4.2.1 Employees shall be assigned grades according to their qualifications and work experience, competencies as well as their roles and responsibilities in the organization. Individual remuneration shall be determined within the appropriate grade and shall be based on various factors such as job profile, skill sets, seniority, experience and prevailing remuneration levels for equivalent jobs.

## **Management Discussion and Analysis**

Alok Industries ('Alok' or 'the Company') is an integrated textile Company with a product range comprising of both cotton and polyester. Alok's plants are situated at Vapi (in Gujarat) and Silvassa (Union territory near Vapi) and the Company has a wide customer base across the world that includes global retail brands, importers, private labels, and domestic retailers, garment & textile manufacturers and traders.

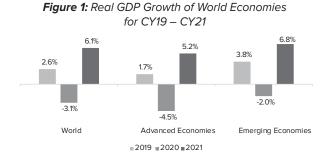
The Company underwent a corporate insolvency resolution process under section 31 of the Insolvency and Bankruptcy Code, 2016. A resolution plan was approved by the Hon'ble National Company Law Tribunal, Ahmedabad Bench (Approved Resolution Plan) vide its order dated 8th March, 2019 and the implementation of the Approved Resolution Plan was concluded in the previous year with the re-constitution of the Board of Directors of the Holding Company on 14th September, 2020.

Under the leadership of new management, the Company is steadily making progress as can be seen from the current year performance. Despite challenges posed by COVID Pandemic and rising raw material trend during the year, the Company has grown on sales by 91.44% to ₹7,150.91 crore and EBIDTA by 53% to ₹611.61 crore and made a Cash Profit of ₹160.7 crore as compared to cash loss of ₹65.7 crore in the previous year. The detailed analysis of the performance of the Company has been given in Section 3 "Financial Performance".

#### 1. Economic Overview

#### 1.1. Global – Economic Overview

The global economy recovered strongly in 2021 after decline in 2020 due to the pandemic. Global real GDP is estimated to have grown at 6.1% in 2021 compared to a decline of -3.1% in 2020. Emerging market GDP growth has overshadowed the growth witnessed before the Covid era and the growth has come roaring back for the advanced economies of the USA and Europe. Despite a recovery in output and trade, there has been few disruptions which have caused economic uncertainties in the short run in 2022. The pandemic is still not over and there is a renewed surge in COVID-19 cases in advanced economies. Moreover, the ongoing geopolitical conflict between Ukraine and Russia is also having a significant impact on global GDP growth prospects in 2022. Further the supply side disruptions and rising energy prices have resulted in higher inflation across countries.

The global economy is predicted to be weaker in 2022 than originally anticipated. The risk of new disruptive COVID variants has the potential to prolong the pandemic while also causing fresh economic impacts. Furthermore, supply chain disruptions, energy price volatility, and localized wage pressures all contribute to a high level of uncertainty about inflation and policy directions. Risks to the financial stability of debt-ridden emerging markets and developing nations' capital flows, currencies, and fiscal positions may emerge as mature economies raise policy rates. As a result of the economic uncertainties the world GDP is expected to grow at a slower rate of 3.6% in 2022 compared to 2021, as per IMF (International Monetary Fund).

The world trade recovered in 2021 with a significant growth of 10.1% in merchandise trade. While supply side issues including port backlogs caused strain in global trade, the major risk in trade comes from the resurgence of the Covid pandemic and disruptions caused by the Russia-Ukraine conflict. Assuming the situation resolves, supply chain constraints are expected to ease, and global trade is expected to grow at moderate level in 2022.

## 1.2. India – Economic Overview

India's GDP is estimated at US\$ 3.1 trillion in 2021. India's economy has recovered significantly in 2021 with a growth of 8.9% in GDP compared to a decline of -6.6% in 2020 due to the pandemic. The Indian economy is further expected to grow at a sustained pace with the risk of pandemic reduced especially for domestic demand.

In merchandise exports India crossed the US\$ 400 bn mark for the first time, with a total merchandise exports of US\$417.8 bn in FY2021-22, which shows significant recovery and growth in India's exports.

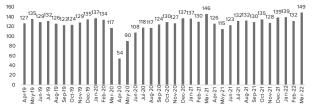
Figure 2: GDP Growth Rate in India (%)

Manufacturing has recovered in 2021 across sectors. The Index of Industrial Production (IIP) has grown at an average of 11.4% in 2021-22. IIP has surpassed 2019-20 levels after decline in 2020 during the height of the pandemic. From the perspective of textile industry, the Index of Industrial Production (IIP) for textiles took a major dip in the FY2020-21 with an average index value of 91.1, however in 2021-22 IIP for textiles has recovered to reach an average value of 118 with growth of 29.5%. The IIP for apparel recovered to reach a peak of 199.6 in March 2022, with an average growth of 28.5% in FY 2021-22 compared to FY 2020-21.

Inflation has risen in 2021-22 driven by rise in prices of crude oil, food items, chemicals etc. The overall Wholesale Price Index (WPI) has increased by 13% in FY 2021-22 compared to FY 2020-21. Inflationary pressures have further intensified with the prolonging of Russia-Ukraine conflict with further rise in energy prices. The Wholesale Price Index (WPI) for textiles has been on a continuously rising trend after the 1<sup>st</sup> quarter of FY20 and a similar trend was seen in the WPI of the apparel. The WPI for textiles increased by 15%, while for apparel WPI has increased by 3.2% in FY 2021-22 compared to FY2020-21.

With the easing of Covid restrictions across the country, consumer confidence is expected to return and result in elevated private consumption soon. The government is also focusing on infrastructure spending and encouraging industries to invest through various PLI schemes across industries. This will further boost investor confidence and is expected to drive the economy forward in 2022, despite the inflation concerns.

## 2. Textile & Apparel Industry Overview

## 2.1. Global Textile & Apparel Market Overview

The global apparel consumption in 2021 is estimated to be US\$ 1.5 trillion, recovered by 16% from 1.2 trillion in 2020. USA was the largest apparel consuming market worth US\$ 257 billion, followed by the EU, China, and Japan, together constituting approximately 40% of the global apparel market consumption. The other major apparel markets include India, Brazil and Canada, accounting for an additional 9% share.

The global apparel demand is expected to grow at a CAGR of 7% from the current US\$ 1.5 trillion to reach US\$ 2 trillion by the year 2025. It is projected that China and India will be the fastest-growing apparel markets, both growing in double digits. China will become the biggest apparel market with US\$ 340 billion in market size by 2025, India will also be one of the most attractive apparel markets with an estimated size of US\$ 135 billion by 2025. The high growth in these markets will be primarily driven by the economic growth and increasing disposable income of a large population base.

The global textile industry is undergoing a structural shift in many aspects. Some of the key trends influencing the textile and apparel industry are the following:

- The consumption inclination towards synthetic fiber is more than ever owing to its better durable, water repellence, wrinkle resistance, color retention, and luster properties over natural fibers.
- The focus on digitalizing manufacturing processes and the supply chain have intensified in the recent past,

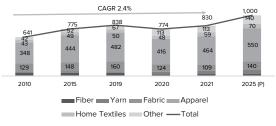
especially post covid. Industries across the world are venturing into newer manufacturing processes based on automation and AI referenced as Industry 4.0.

- The demand for comfort wear, increased focus on health and hygiene, emphasis on participation in sports and heightened attention towards functional garments have emerged as key consumer trends post covid.
- Sustainability and traceability has emerged as a significant trend across the textile and apparel industry globally. The major global apparel brands and retailers are committed to sustainability and traceability of supply chain to ensure compliance at all stages of the manufacturing process. Going forward, this will be an important factor that will dictate global sourcing and manufacturing dynamics.

#### 2.1.1. Global Textile & Apparel Trade

Global Textile & Apparel trade has rebounded from 2020 and reached US\$ 830 bn in 2021, growing by 7.2%. Global trade is expected to further grow and reach US\$ 1 trillion by 2025, growing at a CAGR of 4.8%. In 2021, Apparel constituted a 56% share of the global textile & apparel trade followed by fabric which accounted for 13% of the total trade.

The post-pandemic growth in global trade indicates an attractive opportunity for countries with large manufacturing capacities and competitive manufacturing. However global concerns persist with the possible emergence of next covid wave and persisting Ukraine-Russia conflict. With easing of the geo political situation trade is expected to recover next year and grow further.

#### 2.1.2. Key Exporters

One of the key sourcing trends recently has been buyers diversifying sourcing from China to alternate destinations to reduce their sourcing risks. The US ban on Xinjiang cotton has further incentivized buyers to look for alternate sourcing destinations. As the pandemic spread out from China, many buyers started to move out of the country and explore new sourcing options. Increasing labour and other costs were already causing enough loss in its share. While China is still the major supplier, its share has reduced gradually. In 2021, although China stood as the largest exporter with a 37% share in the global trade, it registered a loss of nearly 10% in its global share since 2015. The share has mainly been taken up by Vietnam and Bangladesh having 2<sup>nd</sup> and 5<sup>th</sup> position in global trade, respectively, though they have a very small presence in textiles trade. India stood at 4<sup>th</sup> position in global trade with a 5% overall share. While countries like Vietnam and Bangladesh have gained because of sourcing shift from China, India can also take advantage and increase its global trade share going forward.

## 2.1.3. USA imports

Textile and apparel imports to the US have recovered to pre-pandemic levels. US imports were US\$ 118 billion in 2021 compared to US\$ 117 billion in 2019. USA's overall imports from China have seen a decline for the first time in many years. Exports from China to the USA have fallen at a rate of 3% from US\$ 39 billion in 2019 to US\$ 37 billion in 2021. Contrastingly, the share of imports from other key countries have grown significantly. India's exports to the USA have grown at a CAGR of 11% in the year 2021 since 2019 and along with India, the exports of Vietnam, Bangladesh, Pakistan and Cambodia have also witnessed a spike in their exports to the country.

## 2.1.4. EU imports

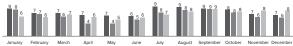
Textile and apparel imports to the EU have also recovered to pre-pandemic levels to reach US\$ 127 billion in 2021 compared to US\$ 126 billion in 2019. Exports from China to the EU have grown slightly at 3% CAGR from US\$ 38 billion in 2019 to US\$ 40 billion in 2021. China's share had increased significantly in 2020 primarily due to supply of PPE products during peak of the pandemic. However, in 2021 the values have come back to 2019 levels. The imports from other import partners have grown at the average level. India's export to the EU have grown at a CAGR of 1% in the year 2021 since 2019. The exports of Turkey and Pakistan have also witnessed a positive spike in their exports to the country.



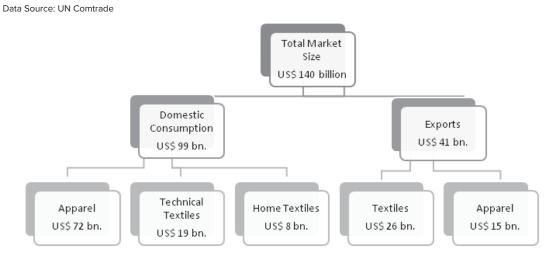

In second half of 2021, EU-27 apparel store sales overshadowed the sales seen during the same period in 2020. EU-27 apparel imports recovered steadily till the year-end from the weaker demand witnessed during the start of the calendar year. Months of April, May and June of 2020 witnessed the least imports of apparel in the EU countries due to a severe rise covid cases.

## 2.2. Indian Textile and Apparel Industry

The overall size of India's textile and apparel market is estimated to be around US\$ 140 bn in 2021. Indian domestic textile and apparel market is estimated to be US\$ 99 billion in 2021 which has recovered from a drop in 2020 due to the pandemic. The market is expected to continue with 10% growth post-pandemic and reach US\$ 190 billion by 2025. India exported textiles worth US\$ 26 billion and apparel worth US\$ 15 billion in 2021. The total production capacity of India is increasing owing to the setting up of new manufacturing units across the value chain.

The domestic textile and apparel market had declined during the peak of the pandemic in 2020. Market is still recovering and is yet to reach 2019 levels, however with strong domestic demand fundamentals the market is expected to recover fully soon and is further expected to grow at a significant pace.

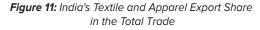
The government of India has also been very proactive in incentivizing and encouraging the textile industry to invest through key policy initiatives. The government has introduced Production Linked Incentive Scheme for textile industry under which incentives will be provided to industry for setting textile and apparel manufacturing in key man-made fiber-based products. This will help in attracting investment in the entire value chain of manmade textiles in India in the near term.

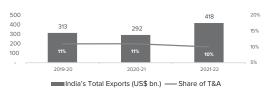
The Union Cabinet also approved PM MITRA (Mega Integrated Textile Region and Apparel) parks scheme for the textile sector to set up seven integrated textile parks in the country, as announced in Union Budget for 2021-22. The parks will offer an opportunity to create an integrated textile value chain, right from spinning, weaving, processing/ dyeing and printing to garment manufacturing, at one location. World-class industrial infrastructure would attract cutting edge technology and boost FDI and local investment in the sector.

Also, India signed FTA with the UAE owing to which the Indian textile and garment sector will see additional exports of \$2 billion to the UAE over the next 5 years. Of this, incremental exports in man-made fiber textiles alone will be to the tune of \$650 million. FTAs with countries like UK and Australia are already in the advanced stages of discussions. It is expected that FTA with UK will open the doors of possibilities of FTAs with other European countries and make India a preferred destination for these countries to import textiles and apparel in Asia.

#### 2.2.1. India's Exports Scenario

The textile and apparel sector is a major contributor to India's total export earnings. Currently, it contributes to 10% of total export earnings of US\$ 417.8 billion. The share of the sector in exports has declined over the years, even though absolute value of textile and apparel exports has increased.

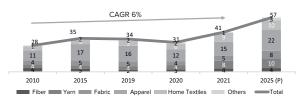

Overall, India holds the fifth position with a 4% share of global textile & apparel exports. The textile & apparel exports in 2021 was worth US\$ 41 billion, rising at a CAGR of 3.5% since 2010. The exports in 2020 had already shown a dip of 9% when compared to the exports in 2019 and now have rebounded by more than 33% to grow beyond the pre covid levels. Home Textiles have shown the highest growth since 2010, growing at a CAGR of 7.7% to reach at the value of US\$ 9 billion from US\$ 4 billion in 2010. India's exports are expected to grow in future and reach US\$ 57 billion by 2025. India is expected to continue on this growth trajectory and become a strong alternative to Chinese textile and apparel exports.

#### 2.2.2. India's Imports Scenario

India's imports have been increasing over the last few years. However, this trend was also disrupted by the pandemic. India's textile and apparel import were US\$ 6 billion in 2020 and reached US\$ 8 billion in 2021. The imports are expected to continue to rise at a modest rate of 6% as seen from 2010 to 2021. A large part of imports comprises fibre, yarn and fabrics of synthetic fibres which are not made extensively in India.

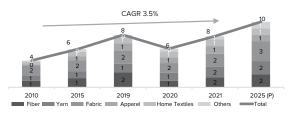

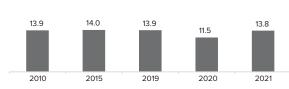

Given below is a brief market overview of the key business segments of Alok i.e., Spinning, Polyester, Home textiles and Apparel & Fabric segments.

## 3.1 Spinning Business Environment / Outlook

The global trade of cotton yarn was valued at US\$ 13.8 billion in 2021 which has recovered at a significant CAGR of 20% post pandemic. Due to the pandemic the global cotton yarn demand came under significant stress, moreover, cotton produced in the Xinjiang province region of China, which supplies 70% of the world cotton demand, was banned in the US for using forced labour, due to this demand of cotton rose and yarn prices increased and therefore buyers began to source their yarn and cotton from other nations such as India and Vietnam in early 2020 which gave Indian spinning a strong boost to recover in the pandemic.

In the case of yarn manufacturing, India has production facilities in both natural and man-made yarn production. India has an installed capacity of 57 million spindles, producing approximately 4,910 million kg yarn in 2020-21. India is one of the largest producers and exporters of cotton yarn in the world with a production of 3,509 million kgs of 100% Cotton Spun Yarn in 2020-21.

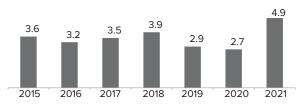

India's exports of cotton yarn were declining before the pandemic. The exports fell from US\$ 3.6 billion in 2015 to US\$ 2.9 billion in 2019. The exports stayed stagnant during the covid era but witnessed a surge in demand in the year 2021, the exports went up to US\$ 4.9 billion jumping to an all-time high. Global buyers are looking for new destinations to source cotton yarn with low manufacturing costs and better quality. Growing demand for comfortable clothing and home textiles has also led to an increase in cotton yarn demand.

Indian spinners over the last few decades have invested extensively in bringing in the latest spinning technologies and infrastructure to India as a result India has emerged one of the major manufacturer and exporter of Cotton Yarn in the world.

Alok is one of the major players in the Indian spinning industry with modern infrastructure and focus on research & product development. It's Spinning plants are situated at Silvassa. Majority of its yarn (about 60%) are captively consumed in its weaving, knitting & terry towel divisions.

## 3.2 Polyester Business Environment / Outlook

Globally, the demand for polyester-based textiles is growing faster than cotton. Currently, polyester accounts for more than 55% of the total fiber consumption in the world. Polyester fiber consumption is expected to grow by another 22 million tons to reach a level of 78 million tons annually and will form a share of 60% of global fiber consumption of 130 million tons by 2025.

In 2020, the global trade of Polyester Staple Fiber (PSF) stood at US\$ 4.0 billion and that of Polyester Yarn stood at US\$ 13.4 billion. PSF has been growing at a CAGR of 2% since 2015, while Polyester yarn has been growing at a CAGR of 14%. Polyester is manufactured from crude oil derivatives and thus the rising oil prices due to global demand conditions and the Russia – Ukraine conflict has led to a rise in polyester prices as well.

India has a production of 1,085 million kg of polyester staple fibre and 3,934 million kg of polyester filament yarn. It is the second-largest producer of polyester globally. India's exports of polyester registered a value of US\$ 2.0 billion in 2021. The Production linked Incentive (PLI) scheme is set to boost the man-made fibre-based textiles and apparel production in India, many major textile manufacturers have applied in the scheme and it is expected to generate investments of up to ₹ 50,000 crore in the overall man-made fibre textile value chain.

The growth in the volume of polyester consumption is driven by growth in consumption of finished product categories like sportswear, technical textiles and women's wear. India has a presence of complete polyester value chain in the country and therefore it must leverage its expertise and capture the growing demand for polyester-based textiles.

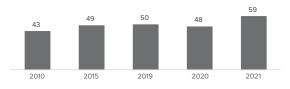
Alok has a state-of-the-art large integrated set up for its polyester division at Silvassa with diversified product portfolio comprising of Polyester chips, Partially Oriented Yarn (POY), Drawn Textured Yarn (DTY), Fully Drawn Yarn (FDY) and Polyester Staple Fibres (PSF).

About 60% of the current year sales of Alok has come from the Polyester division of the Company. Majority (i.e.,85%) of the polyester products are sold in the domestic market and about 15% are exported.

## 3.3 Home Textiles Business Environment / Outlook

The global trade of home textiles was US\$ 48 billion in 2020 declining slightly from 2019 value of US\$ 50 bn. However, in 2021 the home textile exports have grown significantly by 23% to reach US\$ 59 bn. While other textile categories declined significantly during the peak of the pandemic in 2020, the trade in home textiles was still sustained driven by trends like work from home and an increase in spending for home and hygiene products post pandemic in the developed markets like US.

Figure 18: Global Trade of Home Textiles (US\$ billion)



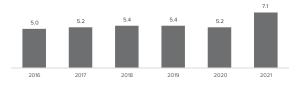

The Indian home textiles exports stood at around US\$ 7.1 billion in 2021 rising significantly by 37% compared to 2020. Exports of Home textile were affected less by the pandemic compared to other major segments such as

apparel. The Exports have also shown a quick recovery compared to other segments. India over the last few years has successfully managed to build its position as a large manufacturer of home textiles in the world, only behind China, with a share of 8% in the global home textile trade.

India exports its home textiles products primarily to the EU and USA, which constitute more than 70% of India's home textiles export markets. India has a strong manufacturing ecosystem for home textiles with the presence of large and integrated players with strong capabilities which will serve as a huge advantage in the post-covid world, in catering to global market requirements.

Figure 19: India's Exports of Home Textiles (US\$ billion)



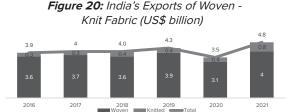

Alok is amongst one of the largest home textiles manufacturers/ exporters in India and has a large capacity of manufacturing bedding as well as terry towel. Its weaving manufacturing facility & major stitching unit for bedding is at Silvassa and fabric processing and another stitching unit for bedding is at Vapi. The entire terry-towel manufacturing is at Vapi.

The major export market for home textile products for the Company is USA, which is the largest consuming Centre for home products in the world. The other export destinations include European countries and Australia. The domestic market is also growing significantly and presently it's about 17% of the total home textile sales of the Company.

## 3.4 Apparel & Fabrics Business Environment / Outlook

India's fabric exports stood at US\$ 4.8 billion in 2021 of which woven fabric is US\$ 4.0 billion and knitted fabric is US\$ 0.8 billion. Fabric exports have recovered post the decline in 2020 due to the pandemic.

The fabric production was around 63,348 million sq.

mtrs in 2019-20 (Apr–Jan), which has grown at 9% CAGR compared to 2018-19 in the same period. The decentralized sector had the major share of 97%, while the rest was of the mill sector. The production of the mill sector declined by -3% while decentralized sector production increased by 9% in 2019-20.

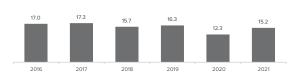

India's apparel exports have recovered from the decline in 2020 to reach US\$ 15.2 bn in 2021, however they are yet to reach the 2019 levels of US\$ 16.3 bn. Nevertheless, the government is keen to support the apparel industry through several policy initiatives and the recently launched schemes like PLI and MITRA are expected to re-energize the industry in apparel manufacturing and attract global buyers to India.

To sustain in the current market scenarios, manufacturers need to be quick in adapting the future trends. Manufacturers need to focus on attaining manufacturing excellence, vertical integration of their operations, venture into new products, gather technical knowhow and look beyond the EU and USA to supply their products.

Alok is a leading player in this segment with a large and integrated set up. Its weaving, knitting, embroidery and major garmenting facilities are situated at Vapi and processing plants and other garment unit is situated at Vapi. Presently, the domestic market constitutes about 75% of the market for Apparel Fabric Division of the Company.

## 4. Financial Performance (Stand Alone)

Alok Industries Limited is an integrated textile manufacturer, with integration in both the streams, in cotton as well as polyester value chain. The Company

has created global sized capacities and expanded its markets across the global territories.

During the current financial year, the Company operated at "76% level on an average-partly due to impact of COVID-19 pandemic and due to additional time taken by the cotton downstream businesses in stabilizing the manufacturing units post completion of capex along with additional time taken for market penetration.

Company reported operating EBIDTA of ₹ 623.50 crore (Vs. FY 21 EBITDA of ₹ 407.03 crore). There were no extraordinary provisions / impairments during the financial year 2021-22, hence reported EBITDA for current year remains at ₹ 611.61 crore (as compared to EBIDTA loss of (₹ 432.63 crore) in the previous year after provisions / impairments. At PBT level, company made a loss of (₹ 184.18 crore), as compared to loss of (₹ 4,431.88 crore) in the previous year due to exceptional loss of (₹ 3,241.10 crore) and provisions of ₹ 839.66 crore. The highlight of the year was that Company made cash profit of ₹ 148.33 crore (previous year cash loss of ₹ 65.69 crore)

Table 5 gives the summarized profit and loss statement of the Company in the current financial year compared to the previous financial year. The brief analysis of the stand-alone results, which relates to the textile business of the Company, is also given below the table.

## **Profit and Loss Analysis**

- Net Sales for the year were ₹ 7,150.91 crore comprising of domestic sales of ₹ 5,451.37 crore and export sales of ₹ 1,699.54 crore. In the previous year, the total sales were ₹ 3,735.31 crore comprising of domestic sales ₹ 2,778.11 crore and export sales of ₹ 957.20 crore. The Company's level of operations was averaged at ~76% during FY 2021-22 as compared to about 50% in the previous year. The sales during the year recorded a growth of 91.44% over the previous year despite challenges of COVID Pandemic and challenges of stabilization of plants, rising raw material cost and time taken in penetration of markets by the downstream cotton businesses. The overall growth in domestic sales was 96.2% and exports grew by 77.6% as compared to previous year.
- Other Income for the year was ₹ 40.33 crore (previous year ₹ 21.66 crore). A major part of the other income comprises of gain related foreign currency exchange rate difference of ₹ 27.14 crore (previous year ₹ 6.45 crore), interest income on fixed deposit with banks ₹ 3.26 crore (previous year ₹ 8.97 crore), insurance claim received ₹ 2.12 crore (previous year ₹ 4.64) and Sundry Credit balance written back ₹ 6.86 crore (previous year ₹ 1.15 crore).
- Material Cost for the current financial year was
   ₹ 4,817.57 crore as compared to ₹ 2,133.14 crore
   in the previous period. As a percentage of sales,
   material cost increased from 57.11% in the previous
   period to 67.37% in the current year due to
   substantial increase in raw material prices both in
   cotton & polyester stream.
- People Costs in the current financial year increased to ₹ 394.92 crore as compared to ₹ 307.41 crore in the previous period. As a percentage to sales, however, it came down to 5.52% in FY 2021-22 as

compared to 8.23% in FY 2020-21. The total head count as on 31st March 2022 was about 26462 people as compared to about 24500 as on 31st March 2021.

- Other Expenses (without Provisions) in the current year were ₹ 1355.25 crore as compared to ₹ 909.39 crore in the previous period. The major items of other expenses for the year were Power & Fuel ₹ 774.61 crore (previous year ₹ 516.81 crore), Labour charges ₹ 136.73 crore (previous year ₹ 98.21 crore), stores & spares consumed ₹ 104.87 crore (previous year ₹ 63.91 crore), freight Coolie & cartage ₹ 92.56 crore (previous year ₹ 34.28 crore), process charges ₹ 68.96 crore (previous year ₹ 60.27 crore), Repairs & Maintenance ₹ 36.26 crore (Previous year ₹ 24.30 crore) and insurance ₹ Crore 22.00 (Previous year ₹ 21.10 crore), miscellaneous expenses ₹ 82.41 crore (Previous year ₹ 56.21 crore) among others.
- Other Expenses (Provisions) Provisions for doubtful advances / impairment of investments included in the other expenses was amounting to ₹ 11.89 crore as compared to ₹ 839.66 crore in the previous year. Provisions / impairment in the previous year were relating to loans given to subsidiary (₹ 689.48 crore), investment in joint venture ₹ 92.38 crore and other receivables of ₹ 53.46 crore).
- Operating Earnings before Interest, Depreciation, Tax and Amortization (EBIDTA) without provisions
   / impairments for the year was profit of ₹ 623.5
   crore as compared to profit of ₹ 407.03 crore in the
   previous year, representing an increase of 53.2%
   over previous year. However, due to increase in
   raw material prices, the EBIDTA in percentage term
   has come down to 8.7% in FY 2022 as compared to
   10.9% in FY 2021.
- Operating Earnings before Interest, Depreciation, Tax and Amortization (EBIDTA) after provisions
   / impairments for the year was ₹ 611.61 crore as compared to loss of (₹ 432.63 crore) in the previous year.
- Depreciation was ₹ 333.00 crore for the current year as compared to ₹ 285.43 crore in the previous year.
- Interest & Finance Cost for the current year was ₹ 462.79 crore comprising of interest on term loan of ₹ 430.91 crore, interest on working capital of ₹ 7.56 crore, interest on Preference Shares of ₹ 24.32 crore as compared to ₹ 472.72 crore in the previous year comprising of interest on term loan of ₹ 448.12 crore, interest on working capital of ₹ 1.61 crore, interest on Preference Shares of ₹ 22.47 crore and other bank charges of ₹ 0.52 crore.

- **Operating PBT** for the year was loss of (₹ 184.18 crore) as compared to loss of (₹ 1,190.78 crore) in the previous year.
- Exceptional Item for the year was ₹ Nil. In the previous year net exceptional expense was ₹ 3,241.10 crore, net of impairment of fixed assets ₹ 8,264.22 crore and profit on conversion of Idebt-to-equity ₹ 5,023.12 crore.
- Net (Loss) / Profit After Tax there was a loss of (₹ 184.17 crore) in the current year against loss of (₹ 5,854.99 crore) in the previous period.

## **Comments on Ratios:**

- Debtors Turnover Days: D-Debtors Turnover Days: Debtor turnover days 24 days decreased during the year as compared to previous year debtor turnover days of 27 days. In absolute amount debtors as on 31<sup>st</sup> March 2022 increased to ₹ 475.11 crore as compared to ₹ 280.49 crore as on 31<sup>st</sup> March 2021 representing an increase of 69.39%. The increase in absolute amount of debtors was mainly on account of increase in the overall sales of the Company by 91.44% during the year.
- Inventory Turnover Days: Inventory turnover days 60 days also decreased during the current year as compared inventory turnover days 86 days in the previous year. However, the absolute amount of inventory increased to ₹ 1182.75 crore as compared to ₹ 884.57 crore in the previous year representing an increase of 33.7%. This is on account of increase in overall level of operations which resulted in increase in sales by 91.1% for the

year. Our integrated cotton segments (Spinning, Apparel Fabrics and Home Textiles) are required to keep sufficient inventories of raw materials (30 days - 60 day) to carry on smooth operations. Moreover, turn around period (work in process) in our Apparel Fabric and Home Textiles segments is ranging from 30 days- 45 days. Similarly, Finished Goods are on an average 30 days in Apparel fabric and Home Textiles Segments. In comparison to this, the overall gross working capital days in case of Polyester business is about 25 days.

- Interest Coverage Ratio: Our interest outgo for the year was ₹ 462.79 crore as compared to previous year interest of ₹ 472.72 crore. With increase in operations, our operating EBITDA for the year was ₹ 623.50 crore (previous year ₹ 407.03 crore), the interest coverage ratio has accordingly, improved to 1.35 times as compared to 0.86 times in the previous year.
- Current Ratio: The current ratio for FY 2021-22 was 1.09 times as compared to 1.36 times in the previous year, mainly on account of increase in current liabilities. The total current assets for the year were ₹ 2,103.28 crore as compared to ₹ 1678.00 crore in the previous year. The current liabilities for the year were ₹ 1934.10 crore, including term loan due within a year of ₹ 334.84 crore (previous year nil) as compared to ₹ 1234.65 crore in the previous year. Increase in Current Assets as well as Current Liabilities were in accordance with the increase in level of activities.
- Debt/ Equity Ratio: The Net worth of the Company in FY 2021-22 was negative (₹ - 16, 450.05 crore) as compared to negative net worth of (₹ - 16,265.37 crore) in FY 2020-21. The increase in negative net worth during the year was due to loss of ₹ 184.18 crore. The outside long-term debt of the Company as on 31st March'22 net of cash & balances was ₹ 4,744.57 crore (Previous year ₹ 4,866.81 crore). The Debt/ Equity ratio for the year was negative (0.29) as compared to negative (0.30) in the previous year.

Quasi- Debt/ Equity Ratio: The quasi networth of the Company as on 31st March'22 was ₹ 1,173.34 crore. The same is arrived at by adding ₹ 17,384.02 crore interest free long-term loans from the promoters and long-term preference shares of ₹ 239.35 crore as on March'22 subscribed by the promoters. The quasi-net worth as on 31st March'21 on like basis was ₹ 1,356.26 crore. Based on this, the quasi debt/ equity ratio as on 31st March'22 was 4.04 as compared to 3.59 as on 31st March'21.

 Operating EBITDA before considering Provisioning: Operating Earnings before Interest, Depreciation, Tax and Amortization (EBIDTA) without considering provisions/impairments for the year was profit of ₹ 623.5 crore (8.7%) as compared to ₹ 407.03 crore (10.90%) in the previous year. The decrease in operating margin is mainly attributable to increased raw material cost both in cotton & polyester segments.

**Operating EBITDA after considering Provisioning:** Operating Earnings before Interest, Depreciation, Tax and Amortization (EBIDTA) for the year after considering provisioning of ₹ 11.89 crores was EBIDTA of ₹ 611.61 crore (8.55%). The provisioning in previous year was ₹ 839.66 crore which resulted in EBIDTA loss of (₹ 432.63 crore) (-11.58%). The provisioning in the previous year of ₹ 839.66 crore was mainly on account of provisioning in the value of loans given to subsidiary and investment made in associates, etc.

Net (Loss) / Profit After Tax: Net (Loss)/ Profit After Tax was a loss of ₹ 184.18 crore in the current year. As compared to this, in the previous year there was a net loss of ₹ 5,854.99 crore on account of provisioning in the value of loans given to subsidiary etc. of ₹ 839.66 crore, net loss due to exceptional items of ₹ 3,241.10 crore and de-recognition of deferred tax of ₹ 1,423.11 crore. The Net profit Margin for the year was negative (- 2.58) % as compared to negative (- 156.75)% in the previous year.

### Comments on Cash Flow:

 Cash Flow from Operating Activities: The Company generated Net Cash Flow from Operation of ₹215.97 crore during the year ended 31st March'22

as compared to Cash Flow from Operation of ₹ 320.5 crore in the previous year ended 31st March'21. During the Financial Year 2021-22, Company generated Operating Cash flow of ₹ 612.44 crore before working capital changes (previous year ₹ 391.35 crore). The changes in working capital were ₹ 390.63 crore for the year (₹ 67.20 crore in the previous year) and Income tax was ₹ 5.84 crore (previous year ₹ 3.65 crore).

- b. Cash Flow from Investing Activities: There was a net cash utilisation of (₹ 63.45 crore) from investing activities in March'22 as compared to cash utilisation of (₹ 194.7 crore) in March'21. The capex started last year towards purchase of capital goods/ maintenance capex/ CWIP also continued this year by the Company amounting to ₹ 103.22 crore (Previous year ₹ 217.47 crore). The major receipts from investing activities were maturity of Fixed deposit & interest of ₹ 39.61 crore in March'22 (₹ 22.68 crore in March'21).
- c. Cash Flow from Financing Activities: The net cash used in Financing activities was (₹ 323.67 crore)

in March'22 as compared to (₹ 333.05 crore) cash utilisation in March'21. The major portion of cash utilisation in March'22 was interest of ₹ 446.44 crore on the term Ioan and working capital limits taken by the company (₹ 443.91 crore in March'21). The inflow in financing activities in March'22 was working capital borrowing of ₹ 122.77 crore (₹ 110.86 crore net in March'21).

d. Cash Flow Summary: Overall, there was a net Cash utilisation of (₹ 171.15 crore) in FY'22 due to increase in working capital, interest and Capital expenditure (previous year cash utilisation was ₹ 207.25 crore).

## Overview

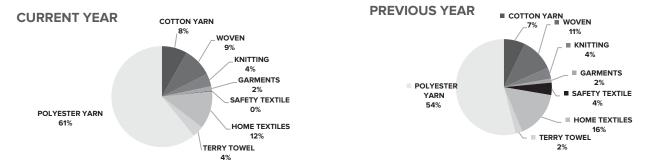

As apparent from Chart 19, polyester yarn accounts for highest share in total sales with a share of 60.8% (54% in the previous year). This is followed by sheeting (Bed sheets) whose share came down to 12.1% (16.0% in the previous year), followed by woven fabrics whose share in the current year was 9.4% down from 11.2% % in the previous year. The share of cotton spinning for the current year was 8.1% as compared to 7.2% in the previous year. The share of knitted fabrics for the current year was 4.2% as compared to 3.7% in the previous year. The share of terry towels for the current year was 3.7% as compared to 2.3% in the previous period garment share was 1.5% as compared to 1.4% in the previous year and lastly the share of Safety Textiles was 0.1% as compared to 4.2% in the previous year.

## Exports

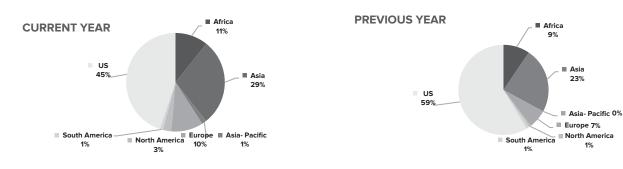
Alok's export business has increased to ₹ 1699.54 crore in the current year as against ₹ 957.20 crore in the previous period representing growth of 77.55%.

Table 9 gives the share of different regions in Alok's exports. The same is represented by way of a pie chart in chart 23. Though USA share in overall exports has come down, it remains the dominant market with 44.88% share in the current year (Previous year 58.58%). The share of Asia has increased from 23.42% in the previous year to 28.64% in the current year, and Europe has increased from 6.69% in the previous year to 10.72% in the current year. Share of African continent has increased to 10.38% in the current year as compared to 9.48% in the previous year.

## **Textiles: Mileta**

Through its step-down subsidiary, Alok Industries International Limited, BVI, Alok has a 100% stake in Mileta, a Czech-based fabric manufacturing company. Mileta's facilities are located in Horice (Weaving and Administration) and Cerny Dul (Processing) in the Czech Republic.

Mileta has high end technological skill in yarn-dyed fabrics and hemming that results in higher per unit realisations. The Mileta range of products includes high quality shirting, batistes and voiles, complete line of functional table linen, bed linen and handkerchiefs. It supplies its fabrics to almost all the leading brands in Europe.

For the year ended 31st March 2022, Mileta has achieved sales of  $\overline{\mathbf{x}}$  159.23 crore and made a loss of  $\overline{\mathbf{x}}$  8.70 crore as compared to sales of  $\overline{\mathbf{x}}$  112.23 crore and loss of  $\overline{\mathbf{x}}$  (18.42) crore in 31st March 2021.

## UK Retail: Store Twenty One

Alok held 99.87% equity in Grabal Alok (UK) Ltd, through its step down subsidiary Alok Industries International Limited and Grabal Alok International Limited. Grabal Alok UK used to operate the 'Store Twenty One' chain of value-format stores in UK.

Grabal Alok UK was taken under liquidation on 10th July 2017. The Company has provisioned for the entire investment.

## Investment: Alok Infrastructure Limited

The Company had made some investments in the realty sector through its 100% subsidiary Alok Infrastructure Limited. The plan was to create value and monetise the same at the right opportunity. However, depressed market conditions in the real estate space resulted in the Company having

to dispose -off some of its assets at losses. The Company has also provided for the loans / advances to the extent not recoverable from its subsidiaries. There are no operations being carried out presently in Alok Infrastructure and it had a revenue of ₹ 0.03 crore for the year (Previous Year ₹ 0.04 crore) and loss for the year was ₹ 12.50 crore (Previous Year loss of ₹ 469.88 crore)

## **Other Subsidiaries**

The other direct and step-down subsidiaries of the Company are non-operational. The performance of all of subsidiaries and step down subsidiaries are given in table 13.

With a total employee strength as on 31st March, 2022, including contract workers at **26462**, your company strives to become an "Employer of Choice", and to achieve this goal, the company's HR Policies & Practices are being geared up. To bring about Transparency, Uniformity and Consistency, many of the existing HR rules & policies were revised during the year, and few new policies were developed, wherever required, including social security schemes for the employees, which have been well received and have provided an empowering environment to employees.

To improve the skill gap and deploy trained manpower at workplace, especially in the mill operations, there has been a constant focus on building the capability of our workforce and of newly engaged contract labourers. Numerous functional skill development initiatives, as well as workplace training programs were delivered throughout the year, for both direct employees and contract labourers.



Employee Productivity continued to be the focus area during the year and various initiatives to provide monetary incentives, reward & recognitions for improving attendance, work efficiency, enhanced output etc. were taken up. Efforts in improving gender diversity has shown positive results with increase in women workforce, especially in Made-up & Garments division.



To establish better Employee Connect, multiple forums & mediums were used by management, such as Central Grievance Cell, open house session entitled "Man Ki Baat" for workers, weekly breakfast meetings at residential colony with Permanent Workers, Jobbers & Trainees etc. for a two-way communication & interaction; thereby creating a platform to understand new challenges, key concerns and find redressal solutions.



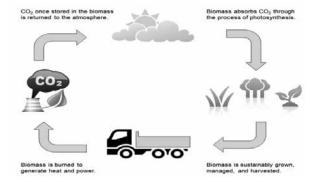
The Industrial Relation during the year was harmonious because of manpower being positively engaged and collaborative work approach in place. All employees, contract labourers & vendor partners have contributed significantly to the growth of the organization.

# Sustainable Business Practices and Social Responsibility initiatives

Having innovative product offerings with a lower carbon footprint, your company remains committed to its core values on Environment, Health, Safety, Society, and Sustainability. Much of your Company's improvements have been through constantly evolving new ideas to protect environment, create efficient product and processes, while adapting and applying latest guidelines pertaining to energy efficiency measures. The aim of the Company is to accelerate dependence on renewable energy, water conservation through rainwater harvesting, recycling of water, war against waste at the factories and try alternative fuel consumptions.

Some of the key initiatives of your Company in the areas of sustainable business practices and social responsibility initiatives during FY 21-22 are listed below:

 Use of biomass briquettes of cotton seed /dust, a remnant / waste of cotton spinning process, saw dust / ground nutshell as fuel in solid fuel fired boilers for steam generation thereby contributing to save ozone movement in right earnest. Biomass, a plant-based material is used as fuel to produce heat and electricity. Biomass being a low carbon fuel / energy source, comes from plant material such as wood, corn, sugarcane, ground nut etc. and is a low cost, renewable and abundant alternative to fossil fuels viz. coal, gas and oil, which are presently mass used due to ever increasing energy demand but are likely to get exhausted in near future.



 Use of recycled products by setting up a recycled Polyester Unit to recycle Polyester and Polyester Yarn waste and flakes to produce 100% recycled Polyester Fibre. Solid wastes at the processing plant are managed

through an external solid waste management company. Company also has effluent treatment plants for primary, secondary, and tertiary treatment of effluents.

- Successfully established new Solar Power Plant of 1.4 MW at Silvassa during the reporting period.
- 4. Apart from helping employees during the pandemic, extended support to communities at large through several social responsibility initiatives, especially in Silvassa, such as establishing Skill Development Centre for Garment Stitching, monetary donations for establishing the Dialysis Centre at Civil Hospital and an Auditorium for SSR College, Silvassa.

As such, adopting to circular economy through waste recovery plant, material efficiency, initiatives on green cover plantation and community welfare are important components of Company's sustainability strategy going forward.

#### **Risks & Risk Mitigation**

This section contains the Company's view on risk and the critical risk factors & threats for the Company. This section also provides how the Company manages risk through its risk management processes.

#### Threats:

The company is concerned about the various threats that it is exposed to which includes factors such as rising competition in the market both on the domestic & export front, duty free access to competing countries in US & European markets, uncertain business environment including impact of COVID-19 pandemic, fluctuating rupee, cost of raw material and its availability, slowdown in demand & change in fashion trends, possibility of increase in interest rates, etc. Besides this the Company is also exposed to factors such as the change in government policies, duties & taxes, availability of power from the grid, availability of labour etc. The Company tries to mitigate these risks by taking quick actions and proactive initiatives and minimize the impact of these risk to the extent possible. Some of these threats are discussed briefly here and in detail in the respective risk factors.

- No free trade agreement with Europe: Competing Countries like Bangladesh, and Vietnam get duty-free access to the European markets, while India pays 9-10 % duty on exports. This is because Bangladesh is a least developed country (LDC) and is given preferential treatment by developed countries. And, Vietnam has a free trade pact with the European Union.
- Increasing Competition from low cost producing countries: Labour in India is relatively more expensive

as compared to other low-cost producers like Vietnam, Pakistan, and Bangladesh. An Indian garment worker earns about \$ 250 month, while a Bangladeshi worker gets only \$ 105. And the monthly wage of a worker in Vietnam is \$ 215. Moreover, the productivity of a Bangladeshi worker is better than that of Indian workers.

- Exchange-rate of Rupee: Overvalued rupee affects the competitiveness of the textile sector as exports become more expensive. Comparatively, Bangladeshi Taka is weaker than Indian rupee making its exports cheaper. Also, Vietnamese dong has been pegged to the US dollar, making the exchange rate more stable in comparison to India. This threat is discussed under the risk "Currency Risk".
- Raw material prices & availability: The raw material prices (cotton, cotton yarn, MEG & PTA) are subject to market conditions and can vary upward & downward during the year. Raw material being substantial portion of our Cost, about 55% 60%, therefore has an impact over company's performance. This threat is discussed in detail under the risk "Raw Material".
- Slow-down in demand/ change in fashion: The Company's performance also depends upon the demand situation. Any slowdown in demand may lead to decline in production/ sales and thus impact profitability. Similarly, company's value-added segment of Apparel Fabrics and to some extent Home Textile, are also subject to change in fashions and consumer behaviour. This threat is discussed in detail under the Risk "Markets".
- Increase in Interest rates: The Company has taken term loans and working capital limits loans from the banks on floating rate basis. Any increase in interest rate would have impact on the bottom line of the Company. This threat is also discussed in detail under the risk "Financial Risk".
- Rigid Labour related Policies: Compared to Indian labour laws, the labour laws in the competing countries are quite flexible for hiring & firing the people as per the need of the business, which give their entrepreneur an upper hand.
- Change in Government Policies: The business also has a threat of sudden change in government policies like policies relating to export & import of certain products, change in customs duty structure, change in export incentives, change in GST rates, etc

Please also refer the other risks provided in this section "Risk & Risk Mitigation".

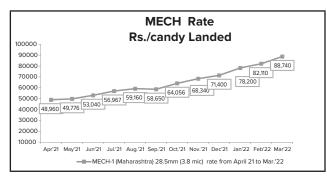
#### **Raw Material**

Raw material being the major cost of production, Company's operations and profitability are significantly dependent on price and timely availability of raw materials used in production process. The primary raw materials for our textile operations are raw cotton and Purified Terephthalic Acid (PTA) & Mono-Ethylene Glycol (MEG). The Company also buys cotton yarn, polyester yarn and fabrics of specifications required by customers which are not produced in its plants or in case the internal capacities are not available.

#### Cotton:

Being an agricultural commodity, prices of cotton are affected by a range of factors like changes in weather conditions affecting sowing, government policies and regulations. Governing taxes, tariffs, duties, subsidies, import and export restrictions on agricultural commodities, overall supply situation in the world, etc. all of these influence pricing and demand supply situation in this industry. The planting of certain crops versus other uses of agricultural resources, the location and size of crop production, volume and types of imports and exports, etc. determine availability of cotton. As the Chart- 24 below shows cotton prices during 2021-22 increased unprecedently. The prices of raw cotton witnessed increasing trend throughout the year. The Cotton price increased from ₹ 48,960/- per candy (356 kgs. Ginned Cotton) in April'21 to ₹ 88,740/- per candy in March 2022.

#### **Chart 24: Price Movement of Cotton MECH**



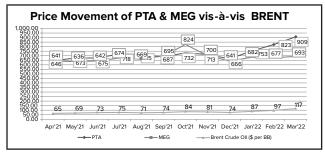
The Company has an experienced team for procurement of raw cotton with a deep understanding of this natural fibre. As a Company, we have adopted various processes whereby we are expanding our sources across different supply chain intermediaries and other stake holders. Cotton being an international commodity, our focus remains optimizing domestic and international opportunities to create a competitive edge of sourcing based on landed cost.

#### Polyester:

For the Company's polyester yarn operations, PTA and MEG are the major raw materials that are required in the

manufacturing of Partially Oriented Yarn (POY) and other polyester yarn. Being, petrochemical products, prices of PTA and MEG are linked to naphtha prices and ethylene prices, respectively, which in turn fluctuate in line with fluctuations in the crude oil prices as can be seen from the Chart 25 below.

#### Chart 25: Price Movement of PTA & MEG



As can be seen from the chart 22 above, both PTA and MEG prices during the financial year 2021-22 were having upward trend in tandem with the price of crude oil (Brent).

PTA prices moved from bottom of USD 646 per ton in April 2021 and showed a rising trend and reached peak of USD 909 per ton in March 2022.

MEG prices also increased from bottom of USD 641 per ton in April 2021 to USD 693 per ton in March 2022.

Being a commodity product, the prices of finished goods like Draw Texturised Yarn (DTY) and Fully Drawn Yarn (FDY), etc. also move with the movement in raw material prices albeit with a lag on both sides.

The Company has assured supplies of PTA & MEG requirement, from Reliance Industries Limited at internationally competitive prices and on arm's length basis.

#### Markets

The Company's products are sold in both domestic as well as exports markets. While the company's major sales are in domestic market (about 75%), exports are also expected to remain a sizeable part (about 25%) of the Company's revenues.

The Company's exports markets, predominantly USA, Europe, and Asia, are very competitive with very high emphasis on timely delivery. The company exports almost all its products. Home textiles (bedding & Towels) are the major chunks of Company's exports constituting about 55% of the total exports.

Ability to develop products as demanded by customers and new designs development capability are critical factors for exports markets. The Company has been, so far, successful in meeting these demands over the years and has also won several export awards in the past instituted by the Government and Export Promotion Councils.



## MANAGEMENT DISCUSSION AND ANALYSIS



India, for past few years, no longer enjoys preferred market access in terms of concessional import duties in major exporting countries like USA & Europe. This is making countries like Bangladesh comparatively more price competitive. As a result, while the overall demand for textile products in Company's major markets is not declining, other nations like Bangladesh are competing aggressively to capture market share. The Company is progressively widening its markets with increasing focus on Asia and some countries in Africa to mitigate the challenges that are likely to arise in the developed markets. The Company has been able to retain key customers in USA and Europe, albeit with lower volumes. Now with completion of the necessary maintenance of its plants, the Company is confident of bringing into its fold, customers who have moved away in the last few years, given the quality of the products and capacity to supply large volumes consistently.

In the domestic market as well, the Company faces competition from organised big players and the unorganised small & fragmented players. The Company has developed a good reputation amongst the domestic traders, garment manufacturers and brands due to its quality, design capabilities and cost. Further, the Company has now started building relationships with large retailers (physical and online) to supply fabrics and garments. The Company's operations are now getting scaled up and it is fully prepared to meet large volumes. The Company is confident that it would regain a preferred supplier status for big brands & retailers given the quality, design capability and the capacity available to provide large volumes on a consistent basis.

The Company has been a leading supplier of polyester yarns over the years given its large capacity, the quality, and the range of its products. The Polyester operations are now fully stabilized, and the Company has re-establishing itself as a premium supplier of polyester yarn and fibre.

#### Information Technology Risk

Information and Technology being the major backbone of Company's overall operation and data storage/ analysis, is another key risk area identified by the Company and several measures are being taken to strengthen the same and mitigate the risk associated with this.

The company is in the process of re-implementing SAP to replace the present instance, which has been functional since 2007 with unsubscribed enterprise support service status. A team of consultants are working with our business teams to understand the present processes and configure the same on new landscape. Following core modules are expected to go live before next financial year (2023-24):

- 1. Sales and Distribution
- 2. Materials Management
- 3. Finance and Controlling
- 4. Production and Planning
- 5. Quality Management
- 6. Plant Maintenance
- 7. Logistics & EWM
- 8. Human Capital Management

Other modules/functions such as CRM, BI etc. are planned in phase 2, after the core modules stabilise. Required functional and technical teams are being mobilised to ensure timely implementation.

Infrastructure, network, and applications continue to be secured through firewalls and role-based authorizations. In addition to the generator power backup provided by building facility infrastructure, multiple UPS systems installed in data Centre supports power requirement for another 4-6 hours. New SAP landscape is proposed to be installed at a data Centre, which ensures redundancy and concurrent maintainability.

SAP database is secured by replicating online at different geographical locations using different technologies to mitigate risks arising out of any possible technology issues. This is done with the primary objective to achieve highest possible Recovery Point Objective (RPO). However, Recovery Time Objective (RTO) remains a constraint as the current environment does not run on a scalable infrastructure. This is considered in the new implementation as a key requirement and a much more robust database replication is being planned to ensure higher RTO.

Cyber security being a major concern for the IT ecosystem, we are working on developing a strong cyber security architecture which can protect our landscape from a wider range of security threats. Access to computing infrastructure such as servers, workstations, network devices etc are monitored very closely for possible security threats. Necessary controls are strengthened on a continuous basis. This is one of the primary focus areas of IT department. A dedicated IT security cell is also being planned.

Remote working is enabled for all employees who need to access company's computing resources from anywhere through secure and controlled paths created through VPN. Some of the improvements done during the financial year are:

- Most of the old and obsolete IT systems are replaced with new systems.
- End-point security has been upgraded to "Endpoint Detection and Response Optimum"
- Network infrastructure is being hardened to mitigate security threats (ongoing process).



- Implemented stronger password management, Multifactor Authentication (MFA), MAC address binding etc in various applications and devices.
- Adequate redundancy (from different service providers) has been provided to ensure seamless connectivity across manufacturing locations.

#### **Financial Risk**

The Company's operations and capacity utilisation are gradually improving. The Company is having term Ioan assistance from banks of ₹ 5,137 crore and working capital limits of ₹ 415 crore. The Company is required to meet interest obligation on these Ioans periodically and would also have to meet the repayment of term Ioan as per the terms of sanction. Moreover, the Company's Ioans are linked to MCLR of the sanctioning banks. Any increase in MCLR would lead to increase in interest rate for the Company on its borrowings.

The Company's present rating is AA (by CARE) based on the financial support from its Promoters. The Company has been generating adequate cash profits and meeting its obligations on time. Thus we does not foresee any major risk on this account.

#### **Currency Risk**

The Company is subject to currency exposure risk given its significant size of exports. The company's imports are much lower as compared to its exports and thus as far as foreign currency payments are concerned, the company has a natural hedge. The Company has been sanctioned a limit to hedge the currency exposure on export receivables and has started covering exports to the extent needed to cover open risk (net). The Company also has in place a hedging policy to mitigate currency risks. The currency risk is thus adequately mitigated.

#### Impact of COVID-19 Pandemic

The second and third wave of COVID-19 pandemic had impacted the normal business operations of the Company by way of interruption in production, supply chain disruption, unavailability of personnel, etc. However, the company was well geared with set processes and precautionary measures as a result there was not much impact on production and supply of goods.

The situation relating to pandemic is, however, dynamic and changing rapidly giving rise to uncertainty around the extent and timing of the potential future impact of the pandemic which may be different from that estimate made by the Company. We have clearly seen the impact of second wave of the pandemic in the first quarter of FY 2021-22. The Company has made detailed assessment of its business scenario for the current year (FY 2022-23) and do not foresee any major challenges on this account. The Company is closely monitoring and would account for any material changes arising out of future economic conditions and impact on its business.

#### Outlook

With completion of necessary capital expenditure to rampup the plants, the operations of the company are gradually increasing. The human resources required to cope-up with the growth requirements of the company are also gradually being put in place. The company is progressively improving its capacity utilization and regaining its market share. It is also generating adequate cash-flows to meet its obligations. We, therefore, look at the future optimistically.

#### Internal Control and Adequacy

The Company has in place a well-established framework of internal control systems which are commensurate with the size and complexity of its business. The Company has an independent internal audit function covering major areas of operations and the same is carried out by external Chartered Accountant firm engaged for this purpose.

As on 31st March, 2022, the Board consists of seven Directors comprising three Independent Directors including one Woman Director and four Non–Executive Directors. Commensurate with the size of the Company, complexity and nature of underlying business, the composition of the Board represents an optimal mix of professionalism, knowledge and experience and enables the Board to discharge its responsibilities and provide effective leadership to the business. The Independent Directors bring external perspective and independence to decision making.

All the Independent Directors have confirmed to the Board that they meet the criteria for Independence in terms of the definition of 'Independent Director' stipulated under Regulation 16(1)(b) of the Listing Regulations and Section 149 of the Act. Further, all the Independent Directors have confirmed that their names are included in the databank of Independent Directors maintained by Indian Institute of Corporate Affairs ("IICA") and have passed / are exempted from the online proficiency self assessment test. These confirmations have been placed before the Board. None of the Independent Directors hold office as an Independent Director in more than seven listed companies as stipulated under Regulation 17A of the Listing Regulations. The maximum tenure of Independent Directors is determined in accordance with the Act and rules made thereunder, in this regard, from time to time.

All the Directors have made necessary disclosures regarding their directorships as required under Section 184 of the Act and the Committee positions held by them in other companies as stipulated under Regulation 26 of Listing Regulations. All the Directors of the Company are in compliance of Regulation 17A and 26 of the Listing Regulations regarding their Directorships, Committee Membership and Chairmanship of the Committee. The Company had complied with and adopted the mandatory requirements of the Listing Regulations except (i) noncompliance with respect to submission of financial results mentioned in above paragraph, and (ii) non-compliance with respect to the disclosures and filings required to be submitted by the Company, with respect to non-convertible debentures issued by the Company, with the Stock Exchanges under the Listing Regulations. The Company has vide e-mail dated 16th November, 2018 to SEBI confirmed the compliance of the relevant provisions under the Listing Regulations dealing with disclosures and submissions required to be made with respect to non-convertible debentures for the period ending 30th September, 2018. Further, the Company has sought relief from the non-compliance of the certain provisions of the Listing Regulations for the period prior to commencement of the Corporate Insolvency Resolution Process of the Company. SEBI had, post conclusion of the hearing in the subject matter, imposed a penalty of ₹ 12 lakhs on the Company, which was contested at the Securities Appellate Tribunal, Mumbai ("SAT"). SAT had ruled that no penalty is payable and this decision has been contested by SEBI at the Supreme Court. A decision in this regard is awaited.

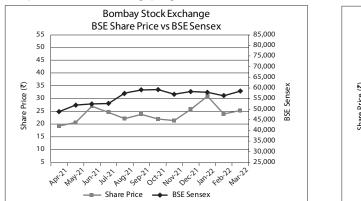

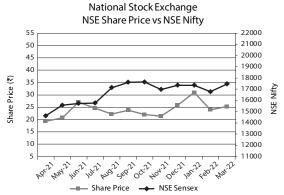

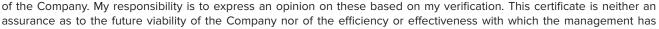

The products of the Company are manufactured in compliance with applicable laws, regulations and the products are supplied in the Business to Business segment. The Company's manufacturing processes have adequate systems and processes which ensure protection of environmental factors like reduction of emissions, discharge of pollutants and hazardous waste and treatment thereof in systematic manner to minimize adverse environmental impact. The Company prioritizes domestic sourcing wherever possible. Efforts are also made to transport maximum cargo via ship/rail.

The manufacturing process also takes care of other aspects like minimizing and treatment of occupational disease, safety measures to avoid accidents, fire / leakages by adopting certain measures including a) selecting right equipment, processes, inputs and tracking emissions and b) organizing safety awareness programs, safety training, structural audit. The Company also provides employment opportunities to local people around its manufacturing plants.

The Company operates in Business to Business segment therefore the Company's products do not have any broad-based impact in the reduction of consumption of energy and water by its consumers. The Company has a structured procedure for sourcing to ensure raw materials are sourced in an optimal and sustainable manner. The Company procures key raw material like raw cotton from Maharashtra, Gujarat and Madhya Pradesh, Cotton Yarn from Tamil Nadu, Maharashtra, PTA, MEG and Furnace Oil from Gujarat and Chemicals and Dyes from Maharashtra and Gujarat. The sourcing of raw materials like cotton, cotton yarn, PTA, MEG were made through rail wagons and road transport.

The Company believes in inclusive growth and encourages local sourcing wherever possible. Most of such local suppliers are categorized under MSME (Micro, Small & Medium Enterprises) sector. To ensure improvement of capacity and capability of such local suppliers the Company ensures the timely payments against the respective services rendered by them. The Company do avail/employ people residing in vicinity of plants of the Company, whenever required, for the purpose of its manufacturing activities. The Company is providing technical and safety training, as required in plant, which makes them more reliable and employable in safe ways.

The Company encourages the use of recycled products and has set up a recycled polyester unit to recycle polyester and polyester yarn waste and flakes to produce 100% recycled polyester fiber. In view, however of the reduced capacity utilization, over the past few years, the percentage of recycling is not significant. Solid waste at the processing plant is managed through an external solid waste management Company. Alok also has an effluent treatment plant for primary, secondary and tertiary treatment of effluent.

#### **Report on the Audit of the Standalone Financial Statements**

#### Opinion

We have audited the accompanying standalone financial statements of Alok Industries Limited ("the Company"), which comprise the Balance sheet as at March 31 2022, the Statement of Profit and Loss including the statement of Other Comprehensive Income, the Cash Flow Statement and the Statement of Changes in Equity for the year then ended, and notes to the standalone financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid standalone financial statements give the information required by the Companies Act, 2013, as amended ("the Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2022, its loss including other comprehensive income, its cash flows and the changes in equity for the year ended on that date.

#### **Basis for Opinion**

We conducted our audit of the standalone financial statements in accordance with the Standards on Auditing (SAs), as specified under section 143(10) of the Act. Our responsibilities under those Standards are further described in the 'Auditor's Responsibilities for the Audit of the Standalone Financial Statements' section of our report. We are independent of the Company in accordance with the 'Code of Ethics' issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Act and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion on the standalone financial statements.

#### **Emphasis of Matter**

We draw attention to Note 34 of the standalone financial statements in respect of the resolution plan approved by the National Company Law Tribunal vide its order dated March 8, 2019 under section 31(1) of the Insolvency and Bankruptcy Code, 2016. The Company has accounted the assigned debt as per the aforesaid resolution plan at cost, overriding the Indian Accounting Standards which would require the Company to recognize the assigned debt at its fair value and accordingly the imputed interest cost over the period of the loan. Our opinion is not modified in respect of this matter.

#### **Key Audit Matters**

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the standalone financial statements for the financial year ended March 31, 2022. These matters were addressed in the context of our audit of the standalone financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. For each matter below, our description of how our audit addressed the matter is provided in that context.

We have determined the matters described below to be the key audit matters to be communicated in our report. We have fulfilled the responsibilities described in the Auditor's responsibilities for the audit of the standalone financial statements section of our report, including in relation to these matters. Accordingly, our audit included the performance of procedures designed to respond to our assessment of the risks of material misstatement of the standalone financial statements. The results of our audit procedures, including the procedures performed to address the matters below, provide the basis for our audit opinion on the accompanying standalone financial statements.

# AUDITOR'S REPORT on Standalone Financial Statement



#### Key audit matters

#### Recoverability of loan given to wholly owned subsidiary

The Company had in earlier years given loan to Alok Infrastructure Limited (a wholly owned subsidiary of the Company or "AIL"). As at March 31, 2022, the outstanding balance of loan is ₹ 1,372.99 crores (gross of impairment allowance of ₹ 1,190.87 crores). AlL does not have significant business operations and has made a loss of ₹ 12.50 crores for the year ended March 31, 2022 and has accumulated losses of ₹ 1,492.39 crores as on March 31, 2022.

To assess the recoverability of the outstanding loan, the Company has considered the valuation of the AlL's investment properties / inventories performed by the subsidiary with the help of external valuation specialists and has accordingly assessed that there is no further provision required for the year ended March 31, 2022.

Considering the assumptions / judgment used in valuation under the sales comparison method of market approach / depreciation replacement cost method under cost approach, the same has been considered as a key audit matter. Refer Note 6 of the standalone financial statements.

#### Capitalization of property, plant and equipment

In the earlier years, prior to implementation of the NCLT approved resolution plan, the Company was operating at a lower capacity utilization and overall maintenance activity at the plant was curtailed due to lack of working capital. Consequently, many of the plant and machinery remained idle / non-functional and in most cases the machinery's operating speed was reduced, resulting in lower efficiency and production.

In the previous year, the re-constituted Board of Directors had approved a business plan which also included capital expenditure to overhaul the plant and machinery at the Company's manufacturing locations.

During the year ended March 31, 2022, the Company has incurred expenditure of ₹ 114.99 crores, largely related to purchase of spares to overhaul the existing plant and machinery in order to improve their efficiency and increase the capacity utilization. Further, the Company has capitalised ₹ 8.81 crores out of the capital work in progress of the previous year.

Judgement is involved to ensure that the aforesaid expenditure meets the specific recognition criteria under Ind AS 16, 'Property, Plant and Equipment'.

Accordingly, the same is considered as a key audit matter. Refer Note 2, 4 and 32 of the standalone financial statements.

#### Recoverability of carrying value of property, plant and equipment

In the previous year, consequent to the business plan approved by the re-constituted Board of Directors of the Company, the Company had through an external valuation specialist determined the value in use of property, plant and equipment and recorded an impairment provision of ₹ 8,264.22 crores in the books.

Based on recent business developments, the Board has made required revisions to the business plan and has accordingly updated the value in use calculations using the discounted cash flow method with the help of an external valuation specialist. Based on the same, the Company has determined there are no material adjustments required to the impairment allowance already recorded. The value in use is sensitive to changes in certain inputs / assumptions used for forecasting the discounted cash flow projections due to inherent uncertainty involved in these assumptions. Accordingly, the same has been considered as a key audit matter.

#### How our audit addressed the key audit matter

Our audit procedures included and were not limited to the following:

- Obtained and read the audited financial statements of Alok Infrastructure Limited for the year ended March 31, 2022.
- Performed inquiry procedures with auditor of Alok Infrastructure Limited and discussed the audit procedures performed by them on the valuation report issued by the external specialists in respect of the subsidiary's investment properties/ inventories.
- Assessed key valuation aspects of the investment properties / inventories of Alok Infrastructure Limited by engaging internal valuation specialists.
- Assessed the disclosures made in the standalone financial statements.

In the earlier years, prior to implementation of the NCLT approved Our audit procedures included and were not limited to the following:

- Assessed the design and operating effectiveness of controls of the Company relating to capitalization of property, plant and equipment (including capital work in progress).
- Assessed on test basis for samples selected, that the recognition criteria under Ind AS 16 is met.
- Inquired with management on any significant variation (if any) between the approved capex budget in previous year with the actual expenditure incurred as at the balance sheet date.
- Assessed disclosures made in the standalone financial statements.

Our audit procedures included and were not limited to the following:

- Obtained the revised cash flow projections as approved by the Board of Directors.
- Assessed the valuation methodology applied in determining the value in use. In making this assessment, we evaluated the objectivity and independence of Company's external specialists involved in the process.
- Assessed key assumptions applied to arrive at the value in use by involving internal valuation specialists

Further, the Company has in earlier years granted loans to companies of ₹ 1,465.99 crores (on which impairment allowance of ₹ 1,465.99 crores has been made as at March 31, 2022) where the schedule of repayment of principal and payment of interest has not been stipulated. Accordingly, we are unable to make a specific comment on clause 3(iii)(d) on amounts overdue for more than 90 days and whether reasonable steps have been taken by the Company for recovery of the principal and interest in respect of such loans.
  - (e) The Company has in earlier years granted loans to a wholly owned subsidiary amounting to ₹ 1,372.99 crores (on which impairment allowance)

of ₹ 1,190.87 crores has been made as at March 31, 2022) in respect of which, the loan has not fallen due during the year. Further, the Company has in earlier years granted loans to companies of ₹ 1,465.99 crores (on which impairment allowance of ₹ 1,465.99 crores has been made as at March 31, 2022) where the schedule of repayment of principal and payment of interest has not been stipulated. Accordingly, in respect of such loans, we are unable to make a specific comment on clause 3(iii)(e) on whether loans granted to companies have fallen due during the year. # NOTES

to Standalone Financial Statements for the year ended 31st March, 2022

#### CORPORATE INFORMATION

Alok Industries Limited ("The Company") is a Public Limited Company, domiciled in India and incorporated under the provisions of the Companies Act, 1956. The equity shares of the Company are listed on the Bombay Stock Exchange (BSE) and National Stock Exchange (NSE). It is primarily engaged in the business of textile manufacturing including mending and packing activities. The registered office of the Company is located at 17/5/1, 521/1, Village Rakholi/ Saily, Silvassa, The Union Territory of Dadra and Nagar Haveli-396230.

Pursuant to an application made by the State Bank of India, the Hon'ble National Company Law Tribunal, Ahmedabad bench ("Adjudicating Authority"), vide its order dated 18th July, 2017, had ordered the commencement of the corporate insolvency resolution ("CIR") process in respect of the Company under the provisions of the Insolvency and Bankruptcy Code, 2016 (the "Code"). Pursuant to its order dated 8th March, 2019 ("NCLT Order"), the Adjudicating Authority approved the resolution plan submitted by the Resolution Applicants for the Company under Section 31 of the Insolvency and Bankruptcy Code, 2016 ("Code") ("Approved Resolution Plan"). As per the terms of Section 31 of the Code, the Resolution Plan shall be binding on the Company, its employees, members, creditors, guarantors and other stakeholders involved in the Resolution Plan. During the previous year, the Company has completed all the implementation steps as required in the Resolution Plan.

#### NOTE 1: SIGNIFICANT ACCOUNTING POLICIES

#### a) Basis of preparation:

The financial statements of the Company have been prepared in accordance with Indian Accounting Standards (Ind AS) notified pursuant to section 133 of the Companies Act 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and Companies (Indian Accounting Standards) Amendment Rules, 2016(as amended from time to time) and presentation requirements of Division II of Schedule III to the Companies Act, 2013, (Ind AS compliant Schedule III), as applicable to the Financial statements ('Standalone Ind AS Financial Statements').

The financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies below:

- a. Derivative financial instruments,
- b. Certain financial assets and liabilities measured at fair value, and
- c. Defined benefit plans plan assets measured at fair value;

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Company takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of Ind AS 102, leasing transactions that are within the scope of Ind AS 116 'Leases' ("Ind AS 116"), and that have some similarities to fair value but are not fair value, such as net realisable value in Ind AS 2 'Inventories' ("Ind AS 2") or value in use in Ind AS 36 'Impairment of Assets' ("Ind AS 36").

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2, or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The principal accounting policies are set out below.

The financial statements are presented in  $\overline{\mathbf{T}}$ , which is the functional currency and all values are rounded to the nearest crore ( $\overline{\mathbf{T}}$  00,00,000), except when otherwise indicated.

#### b) Current versus non-current classification

The Company presents assets and liabilities in the balance sheet based on current/non-current classification. An asset is treated as current when it is:

- Expected to be realised or intended to be sold or consumed in normal operating cycle
- Held primarily for the purpose of trading
- Expected to be realised within twelve months after the reporting period, or
- Cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period.

All other assets are classified as non-current

A liability is current when:

- It is expected to be settled in the normal operating cycle
- It is held primarily for the purpose of trading
- It is due to be settled within twelve months after the reporting period, or
- There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period.

The terms of the liability that could, at the option of the counterparty, result in its settlement by the issue of equity instruments do not affect its classification.

The Company classifies all other liabilities as non-current.

Deferred tax assets and liabilities are classified as noncurrent assets and liabilities.

Based on the nature of services and the normal time between the acquisition of assets and their realisation into cash and cash equivalents, the Company has ascertained its operating cycle as 12 months for the purpose of current and non-current classification of assets and liabilities.

#### c) Foreign Currency Transactions and Translation

The management of the Company has determined Indian rupee (" $\mathfrak{T}$ .") as the functional currency of the Company. In preparing the financial statements of the Company, transactions in currencies other than the Company's functional currency ("foreign currencies") are recognised at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date.

Exchange differences on monetary items are recognised in statement of profit and loss in the period in which they arise except for:

 exchange differences on foreign currency borrowings relating to assets under construction for future productive use, which are included in the cost of those assets when they are regarded as an adjustment to interest costs on those foreign currency borrowings

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value is determined. The gain or loss arising on translation of non-monetary items measured at fair value is treated in line with the recognition of the gain or loss on the change in fair value of the item (i.e., translation differences on items whose fair value gain or loss is recognised in OCI or profit or loss are also recognised in OCI or profit or loss, respectively).

In determining the spot exchange rate to use on initial recognition of the related asset, expense or income (or part of it) on the derecognition of a non-monetary asset or non-monetary liability relating to advance consideration, the date of the transaction is the date on which the Company initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Company determines the transaction date for each payment or receipt of advance consideration.

#### d) Revenue from contract with customers:

The Company recognises revenue from the following major sources, acting in the capacity of principal:

- Sale of consumer product
- Other operating revenue

#### Sale of consumer product

The Company sells textile Products. The Company recognizes revenue on the sale of goods, net of discounts, sales incentives, estimated customer returns and rebates granted, commission, if any, when control of the goods is transferred to the customer.

Discounts given include rebates, price reductions and other incentives given to customers. The Company bases its estimates on historical results, taking into consideration the type of customer, the type of transaction and the specifics of each arrangement.

#### **Export Incentives**

Export benefits arising from Duty Drawback scheme, Merchandise Export Incentive Scheme and other eligible export incentives are recognised on post export basis at the rate at which the entitlements accrue and is included in the 'Other Operating Income' (Revenue from operation).

# Nature, timing of satisfaction of performance obligation and transaction price (Fixed and variable)

The Company recognises revenue when it transfers control of a product or service to a customer.

The control of goods is transferred to the customer depending upon the terms or as agreed with customer or delivery basis (i.e. at the point in time when goods are delivered to the customer or when the customer purchases the goods from the Company warehouse). Control is considered to be transferred to customer when customer has ability to direct the use of such goods



and obtain substantially all the benefits from it such as following delivery, the customer has full discretion over the manner of distribution and price to sell the goods, has the primary responsibility when onselling the goods and bears the risks of obsolescence and loss in relation to the goods.

Based on the terms of the contract and as per business practice, the Company determines the transaction price considering the amount it expects to be entitled in exchange of transferring promised goods or services to the customer. It excludes amount collected on behalf of third parties such as taxes.

The Company provides volume discount and rebate schemes, to its customers on certain goods purchased by the customer once the quantity of goods purchased during the period exceeds a threshold specified in the contract. Volume discount and rebate schemes give rise to variable consideration. To estimate the variable consideration to which it will be entitled, the Company considers that either the expected value method or the most likely amount method, depending on which of them better predicts the amount of variable consideration for the particular type of contract.

#### **Rendering of services**

Revenue from rendering of services is recognised over time considering the time elapsed. The transaction price of these services is recognised as a contract liability upon receipt of advance from the customer, if any, and is released on a straight line basis over the period of service.

# Contract assets, contract liabilities and trade receivables

Revenues in excess of invoicing are classified as contract assets (which we refer as unbilled revenue) while invoicing in excess of revenues (which we refer to as unearned revenues) and advance from customers are classified as contract liabilities. A receivable is recognised by the Company when the control over the goods is transferred to the customer such as when goods are delivered as this represents the point in time at which the right to consideration becomes unconditional, as only the passage of time is required before payment is due. The average credit period on sale of goods is 7 to 90 days.

#### **Dividend and Interest income**

Dividend income from investments is recognised when the Company's right to receive payment has been established (provided that it is probable that the economic benefits will flow to the Company and the amount of income can be measured reliably).

Interest income from a financial asset is recognised when it is probable that the economic benefits will

flow to the Company and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

#### e) Income taxes:

#### **Current tax**

Current tax payable is based on taxable profit for the year. Taxable profit differs from 'profit before tax' as reported in the statement of profit and loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Company's current tax is calculated using tax rates that have been enacted by the end of the reporting period.

#### **Deferred tax**

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the Ind AS financial statements and the corresponding tax bases used in the computation of taxable profit. While preparing standalone Ind AS financial statements, temporary differences are calculated using the carrying amount as per standalone Ind AS financial statements and tax bases as determined by reference to the method of tax computation.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- When the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss
- In respect of taxable temporary differences associated with investments in subsidiaries, associates and interests in joint ventures, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future

Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences, the carry forward of unused tax credits and unused tax losses to the extent that it is probable that taxable profits will be available against which deductible temporary differences and the carry forward of unused tax credits and unused tax losses can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and to Standalone Financial Statements for the year ended 31st March, 2022



liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Company expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Current and deferred tax are recognised in statement of profit and loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively. Where current tax or deferred tax arises from the initial accounting for a business combination, the tax effect is included in the accounting for the business combination.

#### f) Leases:

NOTES

The Company assesses at contract inception whether a contract is, or contains, a lease. That is, if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

#### Company as a lessee

The Company applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Company recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

#### i) Right-of-use assets

The Company recognises right-of-use assets at the commencement date of the lease (i.e., the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives

received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease term and the estimated useful lives of the assets, as follows

#### • Building 2 to 3 years

If ownership of the leased asset transfers to the Company at the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

The right-of-use assets are also subject to impairment.

#### ii) Lease Liabilities

At the commencement date of the lease, the Company recognises lease liabilities measured at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including insubstance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Company and payments of penalties for terminating the lease, if the lease term reflects the Company exercising the option to terminate. Variable lease payments that do not depend on an index or a rate are recognised as expenses (unless they are incurred to produce inventories) in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Company uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in the lease payments (e.g., changes to future payments resulting from a change in an index or rate used to determine such lease payments) or a change in the assessment of an option to purchase the underlying asset.

#### iii) Short-term leases and leases of low-value assets

The Company applies the short-term lease recognition exemption to its short-term leases (i.e., those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the lease of low-value assets recognition exemption to

leases of office equipment that are considered to be low value. Lease payments on short-term leases and leases of low-value assets are recognised as expense on a straight-line basis over the lease term.

#### Company as a lessor

Leases in which the Company does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. Rental income arising is accounted for on a straight-line basis over the lease terms. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

#### g) Property, Plant and Equipment

Assets held for use in the production or supply of goods or services, for rental to others or for administrative purposes, are stated in the standalone balance sheet at cost less accumulated depreciation and accumulated impairment losses. Freehold land is not depreciated, however, it is subject to impairment.

Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Cost includes professional fees and, for qualifying assets, borrowing costs capitalised in accordance with the Company's accounting policy. Such properties are classified to the appropriate categories of property, plant and equipment when completed and ready for intended use.

Likewise, subsequent cost incurred to overhaul the plant and machineries and major inspection costs are recognised in the carrying amount of the plant and equipment as a replacement if the recognition criteria are satisfied. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to statement of profit and loss during the reporting period in which they are incurred.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in statement of profit and loss.

Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use. Stand-by equipment and servicing equipment are recognised as property, plant and equipment if they are held for use in the production or supply of goods or services, for rental to others, or for administrative purposes and are expected to be used during more than one period. Property, plant and equipment which are not ready for intended use as on the date of Balance Sheet are disclosed as 'Capital work-in-progress'.

# Depreciation methods, estimated useful lives and residual value:

Depreciation is recognised so as to write off the cost of assets (other than freehold land) less their residual values over their useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis. Depreciation on property, plant and equipment has been provided on straight line method as per the useful life prescribed in Schedule II of the Company's Act, 2013, except in case of following assets, where useful life used is different than those prescribed in part C of Schedule II:

Asset category	Estimated useful life
Buildings	50 to 60 years
Plant and Machinery	15 to 40 years

Based on technical evaluation done by the Chartered Engineer, the management believes that the useful lives as given above, best represent, the period over which management expects to use these assets. Hence, the useful lives for these assets is different from the useful lives as prescribed under Part C of Schedule II of the Companies Act, 2013.

The residual values are not more than 5% of the original cost of the asset.

The residual values, useful lives and method of depreciation of property, plant and equipment are reviewed at each financial year end and any changes there in are considered as change in estimate and accounted prospectively.

#### h) Intangible assets:

#### Intangible assets acquired separately

Intangible assets with finite useful lives that are acquired separately are carried at cost less accumulated amortisation and accumulated impairment losses. Amortisation is recognised on a straight-line basis over their estimated useful lives. The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis. acquired separately are carried at cost less accumulated impairment losses, if any. The assessment of indefinite life is reviewed annually to determine whether the indefinite life continues to be supportable. If not, the change in useful life from indefinite to finite is made on a prospective basis.

#### Intangible assets acquired in a business combination

Intangible assets acquired in a business combination and recognised separately from goodwill are initially recognised at their fair value at the acquisition date (which is regarded as their cost).

Subsequent to initial recognition, intangible assets acquired in a business combination are reported on the same basis as intangible assets that are acquired separately.

#### Derecognition of intangible assets

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains or losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset are recognised in statement of profit and loss when the asset is derecognised.

#### Useful lives of intangible assets

Estimated useful lives of the intangible assets are as follows

#### i) Borrowing costs:

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Interest income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in the statement of profit and loss in the period in which they are incurred.

The Company may incur borrowing costs during an extended period in which it suspends the activities necessary to prepare an asset for its intended use or sale. Such costs are costs of holding partially completed assets and do not qualify for capitalisation. However, an entity does not normally suspend capitalising borrowing costs during a period when it carries out substantial technical and administrative work. The Company also does not suspend capitalising borrowing costs when a

temporary delay is a necessary part of the process of getting an asset ready for its intended use or sale.

The Company shall cease capitalising borrowing costs when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are complete.

#### j) Investment Property:

Investment properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at cost less accumulated depreciation and accumulated impairment loss, if any.

The cost includes the cost of replacing parts and borrowing costs for long-term construction projects if the recognition criteria are met. When significant parts of the investment property are required to be replaced at intervals, the Company depreciates them separately based on their specific useful lives. All other repair and maintenance costs are recognised in profit or loss as incurred.

The Company depreciates building component of investment property over 30 years from the date of original purchase.

The Company, based on technical assessment made by technical expert and management estimate, depreciates the building over estimated useful lives which are different from the useful life prescribed in Schedule II to the Companies Act, 2013. The management believes that these estimated useful lives are realistic and reflect fair approximation of the period over which the assets are likely to be used.

Though the Company measures investment property using cost-based measurement, the fair value of investment property is disclosed in the notes. Fair values are determined based on an annual evaluation performed by an accredited external independent valuer applying a valuation model recommended by the International Valuation Standards Committee.

Investment properties are derecognised either when they have been disposed of or when they are permanently withdrawn from use and no future economic benefit is expected from their disposal. The difference between the net disposal proceeds and the carrying amount of the asset is recognised in profit or loss in the period of derecognition. In determining the amount of consideration from the derecognition of investment property the Company considers the effects of variable consideration, existence of a significant financing component, non-cash consideration, and consideration payable to the buyer (if any).

Transfers are made to (or from) investment property only when there is a change in use.

#### k) Financial instruments

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

#### I. Financial Assets

#### A) Initial recognition and measurement

All financial assets are recognised initially at fair value plus, in the case of financial assets not recorded at fair value through profit or loss, transaction costs that are attributable to the acquisition of the financial asset.

#### B) Subsequent measurement

For purposes of subsequent measurement, financial assets are classified in four categories:

Debt instruments at amortised cost

A 'debt instrument' is measured at the amortised cost if both the following conditions are met:

- The asset is held within a business model whose objective is to hold assets for collecting contractual cash flows, and
- Contractual terms of the asset give rise on specified dates to cash flows that are solely payments of principal and interest (SPPI) on the principal amount outstanding.

This category is the most relevant to the Company. After initial measurement, such financial assets are subsequently measured at amortised cost using the effective interest rate (EIR) method. Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included in other income in the statement of profit and loss. The losses arising from impairment are recognised in the profit or loss. This category generally applies to trade and other receivables.

 Debt instruments at fair value through other comprehensive income (FVTOCI)

A 'debt instrument' is classified as at the FVTOCI if both of the following criteria are met:

- The objective of the business model is achieved both by collecting contractual cash flows and selling the financial assets, and
- The asset's contractual cash flows represent SPPI.

Debt instruments included within the FVTOCI category are measured initially as well as at each reporting date at fair value. Fair value movements are recognised in the other comprehensive income (OCI). On derecognition of the asset, cumulative gain or loss previously recognised in OCI is reclassified from the equity to statement of profit and loss. Interest earned whilst holding FVTOCI debt instrument is reported as interest income using the EIR method.

 Debt instruments at fair value through profit or loss (FVTPL)

FVTPL is a residual category for debt instruments. Any debt instrument, which does not meet the criteria for categorisation as at amortised cost or as FVTOCI, is classified as at FVTPL.

In addition, the Company may elect to designate a debt instrument, which otherwise meets amortised cost or FVTOCI criteria, as at FVTPL. However, such election is allowed only if doing so reduces or eliminates a measurement or recognition inconsistency (referred to as 'accounting mismatch'). Debt instruments included within the FVTPL category are measured at fair value with all changes recognised in the statement of profit and loss.

 Equity instruments measured at fair value through other comprehensive income (FVTOCI)

All equity investments in scope of Ind AS 109 are measured at fair value. Equity instruments which are held for trading and contingent consideration recognised by an acquirer in a business combination to which Ind AS103 applies are classified as at FVTPL. For all other equity instruments, the Company may make an irrevocable election to present in other comprehensive income subsequent changes in the fair value. The Company makes such election on an instrument-by-instrument basis. The classification is made on initial recognition and is irrevocable.

If the Company decides to classify an equity instrument as at FVTOCI, then all fair value changes on the instrument, excluding dividends, are recognised in the OCI. There is no recycling of the amounts from OCI to statement of profit & loss, even on sale of investment. However, the

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Company could be required to repay.

#### D) Impairment of financial assets

Company has retained.

The Company assesses on a forward looking basis the expected credit losses associated

with its assets carried at amortised cost and FVOCI debt instruments. The impairment methodology applied depends on whether there has been a significant increase in credit risk. For trade receivables only, the Company applies the simplified approach permitted by Ind AS 109 Financial Instruments, which requires expected lifetime losses to be recognised from initial recognition of the receivables.

# E) Investments in subsidiaries, associates and joint ventures

The Company has elected to account for its equity investments in subsidiaries, associates and joint ventures under IND AS 27 on Separate Financials Statements, at cost. At the end of each reporting period the Company assesses whether there are indicators of diminution in the value of its investments and provides for impairment loss, where necessary.

#### II. Financial Liabilities

#### A) Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables, or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

#### B) Subsequent measurement

The measurement of financial liabilities depends on their classification, as described below:

 Financial liabilities at fair value through profit or loss

Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss. Financial liabilities are classified as held for trading if they are incurred for the purpose of repurchasing in the near term. This category also includes derivative financial instruments entered into by the Company that are not designated as hedging instruments in hedge relationships as defined by Ind AS 109. Separated embedded derivatives are also classified as held for trading unless

Financial liabilities designated upon initial recognition at fair value through profit or loss are designated as such at the initial date of recognition, and only if the criteria in Ind AS 109 are satisfied. For liabilities designated as FVTPL, fair value gains/ losses attributable to changes in own credit risk are recognised in OCI. These gains/ loss are not subsequently transferred to statement of profit and loss. However, the Company may transfer the cumulative gain or loss within equity. All other changes in fair value of such liability are recognised in the statement of profit or loss.

Loans and Borrowings

This is the category most relevant to the Company. After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost using the EIR method. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the EIR amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included as finance costs in the statement of profit and loss.

Financial guarantee contracts

Financial guarantee contracts issued by the Company are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. Financial guarantee contracts are recognised initially as a liability at fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequently, the liability is measured at the higher of the amount of loss allowance determined as per impairment requirements of Ind AS 109 and the amount recognised less cumulative amortisation.

The fair value of financial guarantees is determined as the present value of the

difference in net cash flows between the contractual payments under the debt instrument and the contractual payments that would be required without the guarantee, or the estimated amount that would be payable to a third party for assuming the obligations.

#### C) De-recognition

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the statement of profit or loss.

#### D) Compound instruments

The component parts of compound instruments (optionally convertible preference share) issued by the Company are classified separately as financial liabilities and equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument. A conversion option that will be settled by the exchange of a fixed amount of cash or another financial asset for a fixed number of the Company's own equity instruments is an equity instrument.

At the date of issue, the fair value of the liability component is estimated using the prevailing market interest rate for similar non-convertible instruments. This amount is recorded as a liability on an amortised cost basis using the effective interest method until extinguished upon conversion or at the instrument's maturity date.

The conversion option classified as equity is determined by deducting the amount of the liability component from the fair value of the compound instrument as a whole. This is recognised and included in equity, net of income tax effects, and is not subsequently remeasured. In addition, the conversion option classified as equity will remain in equity until the conversion option is exercised, in which case, the balance recognised in equity will be transferred to other component of equity. When the conversion option remains unexercised at the maturity date of the convertible instrument, NOTES

the balance recognised in equity will be transferred to retained earnings. No gain or loss is recognised in statement of profit and loss upon conversion or expiration of the conversion option.

Transaction costs that relate to the issue of the convertible instruments are allocated to the liability and equity components in proportion to the allocation of the gross proceeds. Transaction costs relating to the equity component are recognised directly in equity. Transaction costs relating to the liability component are included in the carrying amount of the liability component and are amortised over the lives of the convertible instrument using the effective interest method.

#### III. Reclassification of financial assets / liabilities

After initial recognition, no reclassification is made for financial assets which are equity instruments and financial liabilities. For financial assets which are debt instruments, a reclassification is made only if there is a change in the business model for managing those assets. Changes to the business model are expected to be infrequent. The Company's senior management determines change in the business model as a result of external or internal changes which are significant to the Company's operations.

#### IV. Offsetting of financial instruments

Financial assets and liabilities are offset and the net amount is reported in the balance sheet where there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of Company or the counterparty.

#### V. Derivatives and hedging activities

The Company enters derivatives like forwards contracts to hedge its foreign currency risks. Derivatives are initially recognised at fair value on the date a derivative contract is entered into and are subsequently marked to market at the end of each reporting period with profit/loss being recognised in statement of profit and loss. Derivative assets/ liabilities are classified under "other financial assets/ other financial liabilities". Profits and losses arising from cancellation of contracts are recognised in the statement of profit and loss.

#### I) Inventories:

Finished goods are stated at the lower of cost and net realisable value. Raw material, packing materials and stores & spares are stated at costs unless the finished goods in which they will be incorporated are expected to be sold below cost. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

Costs incurred in bringing each product to its present location and condition are accounted for as follows:

- Raw materials, Packing Materials and stores & spares: cost includes cost of purchase and other costs incurred in bringing the inventories to their present location and condition.
- Finished goods and work in progress: cost includes cost of direct materials and labour and a proportion of manufacturing overheads based on the normal operating capacity, but excluding borrowing costs.

Due allowances are made for slow moving and obsolete inventories based on estimates made by the Company.

#### m) Impairment of non-financial assets

At the end of each reporting period, the Company reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any. When it is not possible to estimate the recoverable amount of an individual asset, the Company estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash-generating units, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Intangible assets with indefinite useful lives and intangible assets not yet available for use are tested for impairment at least annually, and whenever there is an indication that the asset may be impaired.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in statement of profit and loss.

When an impairment loss subsequently reverses, the carrying amount of the asset (or a cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or cash-generating unit) in prior years. A reversal of an impairment loss is recognised immediately in statement of profit and loss.

#### n) Provisions and contingent liabilities:

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that the Company will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (when the effect of the time value of money is material). When discounting is used, the increase in the provision due to the passage of time is recognised as a finance cost.

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

#### A contingent liability is:-

- a possible obligation that arises from past events and whose existence will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the entity; or
- b) a present obligation that arises from past events but is not recognised because:-
  - it is not probable that an outflow of resources embodying economic benefits will be required to settle the obligation; or
  - ii) the amount of the obligation cannot be measured with sufficient reliability.

#### Contingent liability is disclosed in the case of:

 a present obligation arising from past events, when it is not probable that an outflow of resources will be required to settle the obligation;

- a present obligation arising from past events, when no reliable estimate is possible;
- a possible obligation arising from past events, unless the probability of outflow of resources is remote.

A contingent asset is disclosed where an inflow of economic benefits is probable.

Provisions, contingent liabilities and contingent assets are reviewed at each balance sheet date.

#### o) Retirement and other employee benefits:

Post-employment benefits

- Payments to defined contribution benefit plans are recognised as an expense when employees have rendered service entitling them to the contributions. For defined benefit retirement plans, the cost of providing benefits is determined using the projected unit credit method, with actuarial valuations being carried out at the end of each annual reporting period. Remeasurement, comprising actuarial gains and losses, the effect of the changes to the asset ceiling (if applicable) and the return on plan assets (excluding net interest), is reflected immediately in the balance sheet with a charge or credit recognised in other comprehensive income in the period in which they occur. Remeasurement recognised in other comprehensive income is reflected immediately in retained earnings and is not reclassified to statement of profit and loss. Past service cost is recognised in statement of profit and loss in the period of a plan amendment. Net interest is calculated by applying the discount rate at the beginning of the period to the net defined benefit liability or asset. Defined benefit costs are categorised as follows:
- Service cost (including current service cost, past service cost, as well as gains and losses on curtailments and settlements);
- Net interest expense or income; and
- Re-measurement.

The Company presents the first two components of defined benefit costs in statement of profit and loss in the line item "Employee benefits expense", and the last component in Other Comprehensive Income which is immediately reflected in retained earnings and is not reflected in statement of profit and loss account. Curtailment gains and losses are accounted for as past service costs.

The retirement benefit obligation recognised in the balance sheet represents the actual deficit or surplus in the Company's defined benefit plans. Any surplus resulting from this calculation is limited to the present NOTES

value of any economic benefits available in the form of refunds from the plans or reductions in future contributions to the plans.

#### **Terminal benefits**

A liability for a termination benefit is recognised at the earlier of when the entity can no longer withdraw the offer of the termination benefit and when the entity recognises any related restructuring costs.

#### Short-term and other long-term employee benefits

A liability is recognised for benefits accruing to employees in respect of wages and salaries, performance incentives and similar benefits other than compensated absences in the period the related service is rendered at the undiscounted amount of the benefits expected to be paid in exchange for that service.

Liabilities recognised in respect of compensated absences are measured on the basis of actuarial valuation as on the balance sheet date.

Liabilities recognised in respect of other long-term employee benefits are measured at the present value of the estimated future cash outflows expected to be made by the Company in respect of services provided by employees up to the reporting date.

#### p) Earnings per share:

Basic earnings per share is calculated by dividing the profit/loss attributable to the owners of the Company by the weighted average number of equity shares outstanding during the financial year.

Diluted earnings per share adjusts the figure used in determination of basic earnings per share to take into account the after income tax effect of interest and other financing costs associated with dilutive potential equity shares, and the weighted average number of additional equity shares that would have been outstanding assuming the conversion of all dilutive potential equity shares

#### q) Operating segment

The management views the Company's operation as a single segment engaged in business of "Textiles" Hence there is no separate reportable segment under Ind AS 108 'Operating segment'

#### r) Onerous contracts

If the Company has a contract that is onerous, the present obligation under the contract is recognised and measured as a provision. However, before a separate provision for an onerous contract is established, the Company recognises any impairment loss that has occurred on assets dedicated to that contract.

An onerous contract is a contract under which the unavoidable costs (i.e., the costs that the Company

cannot avoid because it has the contract) of meeting the obligations under the contract exceed the economic benefits expected to be received under it. The unavoidable costs under a contract reflect the least net cost of exiting from the contract, which is the lower of the cost of fulfilling it and any compensation or penalties arising from failure to fulfil it. The cost of fulfilling a contract comprises the costs that relate directly to the contract (i.e., both incremental costs and an allocation of costs directly related to contract activities).

#### s) Government Grant

Government grants are recognised where there is reasonable assurance that the grant will be received, and all attached conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the related costs, for which it is intended to compensate, are expensed. When the grant relates to an asset, it is recognised as income in equal amounts over the expected useful life of the related asset.

When the Company receives grants of non-monetary assets, the asset and the grant are recorded at fair value amounts and released to profit or loss over the expected useful life in a pattern of consumption of the benefit of the underlying asset i.e. by equal annual instalments.

When loans or similar assistance are provided by governments or related institutions, with an interest rate below the current applicable market rate, the effect of this favourable interest is regarded as a government grant. The loan or assistance is initially recognised and measured at fair value and the government grant is measured as the difference between the initial carrying value of the loan and the proceeds received. The loan is subsequently measured as per the accounting policy applicable to financial liabilities.

#### t) Key sources of estimation uncertainty and critical accounting judgements

In the course of applying the accounting policies, the Company is required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future period, if the revision affects current and future periods.



#### Key sources of estimation uncertainty

#### a) Useful lives of property, plant and equipment

Management reviews the useful lives of property, plant and equipment at least once a year. Such lives are dependent upon an assessment of both the technical lives of the assets and also their likely economic lives based on various internal and external factors including relative efficiency and operating costs. Refer Note 2 and 30 for further disclosure.

#### b) Impairment of property plant and equipment

Determining whether the property, plant and equipment are impaired requires an estimate in the value in use of cash generating units. It requires to estimate the future cash flows expected to arise from the cash generating units and a suitable discount rate in order to calculate present value. When the present value of the cash flows are less than carrying value of property, plant and equipment a material impairment loss may arise. Refer Note 2 and 39 for further disclosure.

# c) Impairment of investments in and loan given to subsidiaries and joint ventures

Determining whether the investments in and loan given to subsidiaries and joint ventures are impaired requires an estimate in the value in use. In considering the value in use, the Management have anticipated the future cash flows, discount rates and other factors of the underlying businesses/ companies. In certain cases, the Company engages third party qualified valuers to perform the valuation. The management works closely with the qualified external valuers to establish the appropriate valuation techniques and inputs to the model. Refer Note 5, 6 and 49 for further disclosure.

#### d) Provisions, liabilities and contingencies

Provisions and liabilities are recognized in the period when it becomes probable that there will be a future outflow of funds resulting from past events that can reasonably be estimated. The timing of recognition requires application of judgement to existing facts and circumstances which may be subject to change.

In the normal course of business, contingent liabilities may arise from litigation and other claims against the Company. Potential liabilities that are possible but not probable of an outflow of resources embodying economic benefits are treated as contingent liabilities. Such liabilities are disclosed in the notes but are not recognized. Refer Note 36 for further disclosure.

#### e) Taxes

Deferred tax assets are recognized for unused tax losses to the extent that it is probable that taxable profit will be available against which the losses can be utilized. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and the level of future taxable profits together with future tax planning strategies. Refer Note 8 and 38 for further disclosure.

#### f) Employee benefit plans

The cost of defined benefit gratuity plan and other post-employment benefits are determined using actuarial valuations. An actuarial valuation involves making various assumptions that may differ from actual developments in the future. These include the determination of the discount rate, future salary increases and mortality rates. Due to the complexities involved in the valuation and its longterm nature, a defined benefit obligation is highly sensitive to changes in these assumptions. All assumptions are reviewed at each reporting date.

The mortality rate is based on publicly available mortality tables for India. Those mortality tables tend to change only at interval in response to demographic changes. Future salary increases and gratuity increases are based on expected future inflation rates. Refer Note 28 and 42 for further disclosure.

#### g) Lease

The application of Ind AS 116 requires Company to make judgements and estimates that affect the measurement of right-of-use assets and liabilities. In determining the lease term, we consider all facts and circumstances that create an economic incentive to exercise renewal options (or not exercise termination options). Assessing whether a contract includes a lease also requires judgement. Estimates are required to determine the appropriate discount rate used to measure lease liabilities.

The Company cannot readily determine the interest rate implicit in the lease, therefore, it uses its incremental borrowing rate (IBR) to measure lease liabilities. The IBR is the rate of interest that the Company would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-ofuse asset in a similar economic environment. The IBR therefore reflects what the Company 'would have to pay', which requires estimation when no observable rates are available or when they need to be adjusted to reflect the terms and conditions of the lease. The Company estimates the IBR using **NOTES** 

to Standalone Financial Statements for the year ended 31st March, 2022



observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates.

#### h) Recoverability of Trade Receivables

Judgements are required in assessing the recoverability of overdue trade receivables and determining whether a provision against those receivables is required. Factors considered include the credit rating of the counterparty, the amount and timing of anticipated future payments and any possible actions that can be taken to mitigate the risk of non-payment.

**32** In the previous year, the Company has completed all the steps as laid down in the resolution plan approved by the National Company Law tribunal vide its order dated 8th March, 2019 and the resolution applicants had obtained joint control over the Company and the Board of Directors had been re-constituted on 14th September, 2020, being the closing date as determined by the Company in terms of the resolution plan.

The re-constituted Board has adopted a business plan with specific focus on utilising the existing capacities and upgrading the efficiency / productivity of the existing machinery at the manufacturing plants. Though the Company has incurred a loss of ₹ 184.18 crore (before exceptional items) for the year ended 31st March, 2022. The cash flow projections for the next year are adequate to meet the existing financial obligations due in the next year. Further as at 31st March, 2022, the current assets of the Company exceeds its current liabilities by ₹169.18 crore. Accordingly, the financial statements have been prepared on a going concern basis.

**33** The outbreak of corona virus (Covid-19) pandemic globally and in India is causing significant disturbance and slowdown of economic activity. The Company's

operations and revenue during the current and previous period were impacted due to Covid-19. The Company has taken into account the possible impact of Covid-19 in preparation of the financial statements, including its assessment of the recoverable value of its assets based on the internal and external information up to the date of approval of these financial results and current indicators of future economic conditions.

34 As per Clause 1.2 (xi) of Approved Resolution Plan, the outstanding debt amounting to ₹ 17,384.02 crore assigned to Resolution Applicants shall not carry interest for the first 8 years from the Closing Date (as defined in the Approved Resolution Plan), hence such debt has been measured at cost. After such period of 8 years, the terms of assigned debt shall be mutually agreed among the Resolution Plan has an overriding effect on the requirements of Ind AS, as per legal view obtained by the Company in this regard. Hence, had the Company applied the Ind AS, it would have recognised the assigned debt at its fair value and accordingly recognized the imputed interest cost over the period of loan in the statement of profit and loss.

35 As on June 2017, the Company had an amount of ₹11,623.94/- crore receivable from trading debtors on account of sale of fabric ("Outstanding Trading Dues"). As per the Approved Resolution Plan, if any of the trading debtors make payment towards the Outstanding Trading Dues or any person is required to contribute to the assets of the Company under any legal process against the Outstanding Trading Dues and has contributed the same, such amounts (net of any income tax payable by the

The Company has not received any amounts towards Outstanding Trading Dues in the current year.

- 1 The Company has also issued a letter of comfort to Alok Infrastructure Limited, wholly owned subsidiary Company in order to meet its financial obligations. As on 31st March, 2022, management has assessed that the possibility of outflow of resources embodying economic benefits with respect to the letter of comfort issued is remote.
- 2 Claims / Debts against the Company upto the closing date which are addressed under the NCLT approved resolution plan are not included in contingent liabilities though many of such claims / debts may be pending for disposal at various judicial forums. As per clause 3.3.4 of the aforesaid resolution plan, these liabilities stands extinguished.

Accordingly, the management has assessed that the possibility of outflow of resources embodying economic benefits with respect to such claims / debts is remote.

- 3 All direct and indirect tax liabilities relating to assessments of earlier year upto the closing date stand extinguished as per the NCLT approved resolution plan. Further, the implementation of the resolution plan does not have any effect over claims or receivables owed to the Company. Accordingly, the Company has assessed that any receivables due to the Company, evaluated based on merits of underlying litigations, from various governmental agencies continues to subsist.
- 4 The Company has entered into Gas Sale Agreement (GSA) / Gas Transmission Agreement (GTA) dated 27th May, 2013 with GAIL India Limited ('GAIL') for the supply of re-liquified natural gas (RLNG) to the delivery point and for transmission of gas from the delivery point to the unit. The tenure of the agreements was for a period of 15 years and includes a take or pay clause (ToP) in the contract. Upto the closing date i.e 14th September, 2020, GAIL had raised claims of ₹ 1,090 crores invoking the ToP clause under the contract. GAIL was covered as an operational creditor under the NCLT approved resolution plan which provides for Nil payment if dues of operational creditors are above ₹ 3 lacs. Aggrieved by the order, GAIL had filed an appeal with National Company Law Appellate Tribunal (NCLAT), which has been dismissed by the latter by order dated October 4, 2021. Subsequently, the Hon'ble Supreme Court has also dismissed GAIL's appeal vide its order dated March 21, 2022, however the question of law is kept open. Accordingly, the aforesaid claim / demand upto the closing date has been considered as remote.

The NCLT and NCLAT orders supra with respect to the GAIL matter also state that, post the closing date, if GAIL wishes to continue supply of gas to the Company, it may separately negotiate the same with the Company and the same does not fall within the ambit of the Resolution Plan. Basis this, both the parties are negotiating various operational aspects of the agreement, including those relating to ToP liability post the closing date for which GAIL has raised claims on the Company. The Company has requested GAIL for waiver of all claims raised on the Company towards ToP post the closing date and has assessed that in a situation the ToP liability is not waived by GAIL, the Company has an equal right under the gas sale agreement to pick up equivalent gas upto the end of the Recovery

- a) In terms of the Approved Resolution Plan, JM and Reliance Industries Limited ('RIL') have converted such portion of their assigned debt into equity, such that their joint equity holding in the Company is 75%. Pursuant to such conversion, the proportionate reduction in Outstanding ARC Debt as per clause 1.2 (xii) of the Approved Resolution Plan is ₹ 5,240.14 crore. The price at which the conversion has taken place has been determined in accordance with the Approved Resolution Plan and applicable law and consequently, the difference between the issue of 275.46 crore equity shares at face value and the amount by which the assigned debt has been proportionately reduced as stated above has been recognised as exceptional gain in the statement of profit and loss in previous year.

Accordingly, extinguishment of financial liability amounting to ₹ 58.44 crore has been recognised as exceptional gain in the statement of profit and loss in previous year.

C) The Company has been incurring operational losses over the past few years working at capacity utilization of about 30-35%. The carrying value of assets is based on a value in use calculation which uses cash flow projections based on financial budgets approved by the management covering a seven year period, and a discount rate of 11.61% per annum. Based on the dynamics of the sector in which Company operates, the management has assumed long term growth rate of 0% to calculate the terminal value. Accordingly, the Company has recognized an impairment loss of ₹ 8,264.22 crore on tangible assets during the previous year and is included in exceptional items in the Statement of Profit and Loss in previous year.

#### 44 Capital Management and Financial Management Framework:

The Company being in a working capital intensive industry, its objective is to maintain a strong credit rating, healthy ratios and establish a capital structure that would maximize the return to stakeholders through optimum mix of debt and equity.

The Company's capital requirement is mainly to fund its capex, working capital, repayment of principal and interest on its borrowings. The principal source of funding of the Company has been, and is expected to continue to be, cash generated from its operations supplemented by funding from bank borrowings and the capital markets. The Company is not subject to any externally imposed capital requirements.

The Company manages its capital structure and makes adjustments in light of changes in economic conditions and the requirements of the financial covenants. The Company monitors capital using a gearing ratio, which is net debt divided by total capital plus net debt. Since net worth of the Company is negative, debt equity ratio is not calculated.

The key risks associated with day to day operations of the Company and working capital management are given below:

#### A. Credit Risk:

Credit risk is the risk that counter party will not meet its obligation under a financial instrument or customer contract leading to a financial loss. The Company is exposed to credit risk mainly from trade receivables and other financial assets.

#### i) Trade Receivables:

Trade receivables are typically unsecured and are derived from revenue earned from customers. Credit risk has been managed by the Company through credit approvals, establishing credit limits and continuously monitoring the creditworthiness of customers to which the Company grants credit terms in the normal course of business. On account of adoption of Ind AS 109, the Company uses expected credit loss model to assess the impairment loss or gain. The Company uses a provision matrix and forward-looking information and an assessment of the credit risk over the expected life of the financial asset to compute the expected credit loss allowance for trade receivables. Concentrations of credit risk with respect to trade receivables are limited.

#### ii) Other Financial Assets & loans

The Company has limited credit risk arising from cash and cash equivalents as the deposits are maintained with banks and financial institutions with high credit rating. Further, other financial assets mainly comprises of Export incentives and balances with statutory authorities (GST input credit balances) which are recoverable from Government. Hence, these are low risk items and the Company evaluates the recoverability of these financial assets at each reporting date and wherever required, a provision is created against the same.

The Company had in earlier years given loans to its subsidiaries/a Company in which erstwhile directors were interested of ₹ 1,465.99 crore, which are fully provided for in the books. The net exposure of ₹ 182.12 crore is with respect of one wholly owned subsidiary whereby the Company has impaired to the extent of the fair valuation of the subsidiary's investment properties / inventories.

# B. Market Risk:

Market risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises of three types of risks – interest rate risk, currency risk and other price risk in a fluctuating market environment. Financial instrument affected by market risks includes loans and borrowings, deposits, derivatives and other financial assets.

# i) Currency Risk

The Company's functional currency is Indian Rupees (INR). The Company undertakes transactions denominated in foreign currencies; consequently, exposure to exchange rate fluctuations arise. Volatility in exchange rates affects the Company's revenue from export markets and the costs of imports. The Company has exports and to that extent has a natural hedge as a mitigation measure to cover foreign exchange risk on account of imports/ expenses in foreign currency.

The Company manages its foreign currency risk by entering into forward contracts.

#### ii) Interest rate risk

- a. Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Company is exposed to interest rate risk because funds are borrowed at both fixed and floating interest rates. Interest rate risk is measured by using the cash flow sensitivity for changes in variable interest rate. The borrowings of the Company are principally denominated in rupees with a mix of fixed and floating rates of interest. The Company has exposure to interest rate risk, arising principally on changes in base lending rate. The Company uses a mix of interest rate sensitive financial instruments to manage the liquidity and fund requirements for its day to day operations. The risk is managed by the Company by maintaining an appropriate mix between fixed and floating rate borrowings.

# iii) Commodity Price Risk

Commodity price risk arises due to fluctuation in prices of raw materials like PTA, MEG, cotton and yarn. The Company has a risk management framework aimed at prudently managing the risk arising from the volatility in commodity prices and freight costs. The Company's commodity risk is managed centrally through well-established trading operations and control processes.

# C. Financial risk management objectives

The Company has a Risk Management Committee established by its Board of Directors for overseeing the Risk Management Framework and developing and monitoring the Company's risk management policies. The risk management policies are established to ensure timely identification and evaluation of risks, setting acceptable risk thresholds, identifying and mapping controls against these risks, monitor the risks and their limits, improve risk awareness and transparency. Risk management policies and systems are reviewed regularly to reflect changes in the market conditions and the Company's activities to provide reliable information to the Management and the Board to evaluate the adequacy of the risk management framework in relation to the risk faced by the Company.

# D. Liquidity Risk:

Liquidity risk refers to the risk of financial distress or extraordinary high financing costs arising due to shortage of liquid funds in a situation where business conditions unexpectedly deteriorate and requiring financing. The Company requires funds both for short term operational needs as well as for long term capital expenditure for capex. The Company generates sufficient cash flow for operations, which together with the available cash and cash equivalents provide liquidity in the short-term and long-term. The Company has established an appropriate liquidity risk

#### 46 Operating Leases

#### Company as a lessee

The Company has lease contracts for land used in its operations, which has a lease terms of 95 years. Refer note 2 for disclosure relating to right of use assets.

As per the terms of lease, the Company was required to make one-time advance lease payment for the leased land. Hence, following the terms of the leased agreement, the Company has made the one-time lease payment and consequently, there are no lease liabilities recorded in the Balance Sheet as at 31st March, 2022.

#### Company as a lessor

The Company has entered into leases on its investment property portfolio consisting of certain Residential flats and commercial buildings (see Note 3). These leases have terms of between 5 and 20 years. All leases include a clause to enable upward revision of the rental charge on an annual basis according to prevailing market conditions. Rental income recognised by the Company during the year is ₹0.25 crore (2020-21: ₹ 0.43 crore). There are no non-cancellable leases.

- 47 The Company had granted interest free loan in earlier years (prior to corporate insolvency resolution process) to a company which is outstanding as at the year-end amounting to ₹ 233.32 crores (against which an impairment allowance of ₹ 233.32 crores is made). Further, the Company had granted interest free loan in earlier years (prior to the corporate insolvency resolution process) to its wholly owned subsidiaries ('WOS') which are outstanding as at the year-end amounting to ₹ 2,605.66 crores (against which an impairment allowance of ₹ 2,423.54 crores is made). Based on legal opinion obtained by the Company, the provisions of section 186 of the Companies Act, 2013 are not applicable to all such interest free loans granted under the erstwhile Companies Act, 1956 and by virtue of the resolution plan approved by the NCLT, any claim from the authorities with respect to the breach / contravention / non-compliance of any Applicable law is abated, settled and extinguished as at the closing date (i.e. September 14, 2020).
- **48** As per Section 135 of the Companies Act, 2013, a Company, meeting the applicability threshold, needs to spend at least 2% of its average net profit for the immediately preceding three financial years on corporate social responsibility (CSR) activities. The areas for CSR activities are eradication of hunger and malnutrition, promoting education, art and culture, healthcare, destitute care and rehabilitation, environment sustainability, disaster relief and rural development projects.

A CSR committee has been formed by the Company as per the Act. The Company has incurred losses in current and in previous years, Accordingly, as the average net profit for immediately preceding three financial years is NIL there are no amounts required to be spend on corporate social responsibility under section 135 of the Companies Act, 2013. Consequently, there are no unspent amount on ongoing projects / other than ongoing projects.

- 49 In the previous year, on 22nd March, 2021, the NCLT has passed the order for withdrawal of the corporate insolvency resolution process for Alok Infrastructure Limited, wholly owned subsidiary of the Company. Post this, the subsidiary had also performed a valuation of its investment properties / inventories with the help of external valuation specialists and accordingly considered impairment in its books. Based on the results of such impairment testing, the Company had also impaired its loan given to the said subsidiary further by ₹ 689.48 crores in the previous year and disclosed the same in Note 31 (also, refer note 6).
- 50 The Company had unutilised amount of ₹ 150 crore raised through preferential allotment / private placement of equity shares in earlier years which have been utilised in the current year for capital expenditure and meeting working capital requirements.

### Report on the Audit of the Consolidated Financial Statements

### Opinion

We have audited the accompanying consolidated financial statements of Alok Industries Limited (hereinafter referred to as "the Holding Company"), its subsidiaries (the Holding Company and its subsidiaries together referred to as "the Group") and its joint ventures comprising of the consolidated Balance Sheet as at March 31 2022, the consolidated Statement of Profit and Loss including other comprehensive income, the consolidated Cash Flow Statement and the consolidated Statement of Changes in Equity for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies and other explanatory information (hereinafter referred to as "the consolidated financial statements").

In our opinion and to the best of our information and according to the explanations given to us and based on the consideration of reports of other auditors on separate financial statements and on the other financial information of the subsidiaries, the aforesaid consolidated financial statements give the information required by the Companies Act, 2013, as amended ("the Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the consolidated state of affairs of the Group and joint ventures as at March 31, 2022, their consolidated cash flows and the consolidated statement of changes in equity for the year ended on that date.

### **Basis for Opinion**

We conducted our audit of the consolidated financial statements in accordance with the Standards on Auditing (SAs), as specified under section 143(10) of the Act. Our responsibilities under those Standards are further described in the 'Auditor's Responsibilities for the Audit of the Consolidated Financial Statements' section of our report. We are independent of the Group and joint ventures in accordance with the 'Code of Ethics' issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Act and the Rules thereunder, and we

have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion on the consolidated financial statements.

### **Emphasis of Matter**

We draw attention to Note 33 of the consolidated financial statements in respect of the resolution plan approved by the National Company Law Tribunal vide its order dated March 8, 2019 under section 31(1) of the Insolvency and Bankruptcy Code, 2016. The Holding Company has accounted the assigned debt as per the aforesaid resolution plan at cost, overriding the Indian Accounting Standards which would require the Holding Company to recognize the assigned debt at its fair value and accordingly the imputed interest cost over the period of the loan. Our opinion is not modified in respect of this matter.

### **Key Audit Matters**

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the consolidated financial statements for the financial year ended March 31, 2022. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. For each matter below, our description of how our audit addressed the matter is provided in that context.

We have determined the matters described below to be the key audit matters to be communicated in our report. We have fulfilled the responsibilities described in the Auditor's responsibilities for the audit of the consolidated financial statements section of our report, including in relation to these matters. Accordingly, our audit included the performance of procedures designed to respond to our assessment of the risks of material misstatement of the consolidated financial statements. The results of audit procedures performed by us and by other auditors of components not audited by us, as reported by them in their audit reports furnished to us by the management, including those procedures performed to address the matters below, provide the basis for our audit opinion on the accompanying consolidated financial statements. ### Key audit matters

### Capitalization of property, plant and equipment

In the earlier years, prior to implementation of the NCLT approved resolution plan, the Holding Company was operating at a lower capacity utilization and overall maintenance activity at the plant was curtailed due to lack of working capital. Consequently, many of the plant and machinery remained idle / non-functional and in most cases the machinery's operating speed was reduced, resulting in lower . efficiency and production.

In the previous year, the re-constituted Board of Directors of the Holding Company had approved a business plan which also included capital expenditure to overhaul the plant and machinery at the Holding Company's manufacturing locations.

During the year ended March 31, 2022, the Holding Company has incurred expenditure of ₹ 114.99 crores, largely related to purchase of spares to overhaul the existing plant and machinery in order to improve their efficiency and increase the capacity utilization. Further, the Holding Company has capitalised ₹ 8.81 crores out of the capital work in progress of the previous year.

Judgement is involved to ensure that the aforesaid expenditure meets the specific recognition criteria under Ind AS 16, 'Property, Plant and Equipment'.

Accordingly, the same is considered as a key audit matter. Refer Note 2, 4 and 31 of the consolidated financial statements.

### Recoverability of carrying value of property, plant and equipment

In the previous year, consequent to the business plan approved by the re-constituted Board of Directors of the Holding Company, the Holding Company had through an external valuation specialist determined the value in use of property, plant and equipment and recorded an impairment provision of ₹ 8,264.22 crores in the books.

Based on recent business developments, the Holding Company's Board has made required revisions to the business plan and has accordingly updated the value in use calculations using the discounted cash flow method with the help of an external valuation specialist. Based on the same, the Holding Company has determined there are no material adjustments required to the impairment allowance already recorded. The value in use is sensitive to changes in certain inputs / assumptions used for forecasting the discounted cash flow projections due to inherent uncertainty involved in these assumptions. Accordingly, the same has been considered as a key audit matter.

The auditors of Alok Infrastructure Limited have reported a key audit matter with respect to the fair valuation of the assets performed by the management by involving an independent valuer to assess the recoverability of the carrying value of its investment properties / inventories.

### **Contingent liabilities**

As at March 31, 2022, the Holding Company had the following matters where management has assessed the possibility of outflow of resources embodying economic benefits.

- a) Take or pay obligation under the long term gas sale agreement with GAIL India Limited. Refer Note 38 of financial statements.
- Tax liabilities with respect to open assessments for assessment b) years prior to the closing date as per the NCLT approved resolution plan. Refer Note 38 of financial statements.

Management's judgement regarding recognition and measurement of provisions for these matters is inherently uncertain and might change over time as the outcomes of the litigations / discussions are determined.

Accordingly, it has been considered as a key audit matter.

### How our audit addressed the key audit matter

Our audit procedures included and were not limited to the following:

- Assessed the design and operating effectiveness of controls of the Holding Company relating to capitalization of property, plant and equipment (including capital work in progress).
- Assessed on test basis for samples selected, that the recognition criteria under Ind AS 16 is met.
- Inquired with management on any significant variation (if any) between the approved capex budget in previous year with the actual expenditure incurred as at the balance sheet date.
- Assessed disclosures made in the consolidated financial statements.

Our audit procedures included and were not limited to the following:

- Obtained the revised cash flow projections as approved by the Board of Directors of the Holding Company.
- Assessed the valuation methodology applied in determining the value in use. In making this assessment, we evaluated the objectivity and independence of Holding Company's external specialists involved in the process.
- Assessed key assumptions applied to arrive at the value in use by involving internal valuation specialists.
- In respect of the key audit matter reported to us by the auditor of Alok Infrastructure Limited, we performed inquiry of the audit procedures performed by them to address the key audit matter. As reported to us by the subsidiary auditor, the following procedures have been performed by them:
  - Reviewed the valuation report of the independent valuer and the methodologies adopted by the valuer for ascertaining fair value.

Our audit procedures included and were not limited to the following:

- Obtained and read the long term gas supply agreement between the Holding Company and GAIL India Limited.
- Assessed the management's position through discussions with the in-house legal expert.
- Discussed with the management on the development in these matters during the year ended March 31, 2022 along with obtaining underlying documentation for the same, including communication with counterparties.
- Examined the management assessment with respect to possibility of outflow of resources embodying economic benefits in relation to these matters, including independent opinion obtained by the management by involving legal specialists.

### **Other Matter**

These financial statement and other financial information have been audited by other auditors, which financial statements, other financial information and auditor's reports have been furnished to us by the management. ### NOTES

to Consolidated Financial Statements for the year ended 31st March, 2022

### CORPORATE INFORMATION

Alok Industries Limited ("The parent Company") is a Public Limited Company, domiciled in India and incorporated under the provisions of the Companies Act, 1956. The equity shares of the parent Company are listed on the Bombay Stock Exchange (BSE) and National Stock Exchange (NSE). It is primarily engaged in the business of textile manufacturing including mending and packing activities. The registered office of the parent Company is located at 17/5/1, 521/1, Village Rakholi/ Saily, Silvassa, The Union Territory of Dadra and Nagar Haveli-396230.

Pursuant to an application made by the State Bank of India, the Hon'ble National Company Law Tribunal, Ahmedabad bench ("Adjudicating Authority"), vide its order dated 18th July, 2017, had ordered the commencement of the corporate insolvency resolution ("CIR") process in respect of the parent Company under the provisions of the Insolvency and Bankruptcy Code, 2016 (the "Code"). Pursuant to its order dated 8th March, 2019 ("NCLT Order"), the Adjudicating Authority approved the resolution plan submitted by the Resolution Applicants for the parent Company under Section 31 of the Insolvency and Bankruptcy Code, 2016 ("Code") ("Approved Resolution Plan"). As per the terms of Section 31 of the Code, the Resolution Plan shall be binding on the parent Company, its employees, members, creditors, guarantors and other stakeholders involved in the Resolution Plan. During the previous year, the parent Company has completed all the implementation steps as required in the Resolution Plan.

### NOTE 1: SIGNIFICANT ACCOUNTING POLICIES

This Note provides a list of the significant Accounting Policies adopted by Alok Industries Limited (the Parent Company), it's Subsidiaries (collectively referred as the Group) and Joint Ventures; in the preparation of these Consolidated Financial Statements. These policies have been consistently applied to all the years presented, unless otherwise stated.

### a) Basis of preparation:

The financial statements of the Group have been prepared in accordance with Indian Accounting Standards (Ind AS) notified pursuant to section 133 of the Companies Act 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and Companies (Indian Accounting Standards) Amendment Rules, 2016(as amended from time to time) and presentation requirements of Division II of Schedule III to the Companies Act, 2013, (Ind AS compliant Schedule III), as applicable to the Financial statements ('Consolidated Ind AS Financial Statements').

The financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies below:

- a. Derivative financial instruments,
- b. Certain financial assets and liabilities measured at fair value, and
- c. Defined benefit plans plan assets measured at fair value;

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of Ind AS 102, leasing transactions that are within the scope of Ind AS 116 'Leases' ("Ind AS 116"), and that have some similarities to fair value but are not fair value, such as net realisable value in Ind AS 2 'Inventories' ("Ind AS 2") or value in use in Ind AS 36 'Impairment of Assets' ("Ind AS 36").

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2, or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The principal accounting policies are set out below.

The financial statements are presented in  $\mathfrak{F}$ , which is the functional currency and all values are rounded to the nearest crore ( $\mathfrak{F}$  00,00,000), except when otherwise indicated.

### b) Principles of consolidation and equity accounting:

### i) Subsidiary companies

Subsidiary companies are all entities over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the relevant activities of the entity. Subsidiary companies are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

The acquisition method of accounting is used to account for business combinations by the Group.

The Group combines the Financial Statements of the parent and its subsidiary companies line by line adding together like items of assets, liabilities, equity, CORPORATE OVERVIEW

income and expenses. Intercompany transactions, balances and unrealised gains on transactions between Group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. Accounting Policies of subsidiary companies have been changed where necessary to ensure consistency with the policies adopted by the Group. Non-controlling interest in the results and equity of subsidiary companies are shown separately in the Consolidated Statement of Profit and Loss, Consolidated Statement of changes in equity and Balance Sheet respectively.

### ii) Associate companies

Associate companies are all entities over which the Group has significant influence, but not control or joint control. This is generally the case where the Group holds between 20% and 50% of the voting rights. Investments in associate companies are accounted for using the equity method of accounting.

### iii) Joint arrangements

Under Ind AS 111 Joint arrangements, investments in joint arrangements are classified as either joint operations or joint ventures. The classification depends on the contractual rights and obligations of each investor, rather than the legal structure of the joint arrangement. Interest in Joint Venture Company is accounted for using the equity method.

### iv) Equity method

Under the equity method of accounting, the investments are initially recognised at cost and adjusted thereafter to recognise share of the Group in post-acquisition profit and loss of the investee in profit and loss, and share of the Group in Other Comprehensive Income of the investee in Other Comprehensive Income. Dividends received or receivable from associate company and Joint Venture Company are recognised as a reduction in the carrying amount of the investment.

When the Group share of losses in an equityaccounted investment equals or exceeds its interest in the entity, including any other unsecured longterm receivables, the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the other entity.

Unrealised gains on transactions between the Group and its associate company and Joint Venture Company are eliminated to the extent of the Group interest in these entities. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting Policies of equity accounted investees have been changed where necessary to ensure consistency with the policies adopted by the Group.

The carrying amount of equity accounted investments are tested for impairment in accordance with the policy described in (I) below.

### v) Changes in ownership interest

The Group treats transactions with non-controlling interest that do not result in a loss of control as transactions with equity owners of the Group. A change in ownership interest results in an adjustment between the carrying amounts of the controlling and non-controlling interest to reflect their relative interest in the subsidiary companies.

Any difference between the amount of the adjustment to non-controlling interest and any consideration paid or received is recognised within equity.

When the Group ceases to consolidate or equity account for an investment because of a loss of control, joint control or significant influence, any retained interest in the entity is remeasured to its fair value with the change in carrying amount recognised in profit or loss. This fair value becomes the initial carrying amount for the purpose of subsequently accounting for the retained interest as an associate company, joint venture company or financial asset. In addition, any amounts previously recognised in Other Comprehensive Income in respect of that entity are accounted for as if the Group had directly disposed of the related assets or liabilities. This may mean that amounts previously recognised in Other Comprehensive Income are reclassified to the Statement of Profit and Loss.

If the ownership interest in a joint venture company or an associate company is reduced but joint control or significant influence is retained, only a proportionate share of the amounts previously recognised in Other Comprehensive Income are reclassified to the Statement of Profit and Loss where appropriate.

### c) Current versus non-current classification

The Group presents assets and liabilities in the balance sheet based on current/non-current classification. An asset is treated as current when it is:

- Expected to be realised or intended to be sold or consumed in normal operating cycle
- Held primarily for the purpose of trading
- Expected to be realised within twelve months after the reporting period, or
- Cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period.

All other assets are classified as non-current

A liability is current when:

- It is expected to be settled in the normal operating cycle
- It is held primarily for the purpose of trading



- It is due to be settled within twelve months after the reporting period, or
- There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period.

The terms of the liability that could, at the option of the counterparty, result in its settlement by the issue of equity instruments do not affect its classification.

The Group classifies all other liabilities as non-current.

Deferred tax assets and liabilities are classified as noncurrent assets and liabilities.

Based on the nature of services and the normal time between the acquisition of assets and their realisation into cash and cash equivalents, the Group has ascertained its operating cycle as 12 months for the purpose of current and non-current classification of assets and liabilities.

### d) Foreign Currency Transactions and Translation

The management of the Group has determined Indian rupee ("RS.") as the functional currency of the Group. In preparing the financial statements of the Group, transactions in currencies other than the Group's functional currency ("foreign currencies") are recognised at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date.

Exchange differences on monetary items are recognised in statement of profit and loss in the period in which they arise except for:

 exchange differences on foreign currency borrowings relating to assets under construction for future productive use, which are included in the cost of those assets when they are regarded as an adjustment to interest costs on those foreign currency borrowings.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value is determined. The gain or loss arising on translation of non-monetary items measured at fair value is treated in line with the recognition of the gain or loss on the change in fair value of the item (i.e., translation differences on items whose fair value gain or loss is recognised in OCI or profit or loss are also recognised in OCI or profit or loss, respectively).

In determining the spot exchange rate to use on initial recognition of the related asset, expense or income (or part of it) on the derecognition of a non-monetary asset or non-monetary liability relating to advance consideration, the date of the transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of advance consideration.

### e) Revenue from contract with customers:

The Group recognises revenue from the following major sources, acting in the capacity of principal:

- Sale of consumer product
- Other operating revenue

### Sale of consumer product

The Group sells textile Products. The Group recognizes revenue on the sale of goods, net of discounts, sales incentives, estimated customer returns and rebates granted, commission, if any, when control of the goods is transferred to the customer.

Discounts given include rebates, price reductions and other incentives given to customers. The Group bases its estimates on historical results, taking into consideration the type of customer, the type of transaction and the specifics of each arrangement.

### **Export Incentives**

Export benefits arising from Duty Drawback scheme, Merchandise Export Incentive Scheme and other eligible export incentives are recognised on post export basis at the rate at which the entitlements accrue and is included in the 'Other Operating Income' (Revenue from operation).

### Nature, timing of satisfaction of performance obligation and transaction price (Fixed and variable)

The Group recognises revenue when it transfers control of a product or service to a customer.

The control of goods is transferred to the customer depending upon the terms or as agreed with customer or delivery basis (i.e. at the point in time when goods are delivered to the customer or when the customer purchases the goods from the Group warehouse). Control is considered to be transferred to customer when customer has ability to direct the use of such goods and obtain substantially all the benefits from it such as following delivery, the customer has full discretion over the manner of distribution and price to sell the goods, has the primary responsibility when onselling the goods and bears the risks of obsolescence and loss in relation to the goods.

Based on the terms of the contract and as per business practice, the Group determines the transaction price considering the amount it expects to be entitled in exchange of transferring promised goods or services to the customer. It excludes amount collected on behalf of third parties such as taxes.

The Group provides volume discount and rebate schemes, to its customers on certain goods purchased by the customer once the quantity of goods purchased during the period exceeds a threshold specified in the contract. Volume discount and rebate schemes give

rise to variable consideration. To estimate the variable consideration to which it will be entitled, the Group considers that either the expected value method or the most likely amount method, depending on which of them better predicts the amount of variable consideration for the particular type of contract.

### **Rendering of services**

Revenue from rendering of services is recognised over time considering the time elapsed. The transaction price of these services is recognised as a contract liability upon receipt of advance from the customer, if any, and is released on a straight line basis over the period of service.

### Contract assets, contract liabilities and trade receivables

Revenues in excess of invoicing are classified as contract assets (which we refer as unbilled revenue) while invoicing in excess of revenues (which we refer to as unearned revenues) and advance from customers are classified as contract liabilities. A receivable is recognised by the Group when the control over the goods is transferred to the customer such as when goods are delivered as this represents the point in time at which the right to consideration becomes unconditional, as only the passage of time is required before payment is due. The average credit period on sale of goods is 7 to 90 days.

### **Dividend and Interest income**

Dividend income from investments is recognised when the Group's right to receive payment has been established (provided that it is probable that the economic benefits will flow to the Group and the amount of income can be measured reliably).

Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Group and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

### f) Income taxes:

### **Current tax**

Current tax payable is based on taxable profit for the year. Taxable profit differs from 'profit before tax' as reported in the statement of profit and loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's current tax is calculated using tax rates that have been enacted by the end of the reporting period.

### **Deferred tax**

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the Ind AS financial statements and the corresponding tax bases used in the computation of taxable profit. While preparing standalone Ind AS financial statements, temporary differences are calculated using the carrying amount as per standalone Ind AS financial statements and tax bases as determined by reference to the method of tax computation.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- When the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss
- In respect of taxable temporary differences associated with investments in subsidiaries, associates and interests in joint ventures, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future

Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences, the carry forward of unused tax credits and unused tax losses to the extent that it is probable that taxable profits will be available against which deductible temporary differences and the carry forward of unused tax credits and unused tax losses can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Current and deferred tax are recognised in statement of profit and loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively. Where current tax or deferred tax arises from the initial accounting for a business combination, the tax effect is included in the accounting for the business combination.



### g) Leases:

The Group assesses at contract inception whether a contract is, or contains, a lease. That is, if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

### Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-ofuse assets representing the right to use the underlying assets.

### i) Right-of-use assets

The Group recognises right-of-use assets at the commencement date of the lease (i.e., the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease term and the estimated useful lives of the assets, as follows

Building 2 to 3 years

If ownership of the leased asset transfers to the Group at the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

The right-of-use assets are also subject to impairment.

### ii) Lease Liabilities

At the commencement date of the lease, the Group recognises lease liabilities measured at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including insubstance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for terminating the lease, if the lease term reflects the Group exercising the option to terminate. Variable lease payments that do not depend on an index or a rate are recognised as expenses (unless they are incurred to produce inventories) in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in the lease payments (e.g., changes to future payments resulting from a change in an index or rate used to determine such lease payments) or a change in the assessment of an option to purchase the underlying asset.

### iii) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases (i.e., those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the lease of low-value assets recognition exemption to leases of office equipment that are considered to be low value. Lease payments on short-term leases and leases of low-value assets are recognised as expense on a straight-line basis over the lease term.

### Group as a lessor

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. Rental income arising is accounted for on a straight-line basis over the lease terms. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

### h) Property, Plant and Equipment

Assets held for use in the production or supply of goods or services, for rental to others or for administrative purposes, are stated in the consolidated balance sheet at cost less accumulated depreciation and accumulated impairment losses. Freehold land is not depreciated, however, it is subject to impairment.

Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Cost includes professional fees and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy. Such properties are classified to the appropriate categories of property, plant and equipment when completed and ready for intended use.

Likewise, subsequent cost incurred to overhaul the plant and machineries and major inspection costs are recognised in the carrying amount of the plant and equipment as a replacement if the recognition criteria are satisfied. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged NOTES

to statement of profit and loss during the reporting period in which they are incurred.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in statement of profit and loss.

Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

Stand-by equipment and servicing equipment are recognised as property, plant and equipment if they are held for use in the production or supply of goods or services, for rental to others, or for administrative purposes and are expected to be used during more than one period. Property, plant and equipment which are not ready for intended use as on the date of Balance Sheet are disclosed as 'Capital work-in-progress'.

### Depreciation methods, estimated useful lives and residual value:

Depreciation is recognised so as to write off the cost of assets (other than freehold land) less their residual values over their useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis. Depreciation on property, plant and equipment has been provided on straight line method as per the useful life prescribed in Schedule II of the Company's Act, 2013, except in case of following assets, where useful life used is different than those prescribed in part C of Schedule II:

Asset category	Estimated useful life
Buildings	50 to 60 years
Plant and Machinery	15 to 40 years

Based on technical evaluation done by the Chartered Engineer, the management believes that the useful lives as given above, best represent, the period over which management expects to use these assets. Hence, the useful lives for these assets is different from the useful lives as prescribed under Part C of Schedule II of the Companies Act, 2013.

The residual values are not more than 5% of the original cost of the asset.

The residual values, useful lives and method of depreciation of property, plant and equipment are reviewed at each financial year end and any changes there in are considered as change in estimate and accounted prospectively.

### i) Intangible assets:

### Intangible assets acquired separately

Intangible assets with finite useful lives that are

acquired separately are carried at cost less accumulated amortisation and accumulated impairment losses. Amortisation is recognised on a straight-line basis over their estimated useful lives. The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis. Intangible assets with indefinite useful lives that are acquired separately are carried at cost less accumulated impairment losses, if any. The assessment of indefinite life is reviewed annually to determine whether the indefinite life continues to be supportable. If not, the change in useful life from indefinite to finite is made on a prospective basis.

### Intangible assets acquired in a business combination

Intangible assets acquired in a business combination and recognised separately from goodwill are initially recognised at their fair value at the acquisition date (which is regarded as their cost).

Subsequent to initial recognition, intangible assets acquired in a business combination are reported on the same basis as intangible assets that are acquired separately.

### Derecognition of intangible assets

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains or losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset are recognised in statement of profit and loss when the asset is derecognised.

### Useful lives of intangible assets

Estimated useful lives of the intangible assets are as follows

Asset category	Estimated useful life
Computer software	6 years
Trademarks / Brands	10 years

### j) Borrowing costs:

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Interest income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in the statement of profit and loss in the period in which they are incurred.

The Group may incur borrowing costs during an extended period in which it suspends the activities necessary to prepare an asset for its intended use or sale. Such costs are costs of holding partially completed assets and do not qualify for capitalisation. However, an entity does not normally suspend capitalising borrowing costs during a period when it carries out substantial technical and administrative work. The Group also does not suspend capitalising borrowing costs when a temporary delay is a necessary part of the process of getting an asset ready for its intended use or sale.

The Group shall cease capitalising borrowing costs when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are complete.

### k) Investment Property:

Investment properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at cost less accumulated depreciation and accumulated impairment loss, if any.

The cost includes the cost of replacing parts and borrowing costs for long-term construction projects if the recognition criteria are met. When significant parts of the investment property are required to be replaced at intervals, the Group depreciates them separately based on their specific useful lives. All other repair and maintenance costs are recognised in profit or loss as incurred.

The Group depreciates building component of investment property over 30 years from the date of original purchase.

The Group, based on technical assessment made by technical expert and management estimate, depreciates the building over estimated useful lives which are different from the useful life prescribed in Schedule II to the Companies Act, 2013. The management believes that these estimated useful lives are realistic and reflect fair approximation of the period over which the assets are likely to be used.

Though the Group measures investment property using cost-based measurement, the fair value of investment property is disclosed in the notes. Fair values are determined based on an annual evaluation performed by an accredited external independent valuer applying a valuation model recommended by the International Valuation Standards Committee.

Investment properties are derecognised either when they have been disposed of or when they are permanently withdrawn from use and no future economic benefit is expected from their disposal. The difference between the net disposal proceeds and the carrying amount of the asset is recognised in profit or loss in the period of derecognition. In determining the amount of consideration from the derecognition of investment property the Group considers the effects of variable consideration, existence of a significant financing component, non-cash consideration, and consideration payable to the buyer (if any).

Transfers are made to (or from) investment property only when there is a change in use.

### I) Financial instruments

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

### I. Financial Assets

### A) Initial recognition and measurement

All financial assets are recognised initially at fair value plus, in the case of financial assets not recorded at fair value through profit or loss, transaction costs that are attributable to the acquisition of the financial asset.

### B) Subsequent measurement

For purposes of subsequent measurement, financial assets are classified in four categories:

Debt instruments at amortised cost

A 'debt instrument' is measured at the amortised cost if both the following conditions are met:

- The asset is held within a business model whose objective is to hold assets for collecting contractual cash flows, and
- Contractual terms of the asset give rise on specified dates to cash flows that are solely payments of principal and interest (SPPI) on the principal amount outstanding.

This category is the most relevant to the Group. After initial measurement, such financial assets are subsequently measured at amortised cost using the effective interest rate (EIR) method. Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included in other income in the statement of profit and loss. The losses arising from impairment are recognised in the profit or loss. This category generally applies to trade and other receivables.

 Debt instruments at fair value through other comprehensive income (FVTOCI)

A 'debt instrument' is classified as at the FVTOCI if both of the following criteria are met:

- The objective of the business model is achieved both by collecting contractual cash flows and selling the financial assets, and
- The asset's contractual cash flows represent SPPI.

Debt instruments included within the FVTOCI category are measured initially as well as at each reporting date at fair value. Fair value movements are recognised in the other



comprehensive income (OCI). On derecognition of the asset, cumulative gain or loss previously recognised in OCI is reclassified from the equity to statement of profit and loss. Interest earned whilst holding FVTOCI debt instrument is reported as interest income using the EIR method.

Debt instruments at fair value through
 profit or loss (FVTPL)

FVTPL is a residual category for debt instruments. Any debt instrument, which does not meet the criteria for categorisation as at amortised cost or as FVTOCI, is classified as at FVTPL.

In addition, the Group may elect to designate a debt instrument, which otherwise meets amortised cost or FVTOCI criteria, as at FVTPL. However, such election is allowed only if doing so reduces or eliminates a measurement or recognition inconsistency (referred to as 'accounting mismatch'). Debt instruments included within the FVTPL category are measured at fair value with all changes recognised in the statement of profit and loss.

 Equity instruments measured at fair value through other comprehensive income (FVTOCI)

All equity investments in scope of Ind AS 109 are measured at fair value. Equity instruments which are held for trading and contingent consideration recognised by an acquirer in a business combination to which Ind AS103 applies are classified as at FVTPL. For all other equity instruments, the Group may make an irrevocable election to present in other comprehensive income subsequent changes in the fair value. The Group makes such election on an instrument-by-instrument basis. The classification is made on initial recognition and is irrevocable.

If the Group decides to classify an equity instrument as at FVTOCI, then all fair value changes on the instrument, excluding dividends, are recognised in the OCI. There is no recycling of the amounts from OCI to P&L, even on sale of investment. However, the Group may transfer the cumulative gain or loss within equity.

Equity instruments included within the FVTPL category are measured at fair value with all changes recognised in the statement of profit and loss.

### C) Derecognition

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e. removed from the Group's balance sheet) when:

- The rights to receive cash flows from the asset have expired, or
- The Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a 'pass through' arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset. When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass through arrangement, it evaluates if and to what extent it has retained the risks and rewards of ownership. When it has neither transferred nor retained substantially all of the risks and rewards of the asset, nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

### D) Impairment of financial assets

The Group assesses on a forward looking basis the expected credit losses associated with its assets carried at amortised cost and FVOCI debt instruments. The impairment methodology applied depends on whether there has been a significant increase in credit risk. For trade receivables only, the Group applies the simplified approach permitted by Ind AS 109 Financial Instruments, which requires expected lifetime losses to be recognised from initial recognition of the receivables.

### E) Investments in joint ventures

The Group has elected to account for its equity investments in joint ventures under IND AS 27 on Separate Financials Statements, as per the equity method. At the end of each reporting period the Group assesses whether there are indicators of diminution in the value of its investments and provides for impairment loss, where necessary.

### II. Financial Liabilities

### A) Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables, or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

### B) Subsequent measurement

The measurement of financial liabilities depends on their classification, as described below:

Financial liabilities at fair value through
 profit or loss

Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss. Financial liabilities are classified as held for trading if they are incurred for the purpose of repurchasing in the near term. This category also includes derivative financial instruments entered into by the Group that are not designated as hedging instruments in hedge relationships as defined by Ind AS 109. Separated embedded derivatives are also classified as held for trading unless they are designated as effective hedging instruments. Gains or losses on liabilities held for trading are recognised in the profit or loss.

Financial liabilities designated upon initial recognition at fair value through profit or loss are designated as such at the initial date of recognition, and only if the criteria in Ind AS 109 are satisfied. For liabilities designated as FVTPL, fair value gains/ losses attributable to changes in own credit risk are recognised in OCI. These gains/ loss are not subsequently transferred to P&L. However, the Group may transfer the cumulative gain or loss within equity. All other changes in fair value of such liability are recognised in the statement of profit or loss.

Loans and Borrowings

This is the category most relevant to the Group. After initial recognition, interestbearing loans and borrowings are subsequently measured at amortised cost using the EIR method. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the EIR amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included as finance costs in the statement of profit and loss.

### Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. Financial guarantee contracts are recognised initially as a liability at fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequently, the liability is measured at the higher of the amount of loss allowance determined as per impairment requirements of Ind AS 109 and the amount recognised less cumulative amortisation.

The fair value of financial guarantees is determined as the present value of the difference in net cash flows between the contractual payments under the debt instrument and the contractual payments that would be required without the guarantee, or the estimated amount that would be payable to a third party for assuming the obligations.

### C) De-recognition

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the statement of profit or loss.

### D) Compound instruments

The component parts of compound instruments (optionally convertible preference share) issued by the Group are classified separately as financial liabilities and equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument. A conversion option that will be settled by the exchange of a fixed amount of cash or another financial asset for a fixed number of the Group's own equity instruments is an equity instrument.

At the date of issue, the fair value of the liability component is estimated using the prevailing market interest rate for similar non-convertible instruments. This amount is recorded as a liability on an amortised cost basis using the effective interest method until extinguished upon conversion or at the instrument's maturity date.

The conversion option classified as equity is determined by deducting the amount of the liability component from the fair value of the compound instrument as a whole. This is recognised and included in equity, net of income tax effects, and is not subsequently remeasured. In addition, the conversion option classified as equity will remain in equity until the conversion option is exercised, in which case, the balance recognised in equity will be transferred to other component of equity. When the conversion option remains unexercised at the maturity date of the convertible instrument, the balance recognised in equity will be transferred to retained earnings. No gain or loss is recognised in statement of profit and loss upon conversion or expiration of the conversion option.

Transaction costs that relate to the issue of the convertible instruments are allocated to the liability and equity components in proportion to the allocation of the gross proceeds. Transaction costs relating to the equity component are recognised directly in equity. Transaction costs relating to the liability component are included in the carrying amount of the liability component and are amortised over the lives of the convertible instrument using the effective interest method.

### III. Reclassification of financial assets / liabilities

After initial recognition, no reclassification is made for financial assets which are equity instruments and financial liabilities. For financial assets which are debt instruments, a reclassification is made only if there is a change in the business model for managing those assets. Changes to the business model are expected to be infrequent. The Group's senior management determines change in the business model as a result of external or internal changes which are significant to the Group's operations.

### IV. Offsetting of financial instruments

Financial assets and liabilities are offset and the net amount is reported in the balance sheet where there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of Group or the counterparty.

### V. Derivatives and hedging activities

The Group enters derivatives like forwards contracts to hedge its foreign currency risks. Derivatives are initially recognised at fair value on the date a derivative contract is entered into and are subsequently marked to market at the end of each reporting period with profit/loss being recognised in statement of profit and loss. Derivative assets/ liabilities are classified under "other financial assets/ other financial liabilities". Profits and losses arising from cancellation of contracts are recognised in the statement of profit and loss.

### m) Inventories:

Finished goods are stated at the lower of cost and net realisable value. Raw material, packing materials and stores & spares are stated at costs unless the finished goods in which they will be incorporated are expected to be sold below cost. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

Costs incurred in bringing each product to its present location and condition are accounted for as follows:

- Raw materials, Packing Materials and stores & spares: cost includes cost of purchase and other costs incurred in bringing the inventories to their present location and condition.
- Finished goods and work in progress: cost includes cost of direct materials and labour and a proportion of manufacturing overheads based on the normal operating capacity, but excluding borrowing costs.

Due allowances are made for slow moving and obsolete inventories based on estimates made by the Group.

### Impairment of non-financial assets n)

At the end of each reporting period, the Group reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash-generating units, or otherwise they are allocated to the smallest aroup of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Intangible assets with indefinite useful lives and intangible assets not yet available for use are tested for impairment at least annually, and whenever there is an indication that the asset may be impaired.



Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in statement of profit and loss.

When an impairment loss subsequently reverses, the carrying amount of the asset (or a cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or cash-generating unit) in prior years. A reversal of an impairment loss is recognised immediately in statement of profit and loss.

### o) Provisions and contingent liabilities:

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (when the effect of the time value of money is material). When discounting is used, the increase in the provision due to the passage of time is recognised as a finance cost.

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

A contingent liability is:-

- a possible obligation that arises from past events and whose existence will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the entity; or
- b) a present obligation that arises from past events but is not recognised because:-
  - it is not probable that an outflow of resources embodying economic benefits will be required to settle the obligation; or
  - ii) the amount of the obligation cannot be measured with sufficient reliability.

Contingent liability is disclosed in the case of:

- a present obligation arising from past events, when it is not probable that an outflow of resources will be required to settle the obligation;
- a present obligation arising from past events, when no reliable estimate is possible;
- a possible obligation arising from past events, unless the probability of outflow of resources is remote.

A contingent asset is disclosed where an inflow of economic benefits is probable.

Provisions, contingent liabilities and contingent assets are reviewed at each balance sheet date

### p) Retirement and other employee benefits:

### Post-employment benefits

- Payments to defined contribution benefit plans are recognised as an expense when employees have rendered service entitling them to the contributions. For defined benefit retirement plans, the cost of providing benefits is determined using the projected unit credit method, with actuarial valuations being carried out at the end of each annual reporting period. Remeasurement, comprising actuarial gains and losses, the effect of the changes to the asset ceiling (if applicable) and the return on plan assets (excluding net interest), is reflected immediately in the balance sheet with a charge or credit recognised in other comprehensive income in the period in which they occur. Remeasurement recognised in other comprehensive income is reflected immediately in retained earnings and is not reclassified to statement of profit and loss. Past service cost is recognised in statement of profit and loss in the period of a plan amendment. Net interest is calculated by applying the discount rate at the beginning of the period to the net defined benefit liability or asset. Defined benefit costs are categorised as follows:
- Service cost (including current service cost, past service cost, as well as gains and losses on curtailments and settlements);
- Net interest expense or income; and
- Re-measurement.

The Group presents the first two components of defined benefit costs in statement of profit and loss in the line item "Employee benefits expense", and the last component in Other Comprehensive Income which is immediately reflected in retained earnings and is not reflected in statement of profit and loss account. Curtailment gains and losses are accounted for as past service costs.

The retirement benefit obligation recognised in the balance sheet represents the actual deficit or surplus in the Group's defined benefit plans. Any surplus resulting from this calculation is limited to the present value of any economic benefits available in the form of refunds from the plans or reductions in future contributions to the plans.

### **Terminal benefits**

A liability for a termination benefit is recognised at the earlier of when the entity can no longer withdraw the offer of the termination benefit and when the entity recognises any related restructuring costs.

### Short-term and other long-term employee benefits

A liability is recognised for benefits accruing to employees in respect of wages and salaries, performance incentives and similar benefits other than compensated absences in the period the related service is rendered at the undiscounted amount of the benefits expected to be paid in exchange for that service.

Liabilities recognised in respect of compensated absences are measured on the basis of actuarial valuation as on the balance sheet date.

Liabilities recognised in respect of other long-term employee benefits are measured at the present value of the estimated future cash outflows expected to be made by the Group in respect of services provided by employees up to the reporting date.

### q) Earnings per share:

Basic earnings per share is calculated by dividing the profit/loss attributable to the owners of the Group by the weighted average number of equity shares outstanding during the financial year.

Diluted earnings per share adjusts the figure used in determination of basic earnings per share to take into account the after income tax effect of interest and other financing costs associated with dilutive potential equity shares, and the weighted average number of additional equity shares that would have been outstanding assuming the conversion of all dilutive potential equity shares.

### r) Operating segment

The management views the Group's operation as a single segment engaged in business of "Textiles" Hence there is no separate reportable segment under Ind AS 108 'Operating segment'.

### s) Onerous contracts

If the Group has a contract that is onerous, the present obligation under the contract is recognised and measured as a provision. However, before a separate provision for an onerous contract is established, the Group recognises any impairment loss that has occurred on assets dedicated to that contract.

An onerous contract is a contract under which the unavoidable costs (i.e., the costs that the Group cannot avoid because it has the contract) of meeting the obligations under the contract exceed the economic benefits expected to be received under it. The unavoidable costs under a contract reflect the least net cost of exiting from the contract, which is the lower of the cost of fulfilling it and any compensation or penalties arising from failure to fulfil it. The cost of fulfilling a contract comprises the costs that relate directly to the contract (i.e., both incremental costs and an allocation of costs directly related to contract activities).

### t) Government Grant

Government grants are recognised where there is reasonable assurance that the grant will be received, and all attached conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the related costs, for which it is intended to compensate, are expensed. When the grant relates to an asset, it is recognised as income in equal amounts over the expected useful life of the related asset.

When the Group receives grants of non-monetary assets, the asset and the grant are recorded at fair value amounts and released to profit or loss over the expected useful life in a pattern of consumption of the benefit of the underlying asset i.e. by equal annual instalments.

When loans or similar assistance are provided by governments or related institutions, with an interest rate below the current applicable market rate, the effect of this favourable interest is regarded as a government grant. The loan or assistance is initially recognised and measured at fair value and the government grant is measured as the difference between the initial carrying value of the loan and the proceeds received. The loan is subsequently measured as per the accounting policy applicable to financial liabilities.

### u) Key sources of estimation uncertainty and critical accounting judgements

In the course of applying the accounting policies, the Group is required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future period, if the revision affects current and future periods.

### Key sources of estimation uncertainty

### a) Useful lives of property, plant and equipment

Management reviews the useful lives of property, plant and equipment at least once a year. Such lives are dependent upon an assessment of both the technical lives of the assets and also their likely economic lives based on various internal and external factors including relative efficiency and operating costs. Refer Note 2 and 29 for further disclosure.

### b) Impairment of property plant and equipment, investment property and right-of-use assets

assets are impaired requires an estimate in the value in use of cash generating units. ### c) Impairment of investments in joint ventures

Determining whether the investments in joint ventures are impaired requires an estimate in the value in use. In considering the value in use, the Management have anticipated the future cash flows, discount rates and other factors of the underlying businesses/companies. In certain cases, the Group engages third party qualified valuers to perform the valuation. The management works closely with the qualified external valuers to establish the appropriate valuation techniques and inputs to the model. Refer Note 5 and 45 for further disclosure.

### d) Provisions, liabilities and contingencies

Provisions and liabilities are recognized in the period when it becomes probable that there will be a future outflow of funds resulting from past events that can reasonably be estimated. The timing of recognition requires application of judgement to existing facts and circumstances which may be subject to change.

In the normal course of business, contingent liabilities may arise from litigation and other claims against the Group. Potential liabilities that are possible but not probable of an outflow of resources embodying economic benefits are treated as contingent liabilities. Such liabilities are disclosed in the notes but are not recognized. Refer Note 38 for further disclosure.

### e) Taxes

Deferred tax assets are recognized for unused tax losses to the extent that it is probable that taxable profit will be available against which the losses can be utilized. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and the level of future taxable profits together with future tax planning strategies. Refer Note 7 and 40 for further disclosure.

### f) Employee benefit plans

The cost of defined benefit gratuity plan and other post-employment benefits are determined using actuarial valuations. An actuarial valuation involves making various assumptions that may differ from actual developments in the future. These include the determination of the discount rate, future salary increases and mortality rates. Due to the complexities involved in the valuation and its longterm nature, a defined benefit obligation is highly sensitive to changes in these assumptions. All assumptions are reviewed at each reporting date. The mortality rate is based on publicly available mortality tables for India. Those mortality tables tend to change only at interval in response to demographic changes. Future salary increases and gratuity increases are based on expected future inflation rates. Refer Note 27 and 46 for further disclosure.

### g) Lease

The application of Ind AS 116 requires Group to make judgements and estimates that affect the measurement of right-of-use assets and liabilities. In determining the lease term, we consider all facts and circumstances that create an economic incentive to exercise renewal options (or not exercise termination options). Assessing whether a contract includes a lease also requires judgement. Estimates are required to determine the appropriate discount rate used to measure lease liabilities.

The Group cannot readily determine the interest rate implicit in the lease, therefore, it uses its incremental borrowing rate (IBR) to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group 'would have to pay', which requires estimation when no observable rates are available or when they need to be adjusted to reflect the terms and conditions of the lease. The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates.

### h) Recoverability of Trade Receivables

Judgements are required in assessing the recoverability of overdue trade receivables and determining whether a provision against those receivables is required. Factors considered include the credit rating of the counterparty, the amount and timing of anticipated future payments and any possible actions that can be taken to mitigate the risk of non-payment.

### i) Changes in accounting policies and disclosures

**31** In the previous year, the Parent Company has completed all the steps as laid down in appeared by the National Company Law Tribunal vide its order dated 8th March, 2019 of the resolution plan and the resolution applicants had obtained joint control over the Parent Company and the Board of Directors have been re-constituted on 14th September, 2020, being the closing date as determined by the Parent Company in terms of the resolution plan.

The re-constituted Board has adopted a business plan with specific focus on utilising the existing capacities and upgrading the efficiency / productivity of the existing machinery at the manufacturing plants. Though the Parent Company has incurred a loss of ₹ 184.18 crore (before exceptional items) for the year ended 31st March, 2022, the cash flow projection for the next year are adequate to meet the existing financial obligation due in the next year. Further as at 31st March, 2022 the current assets of the Parent Company exceeds its current liabilities by ₹ 169.18 crores. Further, the group management is also in the process of realigning its strategy with respect to its subsidiary operations. The Group has no immediate loan obligations. Basis this, the Group has assessed that it will be able to meet its financial obligations for the next 12 months. Accordingly, the financial statements have been prepared on a going concern basis.

- **32** The outbreak of corona virus (Covid-19) pandemic globally and in India is causing significant disturbance and slowdown of economic activity. The Group's operations and revenue during the current and previous period were impacted due to Covid-19. The Group has taken into account the possible impact of Covid-19 in preparation of the financial results, including its assessment of the recoverable value of its assets based on the internal and external information up to the date of approval of these financial results and current indicators of future economic conditions.
- 33 As per Clause 1.2 (xi) of Approved Resolution Plan, the outstanding debt amounting to ₹ 17,384.02 assigned

to Resolution Applicants shall not carry interest for the first 8 years from the Closing Date (as defined in the Approved Resolution Plan), hence such debt has been measured at cost. After such period of 8 years, the terms of assigned debt shall be mutually agreed among the Resolution Applicants and the Parent Company. The Approved Resolution Plan has an overriding effect on the requirements of Ind AS, as per legal view obtained by the Parent Company in this regard. Hence, had the Parent Company applied the Ind AS, it would have recognised the assigned debt at its fair value and accordingly recognized the imputed interest cost over the period of loan in the statement of profit and loss.

34 As on June 2017, the Parent Company had an amount of ₹ 11,623.94/- crore receivable from trading debtors on account of sale of fabric ("Outstanding Trading Dues"). As at 31st March 2019 the Parent Company had created full provision against said receivables by charging it to the statement of profit and loss in earlier years. As per the Approved Resolution Plan, if any of the trading debtors make payment towards the Outstanding Trading Dues or any person is required to contribute to the assets of the Parent Company under any legal process against the Outstanding Trading Dues and has contributed the same, such amounts (net of any income tax payable by the Parent Company on account of such receipt of the Outstanding Trading Dues) shall be deposited in a designated escrow account ("Escrow Account") to be opened in the name of the Parent Company.

Accordingly, the Parent Company has an obligation to deposit into the escrow account any collections received out of the "Outstanding Trading Dues" or otherwise, as stated above, for the benefit of the Financial Creditors and as a result therefore, the risk and reward associated with the Outstanding Trading Dues now belong to the Financial Creditors. The Parent Company has not received any amounts towards Outstanding Trading Dues in the current year.

### Note

- Claims / Debts against the Parent Company upto the closing date which are addressed under the NCLT approved resolution plan are not included in contingent liabilities though many of such claims / debts may be pending for disposal at various judicial forums. As per clause 3.3.4 of the aforesaid resolution plan, these liabilities stands extinguished. Accordingly, the management has assessed that the possibility of outflow of resources embodying economic benefits with respect to such claims / debts is remote.
- 2) All direct and indirect tax liabilities relating to assessments of earlier year upto the closing date stand extinguished as per the NCLT approved resolution plan. Further, the implementation of the resolution plan does not have any effect over claims or receivables owed to the Parent Company. Accordingly, the Parent Company has assessed that any receivables due to the Parent Company, evaluated based on merits of underlying litigations, from various governmental agencies continues to subsist.
- 3) In Subsidiary Company, arbitration proceeds initiated by Peninsula Land Limited before the Tribunal towards VAT, ITFS and other related liabilities.
- 4) The Parent Company has entered into Gas Sale Agreement (GSA) / Gas Transmission Agreement (GTA) dated 27th May, 2013 with GAIL India Limited ('GAIL') for the supply of re-liquified natural gas (RLNG) to the delivery point and for transmission of gas from the delivery point to the unit. The tenure of the agreements was for a period of 15 years and includes a take or pay clause (ToP) in the contract. Upto the closing date i.e 14th September, 2020, GAIL had raised claims of ₹ 1,090 crores invoking the ToP clause under the contract. GAIL was covered as an operational creditor under the NCLT approved resolution plan which provides for Nil payment if dues of operational creditors are above ₹ 3 lacs. Aggrieved by the order, GAIL had filed an appeal with National Company Law Appellate Tribunal (NCLAT), which has been dismissed by the latter by order dated October 4, 2021. Subsequently, the Hon'ble Supreme Court has also dismissed GAIL's appeal vide its order dated March 21, 2022, however the question of law is kept open. Accordingly, the aforesaid claim / demand upto the closing date has been considered as remote.

The NCLT and NCLAT orders supra with respect to the GAIL matter also state that, post the closing date, if GAIL wishes to continue supply of gas to the Parent Company, it may separately negotiate the same with the Parent Company and the same does not fall within the ambit of the Resolution Plan. Basis this, both the parties are negotiating various operational aspects of the agreement, including those relating to ToP liability post the closing date for which GAIL has raised claims on the Parent Company. The Parent Company has requested GAIL for waiver of all claims raised on the Parent Company towards ToP post the closing date and has assessed that in a situation the ToP liability is not waived by GAIL, the Parent Company has an equal right under the gas sale agreement to pick up equivalent gas upto the end of the Recovery period, as defined in the said agreement. The Parent Company has also assessed that the gas so picked up can be utilised and accordingly no financial loss is expected to arise to the Parent Company. Further, the Parent Company has also taken an independent legal view that pending the conclusion of re-negotiation of the gas sale agreement, the ToP claim, post the closing date, is a contingent liability.

### Exceptional Item - for the year ended March 31, 2021

- a) In terms of the Approved Resolution Plan of Parent Company, JM and Reliance Industries Limited ('RIL') have converted such portion of their assigned debt into equity, such that their joint equity holding in the Parent Company is 75%. Pursuant to such conversion, the proportionate reduction in Outstanding ARC Debt as per clause 1.2 (xii) of the Approved Resolution Plan is ₹ 5,240.14 crore. The price at which the conversion has taken place has been determined in accordance with the Approved Resolution Plan and applicable law and consequently, the difference between the issue of 275.46 crore equity shares at face value and the amount by which the assigned debt has been proportionately reduced as stated above has been recognised as exceptional gain in the statement of profit and loss of previous year.
- b) In terms of the Approved Resolution Plan of Parent Company, 13,59,11,844 pledged equity shares were transferred to JM Financial Asset Reconstruction Company Limited (acting in its capacity as Trustee for JMFARC- March - 2018 – Trust) (referred as "JM"). Further, as per the aforesaid Plan, the debt assigned to JM has been proportionately reduced by the value of such shares (₹ 58.44 crore) determined basis the lower of the trading price prevailing on BSE Limited or National Stock Exchange of India Limited one day before the date of invocation. Accordingly, extinguishment of financial liability amounting to ₹ 58.44 crore has been recognised as exceptional gain in the statement of profit and loss of previous year.
- c) The Parent Company has been incurring operational losses over the past few years working at capacity utilization of about 30-35%. The carrying value of assets is based on a value in use calculation which uses cash flow projections based on financial budgets approved by the management covering a seven year period, and a discount rate of 11.61% per annum. Based on the dynamics of the sector in which Parent Company operates, the management has assumed long term growth rate of 0% to calculate the terminal value. Accordingly, the Parent Company has recognized an impairment loss of ₹ 8,264.22 crore on tangible assets during the year and is included in exceptional items in the Statement of Profit and Loss of previous year.
- d) In the previous year, on 22nd March, 2021, the NCLT has passed the order for withdrawal of the corporate insolvency resolution process for Alok Infrastructure Limited, wholly owned subsidiary of the Company. Post this, the subsidiary has also performed a valuation of its investment properties / inventories with the help of external valuation specialists (based on market sale comparison method) and accordingly considered impairment in its books. The group management believes the fair value considered by the subsidiary is reasonable considering that the same was done by the valuer for the lenders.
- 42 Alok Infrastructure Limited was admitted under the corporate insolvency resolution ("CIR") process in terms of the Insolvency and Bankruptcy Code, 2016 ("Code"), vide an order dated 24 October 2018 of the Hon'ble National Company Law Tribunal, Mumbai ("Adjudicating Authority"). The Resolution Professional has subsequently, under the advice of the Committee of Creditors filed an Application under Section 12A of the Code withdrawing the insolvency petition. Accordingly the Adjudicating authority vide Order dated 22nd March, 2021 has allowed the withdrawal application filed by the Resolution Professional.
- **43** In the previous year, Group has performed an impairment assessment of the recoverability of the carrying value of its investments in the joint ventures i.e Aurangabad Textiles & Apparel Parks Limited and New City of Bombay Mfg. Mills Limited and accordingly impaired the full value in the books. In doing so, Group has taken into consideration the Group's share in expected recovery of assets of the joint ventures, net of any liabilities and guarantees given by the Group in respect of the joint ventures.

### 49 Capital Management and Financial Risk Management Framework

The Group being in a working capital intensive industry, its objective is to maintain a strong credit rating, healthy ratios and establish a capital structure that would maximize the return to stakeholders through optimum mix of debt and equity.

The Group's capital requirement is mainly to fund its capex, working capital, repayment of principal and interest on its borrowings. The principal source of funding of the Group has been, and is expected to continue to be, cash generated from its operations supplemented by funding from bank borrowings and the capital markets. The Group is not subject to any externally imposed capital requirements.

The Group manages its capital structure and makes adjustments in light of changes in economic conditions and the requirements of the financial covenants. The Group monitors capital using a gearing ratio, which is net debt divided by total capital plus net debt. Since net worth of the Group is negative, debt equity ratio is not calculated.

The key risks associated with day to day operations of the Group and working capital management are given below:

### A Credit Risk:

Credit risk is the risk that counter party will not meet its obligation under a financial instrument or customer contract leading to a financial loss. The Group is exposed to credit risk mainly from trade receivables and other financial assets.

### i) Trade Receivables

Trade receivables are typically unsecured and are derived from revenue earned from customers. Credit risk has been managed by the Group through credit approvals, establishing credit limits and continuously monitoring the creditworthiness of customers to which the Group grants credit terms in the normal course of business. On account of adoption of Ind AS 109, the Group uses expected credit loss model to assess the impairment loss or gain. The Group uses a provision matrix and forward-looking information and an assessment of the credit risk over the expected life of the financial asset to compute the expected credit loss allowance for trade receivables. Concentrations of credit risk with respect to trade receivables are limited.

### ii) Other Financial Assets & loans

The Group has limited credit risk arising from cash and cash equivalents as the deposits are maintained with banks and financial institutions with high credit rating. Further, other financial assets mainly comprises of Export incentives and balances with statutory authorities (GST input credit balances) which are recoverable from Government. Hence, these are low risk items and the Group evaluates the recoverability of these financial assets at each reporting date and wherever required, a provision is created against the same.

### B. Market Risk:

Market risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises of three types of risks – interest rate risk, currency risk and other price risk in a fluctuating market environment. Financial instrument affected by market risks includes loans and borrowings, deposits, derivatives and other financial assets.

### i) Currency Risk

The Group's functional currency is Indian Rupees (INR). The Group undertakes transactions denominated in foreign currencies; consequently, exposure to exchange rate fluctuations arise. Volatility in exchange rates affects the Group's revenue from export markets and the costs of imports. The Group has exports and to that extent has a natural hedge as a mitigation measure to cover foreign exchange risk on account of imports/expenses in foreign currency.

The Group manages its foreign currency risk by entering into forward contracts.

### ii) Interest rate risk

a) Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Group is exposed to interest rate risk because funds are borrowed at both fixed and floating interest rates. Interest rate risk is measured by using the cash flow sensitivity for changes in variable interest rate. The borrowings of the Group are principally denominated in rupees with a mix of fixed and floating rates of interest. The Group has exposure to interest rate risk, arising principally on changes in base lending rate. The Group uses a mix of interest rate sensitive financial instruments to manage the liquidity and fund requirements for its day to day operations. The risk is managed by the Group by maintaining an appropriate mix between fixed and floating rate borrowings.

### iii) Commodity Price Risk

Commodity price risk arises due to fluctuation in prices of raw materials like PTA, MEG, cotton and yarn. The Group has a risk management framework aimed at prudently managing the risk arising from the volatility in commodity prices and freight costs. The Group's commodity risk is managed centrally through well-established trading operations and control processes.

### C. Financial risk management objectives

The Group has a Risk Management Committee established by its Board of Directors for overseeing the Risk Management Framework and developing and monitoring the Group's risk management policies. The risk management policies are established to ensure timely identification and evaluation of risks, setting acceptable risk thresholds, identifying and mapping controls against these risks, monitor the risks and their limits, improve risk awareness and transparency. Risk management policies and systems are reviewed regularly to reflect changes in the market conditions and the Group's activities to provide reliable information to the Management and the Board to evaluate the adequacy of the risk management framework in relation to the risk faced by the Group.

### D Liquidity Risk:

Liquidity risk refers to the risk of financial distress or extraordinary high financing costs arising due to shortage of liquid funds in a situation where business conditions unexpectedly deteriorate and requiring financing. The Group requires funds both for short term operational needs as well as for long term capital expenditure for capex. The Group generates sufficient cash flow for operations, which together with the available cash and cash equivalents provide liquidity in the short-term and long-term. The Group has established an appropriate liquidity risk management framework for the management of the Group's short, medium and long-term funding and liquidity management requirements. The Group manages liquidity risk through cash generated from operations, banking facilities and reserve borrowing facilities, by continuously monitoring forecast and actual cash flows, and by matching the maturity profiles of financial assets and liabilities. As at 31st March, 2022, the Group's current liabilities exceeds its current assets by ₹ 1,391.79 crore.

# How do I vote electronically using NSDL e-voting system?

The way to vote electronically on NSDL e-voting system consists of "Two Steps" which are mentioned below:

#### Step 1: Access to NSDL e-voting system

### A) Login method for e-voting for Individual Members holding shares in demat mode:

In terms of SEBI circular dated 9th December, 2020 on e-voting facility provided by Listed Companies, Individual Members holding shares in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Members are advised to update their mobile number and e-mail Id in their demat accounts in order to access e-voting facility.

The .pdf file contains your 'User ID' and your 'initial password'.
    - ii. If your e-mail ID is not registered, please follow steps mentioned below in process for those Members whose e-mail ids are not registered.
- If you are unable to retrieve or have not received the "Initial password" or have forgotten your password:
  - a) Click on "Forgot User Details/ Password?" (If you are holding shares in your demat account with NSDL or CDSL) option available on www. evoting.nsdl.com.
  - b) Physical User Reset Password?" (If you are holding shares in physical mode) option available on www. evoting.nsdl.com.

- c) If you are still unable to get the password by aforesaid two options, you can send a request at evoting@ nsdl.co.in mentioning your demat account number/folio number, your PAN, your name and your registered address etc.

- 7. After entering your password, tick on Agree to "Terms and Conditions" by selecting on the check box.
- 8. Now, you will have to click on "Login" button.
- 9. After you click on the "Login" button, Home page of e-voting will open.

# Step 2: Cast your vote electronically on NSDL e-voting system.

# How to cast your vote electronically on NSDL e-voting system?

- After successful login at Step 1, you will be able to see all the companies "EVEN" in which you are holding shares and whose voting cycle and general meeting is in active status.
- Select "EVEN" of company for which you wish to cast your vote during the remote e-voting period.
- 3. Now you are ready for e-voting as the Voting page opens.
- Cast your vote by selecting appropriate options i.e. assent or dissent, verify/modify the number of shares for which you wish to cast your vote and click on "Submit" and also "Confirm" when prompted.
- 5. Upon confirmation, the message "Vote cast successfully" will be displayed.
- 6. You can also take the printout of the votes cast by you by clicking on the print option on the confirmation page.
- 7. Once you confirm your vote on the resolution, you will not be allowed to modify your vote.

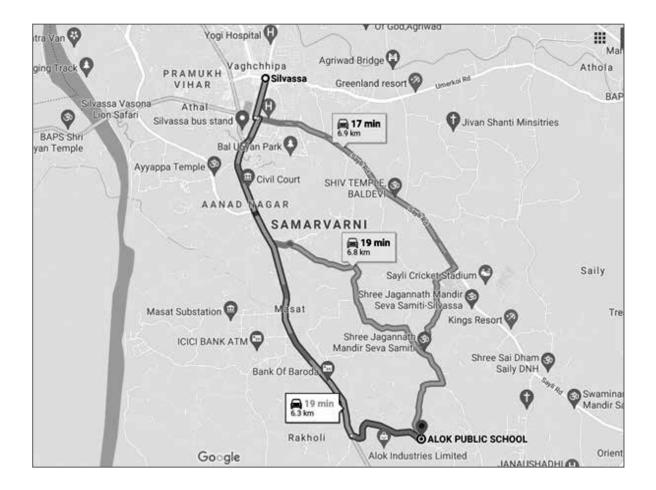
