NOTES FOR THE MEMBERS' ATTENTION

- 1. A member entitled to attend and vote at the meeting is entitled to appoint a proxy to attend and vote instead of himself and such proxy need not be a member of the company. - 3. The Register of Members and Share Transfer Books of the company will remain closed from 16th December 2010 to 30th December 2010 (both days inclusive)
