Any Member entitled to attend and vote at the Annual General Meeting is entitled to appoint a proxy to attend the said meeting and vote on her/his behalf, and the proxy need not be a Member of the Company. Proxies, in order to be effective, must be received at the Registered Office of the Company not less than 48 hours before the commencement of the meeting.
Pursuant to Section 105(1) of the Companies Act, 2013, read with Rule 19 of the Companies (Management and Administration) Rules, 2014, a person can act as proxy on behalf of Members not exceeding 50 (fifty) in number and holding in aggregate not more than 10 (ten) per cent of the total share capital of the Company carrying voting rights. In the case of a Member holding more than 10 (ten) per cent of the total share capital of the Company carrying voting rights, such a Member may appoint a single person as proxy, who however shall not act as proxy for any other person or shareholder.
2. Pursuant to provisions of Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended by the Companies (Management and Administration) Amendment Rules, 2015 and Clause 44 of the Listing Agreement, the Company is pleased to provide members facility to exercise their right to vote at the Annual General Meeting by electronic means along with the Ballot Form and the business may be transacted through e-Voting Services. The members who have cast their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.
The e-voting period commences on 20th September, 2017 (10:00 a.m.) and ends on 22nd September, 2017 (05:00 p.m.). During this period shareholders' of the Company, may cast their vote electronically. Please note the following:

A member may participate in the AGM even after exercising his right to vote through remote e-voting but shall not be allowed to vote again at the AGM.

A person, whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date only shall be entitled to avail the facility of remote e-voting as well as voting at the AGM through ballot paper.

The Chairman shall, at the AGM, at the end of discussion on the resolutions on which voting is to be held, allow voting with the assistance of scrutinizer, by use of ballot paper for all those members who are present at the AGM but have not cast their votes by availing the remote e-voting facility.

The Directors of Haryana Leather Chemicals Ltd. are pleased to present the 32nd Annual Report and Audited Statement of the Company's accounts for the year ended on 31st March, 2017.

OPERATIONS

The net profit from the operations during the year 2016-17 remain same as last year as compared to previous year's profits. In spite of recessionary trends in Indian leather industry. Overall sales turnover is lower than last year mainly due to drop in domestic sale by nearly 4%.

DIRECTORS

The composition of the Board of Directors of the Company is furnished in the Corporate Governance Report annexed to this report.

Pursuant to the provisions of the Articles of Association of the Company, the Directors - Mr. Pradeep Behl (DIN: 00703855), Mr. Marco Medini (DIN: 06709885) and Mr. Vijay Kumar Garg (DIN: 00236460) retire by rotation at the forthcoming Annual General Meeting to be held on 23rd September, 2017 and being eligible they offer themselves for re-appointment.

STATUTORY AUDITORS

The statutory auditors of the Company M/s S. C. Dewan & Co., Chartered Accountants, Panchkula are retiring at the forthcoming Annual General Meeting and they are not eligible for re-appointment, instead M/s. AKR & Associates, Chartered Accountants (Firm Registration No. 021179N) offers themselves for the appointment as Statutory Auditors of the Company. Their appointment, if made, will be in accordance with section 139 and 142 of the Companies Act, 2013 (hereinafter referred to the "Act").

The Company has received letter from the Statutory Auditors consenting to the appointment and a confirmation to the effect that their appointment, would be within the prescribed limits and that they do not suffer from any disqualifications under Section 141 of the Companies Act, 2013 and the rules made thereunder.

Auditor's report does not need any comments from the Directors.

PARTICULARS OF EMPLOYEES u/s 134(3) of the Companies Act, 2013

The information required pursuant to Section 134 read with Rule 5(1) of the Companies (Appointment and Remuneration of Managerial Personnel) Rules, 2014 in respect of Directors, Key Managerial Personnel (KMP) and Employees of the Company are provided as follows:

The Company did not employ any person drawing a remuneration of Rs. 5,00,000.00 or above for one month or part of the month or Rs. 60,00,000.00 or above for one year, whose particulars are required to be mentioned u/s 197 of the Companies Act, 2013.

SECRETARIAL AUDITORS

Pursuant to the provisions of Section 204 of the Companies Act, 2013 and the Companies (Appointment and Remuneration of Managerial Personnel) Rules, 2014, the Company has appointed M/s V. Jhawar & Co., a firm of Company Secretaries in Practice, to undertake the Secretarial Audit of the Company. The report on the Secretarial Audit carried out for the year 2016-17 is annexed herewith as 'Annexure-B'. The Secretarial Audit Report does not contain any qualification, reservation, adverse remark or disclaimer.

COST AUDITOR'S COMPLIANCE

The Central Government has directed that a cost audit of the Company should be conducted in the manner specified in MCA order 52/26/CAB-2010 Dt. 24-01-2012, by a Cost Accountant within the meaning of the Cost and Works Accountants Act, 1959.

However, as per Companies (cost records and audit) Rules, 2014 notified by Ministry of Corporate Affairs, cost audit is not applicable to the Company by virtue of its turnover being less than the prescribed limits. Therefore, the Board did not proceed with the appointment of cost auditor and cost audit for the year 2016-17.

The Company is properly maintaining its cost Record internally.

WOMAN DIRECTOR

In terms of Section 149 of the Act 2013 read with Rule 3 of the Companies (Appointment and Qualification of Directors, Rules, 2014 and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is required to have a woman Director on its Board. Mrs. Sippy Jain is already appointed as the Whole time Director of the Company.

TRANSFER OF FUNDS TO INVESTOR EDUCATION AND PROTECTION FUND

The Company is distributing dividend to its shareholders since 2006 on recommendation of the shareholders of the Company. For the unclaimed dividend for the year 2008-2009 amounting Rs. 2,19,355.00, the Board has taken necessary steps to transfer the unpaid / unclaimed dividend of Equity Shareholders for the year 2008-2009 to the Investor Education and Protection Fund (IEPF) of the Central Government established under section 124 and 125 of the Companies Act, 2013.

NOMINATION AND REMUNERATION POLICY

The Nomination and Remuneration Committee of Directors (NRC) reviews the composition of the Board of Directors of the Company, to ensure that there is an appropriate mix of abilities, qualifications, experience and diversity to serve the interests of all shareholders and the Company.

During the year, in accordance with the requirements under Section 178 of the Act 2013 and relevant clause of Listing Agreement, the NRC formulated a Nomination and Remuneration Policy to govern the terms of nomination / appointment and remuneration of

- (i) Directors,
- (ii) Key Managerial Personnel (KMPs) and
- (iii) Senior Management Personnel (SMPs) of the Company.
- (iv) The same was approved The NRC also reviews succession planning of both SMPs and Board. The Company's approach in recent years is to have a greater component of performance linked remuneration for SMPs.

The process of appointing a Director / KMPs / SMPs is, that when a vacancy arises, or is expected, the NRC will identify, ascertain the integrity, qualification, appropriate expertise and experience, having regard to the skills that the candidate will bring to the Board / Company, and the balance of skills added to that of which the existing members hold.

The NRC will review the profile of persons and the most suitable person is either recommended for appointment by the Board or is recommended to shareholders for their election. The NRC has discretion to decide whether qualification, expertise and experience possessed by a person are sufficient / satisfactory for the concerned position.

NRC will ensure that any person(s) who is / are appointed or continues in the employment of the Company as its executive chairman, managing Director, whole-time Director shall comply with the conditions as laid out under Schedule V to the Act 2013.

NRC will ensure that any appointment of a person as an independent Director of the Company will be made in accordance with the provisions of Section 149 read with Schedule IV of the Act 2013 along with any other applicable provisions and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

VIGIL MECHANISM/ WHISTLE BLOWER POLICY

While every employee's contract of employment stipulates that he will not disclose confidential information about the employer's affairs, in order to bring about accountability and transparency, there should be a mechanism to enable employees to voice their concerns where they discover information which they believe shows serious malpractice, impropriety, abuse or wrong doing within the organization. The employees should be encouraged and assisted to raise concerns without any fear of victimization, subsequent discrimination or disadvantage. If the employee has acted in good faith it does not matter if one is mistaken and the Company shall ensure protection from any harassment or victimization of/against the disclosing employee.

The Company has adopted a Whistle Blower Policy which applies to all permanent employees of the Company including those who are on probation and comes into effect from April 1, 2014, to provide a formal mechanism to the Directors and employees to report their concerns about unethical behaviour, actual or suspected fraud or violation of the Company's Code of Conduct or ethics policy. The Policy provides for adequate safeguards against victimization of employees who avail of the mechanism and also provides for direct access to the Chairman of the Audit Committee. It is affirmed that no personnel of the Company has been denied access to the Audit Committee.

1. Policy and Procedure for disclosure, enquiry and disciplinary action

1.1 Concerns which may be raised-illustrative list

A whole variety of issues could fall under malpractice, impropriety, abuse and wrong doing, some of which are listed below:

- Breach of any Policy or Manual or Code adopted by the Company.
- Fraud and corruption (e.g. receiving bribes).
- Health and safety risks, including risks to the public as well as other employees e.g. faulty electrical equipment).
- Any sort of financial malpractice.
- Abuse of power (e.g. Bullying/harassment).
- any unlawful act, including failure to comply with legal or statutory obligation for and on behalf of the Company.
- Any other unethical or improper conduct.

1.2 Concerns - how to raise/whom to disclose

The concern should be disclosed through letter, e-mail, telephone, fax or any other method to any of the following persons, who shall comprise the Corporate Compliance Committee, headed by the Managing Director & Chairman reporting directly to the Audit Committee of the Board.

The Corporate Compliance Committee comprises the Managing Director & Chairman, the Executive Director & Company Secretary, the CEO and the HR.

All relevant information regarding the concern should be disclosed not later than 1 year from the date on which the employee came to know of the concern. Upon receipt of the disclosure, the member of the Compliance Committee receiving the same shall furnish a copy to the Managing Director & Chairman who shall decide which member shall be responsible for the investigation.

1.3 Procedure for investigation

- Obtain full details and clarifications of the complaint.
- Consider the involvement of the Company's Auditors or any other external investigation agency or person.
- Fully investigate into the allegation with the assistance where appropriate of other individuals/bodies.
- Prepare a detailed written report and submit the same to the Compliance Committee not later than 30 days from the date of disclosure of the concern.

Based on the findings in the written report and after conduct of such further investigation as it may deem fit, the Compliance Committee shall take a decision in the matter not later than 30 days from the date of the written report. If the complaint is shown to be justified then they shall invoke disciplinary or other appropriate action against the defaulting employee.

A copy of all decisions of the Compliance Committee shall be placed before the Audit Committee at the meeting held immediately after such final decision.

The employee making the disclosure as well as all other persons involved in the investigation and the members of the Compliance Committee shall not make public the Concern disclosed except with the prior written permission of the Audit Committee, except where the employee is called upon to disclose this by any judicial process.

FIXED DEPOSIT

The Company has not accepted/renewed any fixed deposits during the period under review.

CORPORATE GOVERNANCE

The Company has taken the requisite steps to comply with the recommendations concerning Corporate Governance. A separate statement on Corporate Governance together with a certificate on the compliance of conditions of corporate governance as stipulated under SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 has been obtained from the Statutory Auditors of the Company and the same has been given below as Annexure.

QUALITY CONTROL

The Company's quality control systems have ensured systematic redressal of quality issues and feedback from the customer base to their full satisfaction. ISO 9001:2008 and ISO 14001:2004 system are regularly audited internally and externally and have ensured very tight quality control and variances to the customer are minimized. The addition of new automatic titration platform has significantly reduced laboratory response time of important quality tests.

The Company continues to update guidelines on Restricted Substances (RS) applicable to leather industry from time to time. Company's "Green -Trek" ethos have been widely recognized by the customers. Under "Green -Trek Firewall" concept, internal screening, calibrated with external testing has eliminated any possible inclusion of banned substances listed under REACH (Registration, Evaluation and Authorization of Chemicals).

EXPORT OPERATIONS

The export continues to show downward trends without any significant sign of revival in Company's main export market of China. The Company through sustained contact has ensured maintenance of dealer and customer base, but the volumes have remained sluggish as most customers are running at lower capacities. The Company is maintaining its close ties with dealers to learn from market trends for future growth. The immigrant problem and tension between Russia and Turkey has seriously affected leather trade in this leather belt of Syria –Turkey –Russia which is closely interconnected. Further sales promotion effort in this belt has been suspended due to safety concern of marketing personnel.

African countries business has been stable with improved satisfaction level of the dealers and the users. The Company has also identified few growth prospects in Kenya, Tanzania and Morocco. Exports to neighboring countries, mainly Pakistan and Bangladesh, have also remained stable. In Iran, inspite of a good start last year, the local elections made business deals tougher. But based on new communications from dealers and the users, the prospects for the coming year are promising. The Company is committed to expand its sampling and demonstration exercise in Iran.

To Company successfully maintains 'Star Export Status' granted by the DGFT, Ministry of Commerce & Industry, Govt. of India vide Certificate No. A/1877, as per Foreign Trade Policy, 2015-2020.

TECHNOLOGY DEVELOPMENT

The Company has fully stabilized on new technologies on material handling and storage for liquids resulting in improved safety and process efficiency. During the year various prevailing technologies on powder handling were evaluated for a spill-proof and fully contained transfer of powder raw materials during process and final bagging. Based on discussions and presentations from powder handling Companies, a vacuum based technology has been shortlisted for phase-wise implantation in the year 2017-18.

In the context of powder properties from Spray Dryers, the Company undertook a consulting project on "Computational Fluid Dynamics" (CFD) jointly with IIT –Patna and IIT Mumbai. Senior professors and CFD experts from both these institutes collected base data for evaluation and also visited the plant to evaluate process conditions. Their suggestions supported by CFD analyses report and Scan Electron Microscopic (SEM) Images have shown the direction for optimizing the process conditions of Spray Dried powder products.

DIVIDEND

Though there was drop in sales revenue as compared to last year, but considering the profitability, the Directors are pleased to recommend dividend @8% this year also.

PERSONNEL & INDUSTRIAL RELATION

The year saw exemplary collaboration between managers and workers of the Company in adapting various process improvements and modernization projects. There is complete cordiality between management and its workforce based on mutual trust. The practice of rewarding performance bonus has been maintained.

One of the Senior Managers of the Company, Mr. Ramesh Goyal (General Manager -Engineering), was found indulging in tampering of Company's EDP structure and stealing of proprietary technical and commercial data.

The Company has initiated legal proceeding against Mr. Ramesh Goyal for data theft under IT Act - section 66.

ENVIRONMENT & POLLUTION CONTROL MEASURES

The Company has successfully transitioned to ZLD (Zero Liquid Discharge) – a monumental step towards water conservation. The Company is first of its kind in the Indian landscape of Leather Chemical production. This water reclaim system is based on Mechanical Vapor Recompression (MVR) technology using vacuum evaporation and condensation for reclaiming distilled water out of the waste streams.

Environmental Policy outlined under ISO 14001:2004 for improving the working environment continues to yield improvements in housekeeping, safety and security at work place.

ACKNOWLEDGEMENT

The Directors extend their most sincere thanks to all employees for their support in easy adoption of new production systems, technologies and environmental policy. Company's suppliers, dealers, service providers, and technical consultants have continued their whole hearted support and the Directors deeply appreciate their role. B) TECHNOLOGY ABSORPTION

a) Research & Development (R & D)

1. Specific area in which R & D was carried out:

The Company reviewed various testing methods of incoming and outgoing materials and adopted automated titration and testing of key quality parameters. The new generation auto- titrators were imported from Mettler Switzerland and have been standardized and calibrated for testing of intermediates and final production.

The Company undertook research to automate weighing and filling of packing containers. Based on demonstrations from various vendors, Mettler –India, a global leader in filling system, supplied three filling system (phase-wise) based on their state of the art PLC based controller for a very high accuracy during filling. Three workshops have been equipped and the remaining work will be completed before Dec 2017.

The Company carried out research on PVC additives range in collaboration with a foreign consultant. The research focused on fusion, film casting and extrusion behavior of processing aids and impact modifiers. Some tests were outsourced in India and abroad and comparison of technical parameters with leading brands. Based on the test reports, production formula and parameters were optimized and pilot trials have been concluded satisfactorily.

2. Benefits derived as a result of above R&D.

The Mettler-auto-titrator platform has significantly reduced testing time, improved accuracy and repeatability. The simplicity of the test platform has allowed complete de-skilling of testing that earlier required a qualified chemist. The Company is now able to share test data with customers for quality standardization and complaint investigation. The automatic filling system has immensely reduced process time during filling and yielded quick turnaround of mix vessels and reactors. The packings are free from any spillage marks that earlier required post – fill cleaning. The operators do not require any special skills now and can be trained within hours that earlier required weeks.

The analyses of fusion behavior of PVC additives on Torque - Rheometer enabled the Company's experts to trace the difference between Company's products and foreign competitors. The iterations of the process and formula that was earlier directionless were made easy; Company's scientists were able to modify target based performance parameters.

3. Future Plan of Action:

The Company plans to automate powder transfer and certain technologies will be tested on pilot scale during the year. It has been felt that in future, powder bag dumping, reactor charging, bagging and palletizing need to be de-skilled due to shortage of qualified operators for reactors. With the culture of increased safety at workplace and containment of powder spills, modern powder transfer technologies need to be adopted sooner than later.

The Company plans to review the wet scrubbing system for Syntan plant. Instead of a wet scrubber, a dry pulse bag filter technology will be adopted to contain fine dust Generated during the spray drying process in Syntan plant. An initial viability study has proved immense benefit of adopting a pulse bag filter instead of a wet scrubber. This would improve the finished product yield and reduce waste water generation.

A new Disc type Reverse Osmosis water purification technology will be evaluated. This can reduce the amount of waste water assigned for treatment using the MVR evaporation and condensation. With the current momentum in waste water reduction the Disc type RO has immense potential for energy saving in treating waste water.

C) TECHNOLOGY ABSORPTION, ADAPTATION & INNOVATION

- The indigenously developed technology for Polyurethane Dispersions (PUD) for leather sector and PVC additives for plastic industry have been commercialized. The technology of "Polymeric Fatliquor" is yet to be commercialized and the Company wishes to restrict to marketing of small lots using the pilot plant as Indian markets are not responding well to this technology due to cost constraints.
- All previously imported technologies have been fully absorbed and commercialized.

MANAGEMENT DISCUSSIONS AND ANALYSIS REPORT

1. Industry Structure:

The Indian leather industry is spread in different segments, namely, tanning & finishing, footwear & footwear components, leather garments, leather goods including saddlery & harness, etc.

The leather industry occupies a place of prominence in the Indian economy in view of its massive potential for employment, growth and exports. There has been an increasing emphasis on its planned development, aimed at optimum utilization of available raw materials for maximizing the returns, particularly from exports. Indian leather industry today has attained well merited recognition in international markets besides occupying a prominent place among the top foreign exchange earners of the country.

2. Opportunities & Threats:

Opportunities:

The leather sector offers a good potential which Indian entrepreneurs can exploit in Germany and other EU and US markets characterized by ever growing competitiveness in terms of price and quality on one hand, and the environmental considerations on the other. With a strong foothold that the Indian leather industry has had for long in these markets, and its advantage of raw material and labour resources, Indian leather exporters can, mount a concerted marketing campaign to wrest a share consistent with their inherent strength and potential.

Threats:

There are some structural aspects of Indian economy and business ecosystem which pose a long term threat to Indian leather industry. The major part of the industry is unorganized ; there is Limited scope for mobilizing funds through private placements and public issues (many businesses are family-owned); the tanneries often report difficulty in obtaining bank loans resulting in high cost of private borrowing; there are stricter international standards on banned substances and environmental and safety regulations. In addition, some new political overtures on slaughtering, and cattle sale can disrupt the industry seriously.

3. Segment-wise or product-wise performance:

Product-wise, the Company continues to maintain its market share in high performance wet-end products (Fatliquor). The competition in Synthetic Tanning Agents, being a commodity item, has kept the margins very tight inspite of increase in energy and manpower cost. Any effort to increase prices in this segment results in losing some market share. However due to high quality, the foreign customers have no issue with the prices. In the Finishing Chemical segment, Company's PUD s and compacts are being recognized well and there is increase in demand as well. These products have a high value addition and the Company will continue to invest in their promotion, in domestic and international markets. About 15 new high value added products have been released to target imports, and Company hopes to gain market share in this segment.

The sales in domestic sector are stable inspite of recession in the industry. The sales can grow further but Company s tight credit control will need to be loosened. The export operations of the Company are not growing due to lower capacity utilization in China market.

4. Outlook:

The leather industry has undergone a dramatic transformation from a mere exporter of raw materials to that of value added finished products. Policy initiatives taken by the Government have been instrumental to such a transformation. In the wake of globalization of Indian economy supported with liberalized economic and trade policies, the industry is poised for further growth to achieve greater share in the global trade.

5. Risks & Concerns

Taking a broader and long term view, here are some risks that Indian leather industry and political leadership needs to address. A major concern is disruptive economic policies like demonetization, tax rationalization and amendments from time to time. Small and medium sector of leather industry is not prompt to respond to quick changes in government policy changes. Besides, forex fluctuation, increase in laborcost due to inflationary trend, lack of strong presence in the global fashion market pose some serious risks to the industry..

There is a serious concern, unless the State Govt. or local body take initiatives to improve Industrial infrastructure at Jind Jind region that lacks good roads and connectivity. Availability of technically trained personnel is becoming a challenge. These factors in very long term could destabilize the Chemical industry in Haryana.

6. Internal control systems and their adequacy

Company's internal control focused on reliable financial reporting, and compliance with laws, regulations and policies. The accounting and auditing assured achievement of in operational effectiveness and efficiency. Management information systems demand forecast, purchase and production planning are integrated with SAP based system with transparency for key personnel. The data security has been tightened online or offline.

Regular reconciliation of stocks and receivables resulted in improved cash flow, timely payment to creditors. Stricter cost control measures, monitoring of financial transactions and logistics cost resulted in significant savings.

7. Discussion on financial performance with respect to operational performance

The profit for the current year has been maintained at same level as that of previous year (2015-16) inspite of drop in sales revenue. This was possible due to: (a) reduced expenditure in maintenance, R & D and marketing cost, (b) lower raw material cost and (c) increase of miscellaneous income. The cash flow improvement is attributed to lower inventory holdings, stricter credit controls and faster production cycles and deliveries.

8. Material developments in Human Resources / Industrial Relation front, including number of People employed

The Company's talent pool remains adequate. There are no unresolved grievances of workers who have exhibited strict discipline and cordial relations with the management. Bonuses and increments have remained aligned with market trends across all levels of employees.

Number of employees as on 31.03.2017 was 89.

- All persons shall deal fairly with employees of the Company. They shall not take any unfair advantage of anyone through manipulation, concealment, abuse of confidential, proprietary or trade secret information, misrepresentation or other unfair dealing-practices.
- All persons shall not indulge in the activity of subscribing or buying or selling the Securities of the Company, which may be in contravention of the policies prescribed by SEBI in the matter of Insider Trading. Such persons shall not misuse any unpublished price sensitive information about the Company with others.

NOTE 27

SIGNIFICANT ACCOUNTING POLICIES

i) Accounting Convention

The financial statements are prepared and presented in the format prescribed in the schedule III of the Companies Act, 2013 ("the Act"). The disclosure requirements are presented as per the Companies (Accounting Standards) rules 2006, read with the General Circular 15/2013 dated 13th September, 2013 of the Ministry of Corporate Affairs in respect of section 133 of Companies Act, 2013.

ii) Fixed Assets

Fixed assets are stated at cost (net of CENVAT) less accumulated depreciation. Cost of acquisition is inclusive of freight, duties, taxes and other incidental expenses.

iii) Depreciation / Amortization

- i) Pursuant to applicability of Schedule II of Companies Act 2013, with effect from 1st April, 2014. The Depreciation on fixed assets is provided on straight line method in accordance with applicable Schedule of the Companies Act, 2013.
- ii) Residual values of assets have been considered at 5% of the original cost of the assets.
- iii) The depreciation calculation is based on the balance useful lives of assets and shift working. Depreciation on assets used on double shift basis have been increase by 50% for that period and Depreciation on assets used in triple shift basis have to be calculated on the basis of 100% for that period, Except for assets in respect of which no extra shift depreciation is permitted (indicated by NESD in Part C of the schedule).

iv) Inventories

- a) Raw materials have been valued at cost on FIFO method.
- b) Stores & Spares and Packing material have been valued at cost on FIFO method.
- c) Work in Process has been valued at Raw material cost plus proportionate conversion cost.
- d) Finished Goods lying at factory have been valued at Raw material cost plus conversion cost including Excise duty payable.

v) Transactions in Foreign Currency

Foreign Currency transactions are recorded at the exchange rate prevailing at the date of transaction and monetary items denominated in foreign currency are restated at rates prevailing on the date of balance sheet. The exchange fluctuation arising is shown as "Foreign Exchange Fluctuation Gain / (Loss)" in the statement of profit and loss as per the requirement of AS 11.

vi) Employee Benefits

The Company has various schemes of retirement benefits such as provident fund, gratuity and leave encashment, which is dealt with as under:-

- A) The Company has taken Group Gratuity Policy from LIC and the fund value as on 31.03.2017 was Rs. 8789.13 Thousand.
- B) The provision for Leave Encashment has been taken on the basis of actuarial valuation. As per the actuarial valuation report the provision for leave encashment has been determined as Rs. 634.08 Thousand as on 31.03.2017.
- C) Contribution to Provident Fund are made in accordance with the provisions of Employee Provident Fund and Misc. Provisions Act, 1952 and charged to revenue every year and this is in conformity as per the requirement of AS 15.

vii) CENVAT

The balance in the Service Tax and CENVAT account is shown under the note "Short Term Loans and Advances".

viii) Revenue Recognition

- A) Revenue is recognised upon the sale of goods i.e. It is recognised at the time of transfer of significant risks and rewards of ownership to the buyer.
- B) Interest from bank is recognised on accrual basis.

ix) Recognition of Expenses

Expenses are recognised on accrual basis and provisions are made for all known losses and liabilities.

x) Accounting for Taxes on Income

Provision for taxation for the year is ascertained on the basis of assessable profits computed in accordance with the provisions of the Income Tax Act, 1961.

Deferred tax is recognised, subject to the consideration of prudence, on timing differences, being the difference between the taxable income and the accounting income that originates in one period and are capable of reversal in one or more subsequent periods. In respect of carry forward of losses and unabsorbed depreciation, deferred tax assets are recognised based on virtual certainty that sufficient future taxable income will be available against which such deferred tax asset can be realized.

- xi) Provision involving substantial degree of estimate in measurement are recognised when there is a present obligation as result of past events and it is probable that there will be an outflow of resources. Contingent Liabilities are not recognised but are disclosed in the notes. Contingent assets are neither recognised nor disclosed in the notes to the financial statements.
