

Your Directors here by present the 26th Annual Report together with the Audited statements of Accounts for the financial year ended on 31st March 2016.

OPERATIONS REVIEW:

During the year under review due to financial crisis company has not carried out any business activities and faces huge set back. So company not in position to generate any revenue from the operation but due to some fixed cost company posted Net Loss of Rs. 481691/-.

BRIEF DESCRIPTION OF THE COMPANY'S WORKING DURING THE YEAR/STATE OF THE COMPANY'S AFFAIR:

The Company does not have any significant business activity and not carried out any business during the year under review.

DIVIDEND:

Considering the loss incurred in the current financial year and accumulated losses, your Directors have not recommended any dividend for the financial year under review.

The Company has not transferred any amount to Reserves for the period under review.

SHARE CAPITAL:

During the year under review, Company shift its registered office from One City Vadodara to Other City Ahmedabad in same State of Gujarat vide result of postal ballot dated November 26 2015.

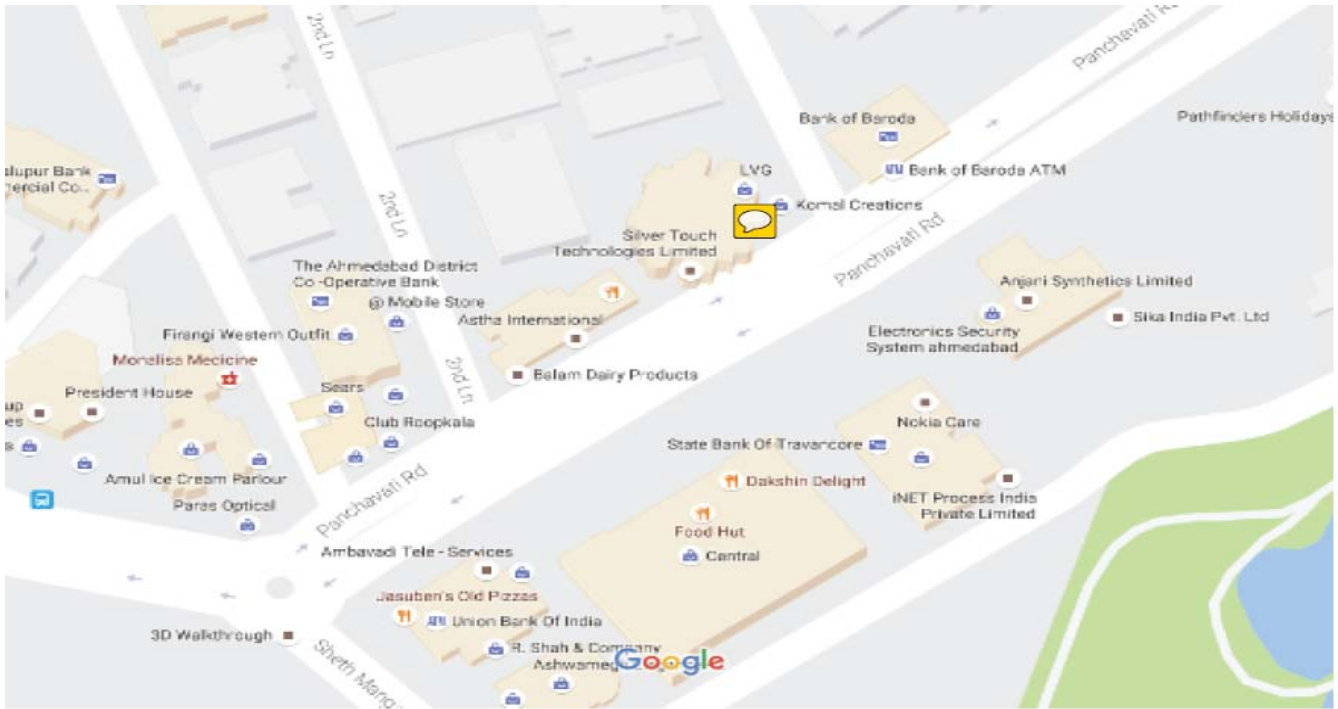
