EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT,2013

The following explanatory Statement pursuant to provisions of Section 102 of the Companies Act, 2013 (including any statutory modification(s) thereto or re-enactment(s) thereof for the time being in force), sets out all material facts relating to the business items of the accompanying Notice.

ITEM NO:4

Mr. Mehul Manubhai Shah (DIN NO 07858648) was appointed as an additional director by the board of directors of the Company w-e-f 25.07.2017. Pursuant to the provisions of Section 161 of the Companies Act, 2013 Mr. Mehul Manubhai Shah will hold office upto the date of ensuing AGM.

The Company has received from Mr. Mehul Manubhai Shah (i) consent in writing to act as a director in Form DIR 2 pursuant to Rule 8 of Companies (Appointment & Qualification of Directors) Rules 2014, (ii) Intimation in Form DIR 8 in terms of Companies (Appointment & Qualification of Directors) Rules 2014, to the effect that he is not disqualified under sub section (2) of Section 164 of the Companies Act, 2013 and (iii) a declaration to the effect that he meets the criteria of independence as provided in sub section 6 of Section 149 of the Companies Act, 2013.

The resolution seeks the approval of members for the appointment of Mr. Mehul Manubhai Shah as an Independent Director of the Company upto 24th July 2022 pursuant to section 149 and other applicable provisions of the Companies Act, 2013 and the Rules made thereunder. He is not liable to retire by rotation.

Corporate Overview

Canopy Finance Limited (Formerly known as Kartavya Udyog Viniyog Limited), incorporated on 26th June 1981, having its registered office at M/s Prezents, Maniram Dewan Road, Bamunimaidan, Opp. Anuradha Cinema, Guwahati-781021 . The Directors of the company are Mr. Ashish Trivedi , Mr. Raj Kumar Sharma, Mr. Om Prakash Trivedi and Mrs. Vinita Agarwal.

Significant accounting policies

Basis of Preparation of financial statements.

The Company maintains its accounts on accrual basis following the historical cost convention in accordance with generally accepted accounting principles ["GAAP"] in India. GAAP comprises mandatory accounting standards as prescribed under section 133 of Companies Act, 2013 (the Act) read with Rule 7 of Companies (Accounts) Rules, 2014, the provisions of the Act (to the extent notified). Corporate Overview
