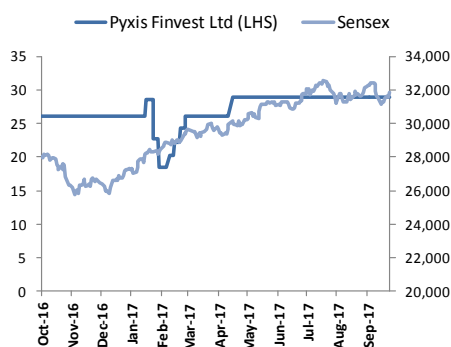

Pyxis Finvest Ltd reported a 58.5% YoY increase in total income to ₹46.02 million in FY17 from ₹29.04 million in FY16.

EBITDA came in at ₹29.24 million for FY'17 as compared with ₹23.82 million for FY'16.

The company reported a net profit of ₹22.12 million for FY'17 compared to a net profit of ₹14.83 million in the prior fiscal year.

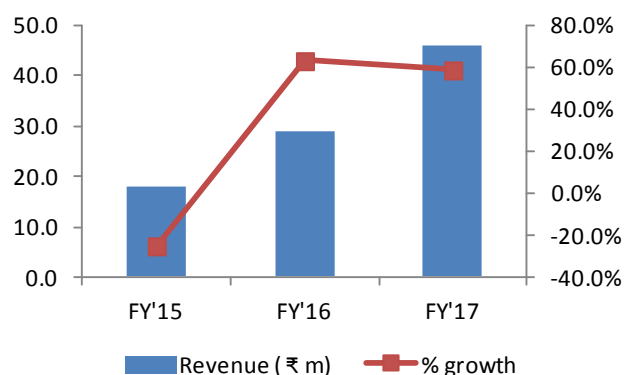

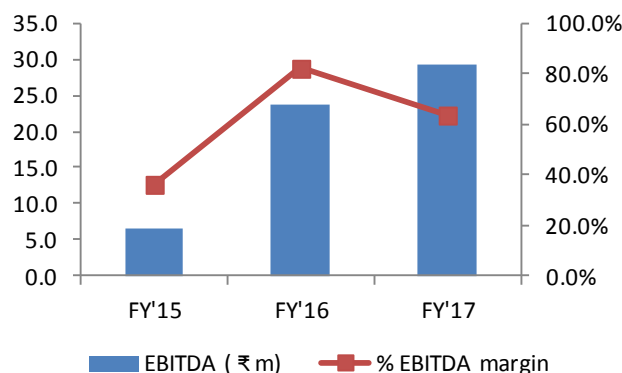

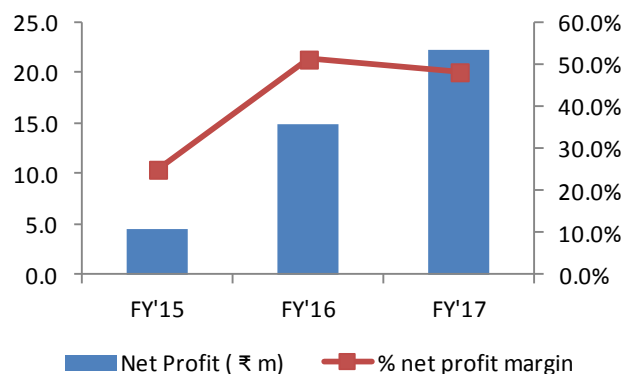
Revenue growth (%)



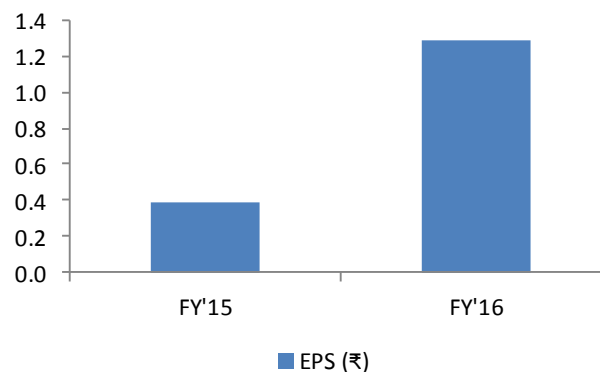
EBITDA margin (%)
