Datasoft Application Software (India) Limited (Datasoft/ the company), is a Listed company in Bombay Stock Exchange that was incorporated on 02nd Day of June 1992 under provisions of the Companies Act, 1956.

The Registered office of Company is currently situated at Plot No. OZ-13, SIPCOT Hi-Tech SEZ, Oragadam, Sriperumbudur Taluk, Kancheepuram District of Tamil Nadu, India, 602105.

Currently, the company is manged by Nandam Family (Mr. Eswara Rao Nandam and Mrs. Uma Nandam) who acquired the shares of DataSoft through a Share Purchase Agreement and followed by open offer in the year 2022.

The Company was not doing business when it was acquired and the new promoters acquired the Company with an intention to carryout the following business of software related activities in future:

- a. Unified Payment Interface Services.
- b. IOT enabled Radio Frequency device software
- c. Establishing and Managing Cloud and Data Centres
- d. Data receiving, Analysing, Data transmission, Data distribution and related activities.

In order to carry out the aforesaid business, the Company has leased a premises and has informed Exchange on 07th -Dec-2023 that the Board has proposed to shift its registered office to No – 42, Commercial Complex, Hiranandani Parks, Senthamangalam Village, Chengalpattu District, Tamil Nadu – 603 204 w.e.f. 1st January 2024. Further new promoters will invest in the Company to develop its business operations in line with the vision of envisaged acquisition.
