# Modification to the Methodology of S&P BSE AllCap Indices

**MUMBAI, JUNE 14, 2017:** Asia Index Private Limited announces methodology changes to the S&P BSE AllCap, Size, and Sector Indices. The following changes will be implemented with the September 2017 rebalancing:

<b>Change</b>	<b>Current Methodology</b>	<b>New Methodology</b>
<b>Rebalancing Reference Dates</b>	Third Friday of the month before the rebalancing date.	Last trading date of January, April, July and October.
<b>Constituent Selection</b>	Stocks must have an IWF, as of the rebalancing reference date, greater than or equal to 10% to be eligible for selection.	Stocks must have an IWF, as of the rebalancing effective date, greater than or equal to 10% to be eligible for selection.
