



- Despite across broad-based losses in December, Indian equities clocked up respectable performance in 2022. The S&P BSE SENSEX gained 6% - its seventh consecutive year of gains.
- Smaller Indian companies lagged blue chips: the S&P BSE SmallCap slipped 1% in 2022, while the MidCap index also fell slightly behind, rising 3%
- The majority of S&P BSE industries and sectors were up for the year, with Power and Utilities the top performers, gaining 29% and 25%, respectively.
   As sentiment towards tech soured around the world, the Teck industry and Information Technology sector were the year's laggards, shedding 18% and 23%, respectively.
- In a sign of the market's confidence in major reforms for Public Sector Undertakings announced by the Minister of Finance, S&P BSE PSU was the best performing Indian equity strategy, up 28%. The S&P BSE IPO Index, last year's runner-up, plunged 28% to take the bottom spot for 2022.
- Most of our reported Indian fixed income indices gained this year. The S&P BSE India 10 Year Sovereign Bond Index advanced 5% but was pipped for the top spot by the Utilities segment of the S&P India Corporate Bond Index, which rose 5.5%. The USD denominated iBoxx ADBI India was at the back of the pack, giving up 9% on the back of the 11% weakening of the rupee against the U.S. dollar.
- Indian investors might have had their interest piqued by the continued strong run of the S&P BSE 100 ESG Index, which outperformed its parent index for the fourth year running, if only just.
