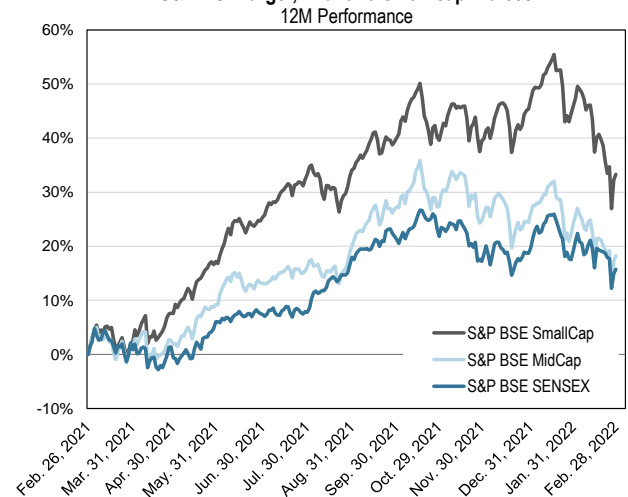

Summary

- Indian equities performed roughly in line with broad international equity benchmarks, with the S&P BSE SENSEX giving up 3% in February.
- Medium and smaller-sized Indian companies trailed large caps, with the S&P BSE MidCap shedding 5% and the S&P BSE SmallCap declining 9%.
- Utilities and Metal were the best-performing S&P BSE sector and industry respectively, as the former slipped by 1% while the latter added 10% in February.
- Among Indian equity strategies, Quality, unchanged month-on-month, led, while at the other end of the spectrum, the S&P BSE IPO dropped 12% in February, extending its year-to-date decline to 20%.
- Dovish messaging by Reserve Bank of India officials after their February rate setting meeting helped both sovereigns and corporate bonds to positive returns in February, with 10-Year sovereign bonds benefitting most, advancing 4% this month.
- In the ESG space, following three straight years of outperformance, the S&P BSE 100 ESG performed in line with its parent index in both February, and year-to-date.
