

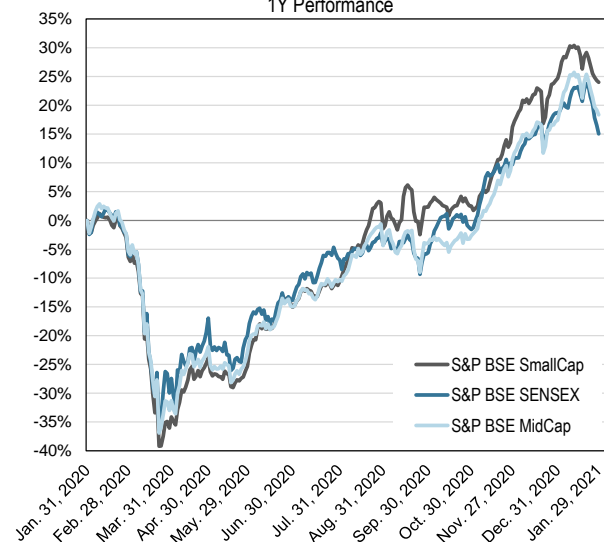

Summary

- Indian equities deviated from the rest of the world (which saw flat or positive gains) and slid in January. The S&P BSE SENSEX saw consecutive declines in the final six days of trading to post a loss of 3% this month. Mid-cap equities offered some relief for investors, gaining 1% amongst a sea of red.
- Most S&P BSE sector and industry indices closed the month lower. Telecom, Industrials and Information Technology bucked the trends, with gains ranging from 2% - 6%. Energy and Metal saw the largest declines, giving up 6% and 5%, respectively.
- Only two of our reported Indian equity strategies rose this month. Enhanced Value and Low Volatility made an odd couple, gaining 3% and 0.4%, respectively. Momentum lagged more than the broader market to post a loss of 5%.
- Most Indian fixed income indices started the year of in the black, the S&P Indian Sovereign Inflation-Linked Bond Index was the noticeable exception declining 1% in January and also giving up 0.4% over the last three months, suggesting a slight dip in local inflation expectations.
- Environmental, Social and Governance (ESG) indices in India provided some relief for investors, declining less than the SENSEX, with the S&P BSE Greenex Index, which focuses on more energy efficient companies finishing in the green, with a gain of 1%.
