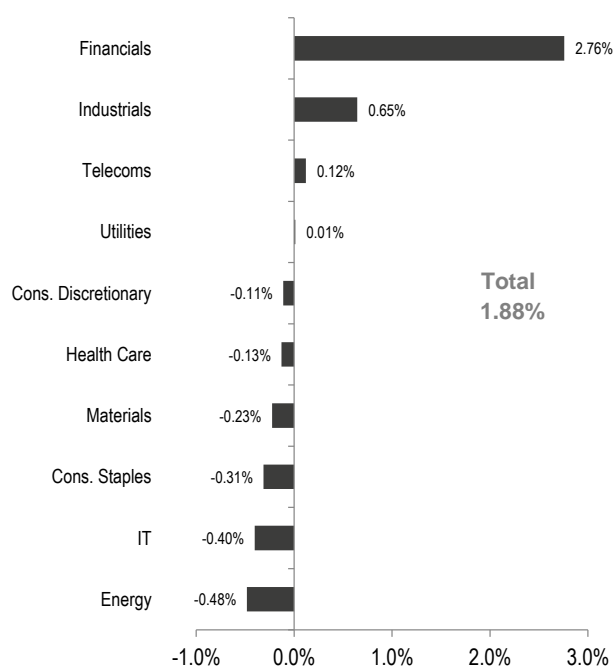

Summary

- The Indian elections brought a sigh of relief to Prime Minister Modi, who secured a convincing win for the BJP in the world's biggest elections.
- Driven by an optimistic outlook following the election results, the S&P BSE SENSEX finished May with a rise of 2%, bringing its YTD gains to 10%.
- Among S&P BSE sectors, Financials and Industrials led the way in May, gaining 6% and 5% respectively. Energy finished with a decline of 2%, driven by a drop in oil prices, but was not the worst performing sector; Health Care and Information Technology declined 7% and 3%, respectively.
- The S&P BSE IPO and S&P BSE PSU were the best performing equity strategies in this month's dashboard, both rose 5%.
- All of our regional fixed income indices finished the month in positive territory; although none as much as the S&P India Sovereign Inflation-Linked Index, which rose a whopping 10% in May.
