

## Summary

- Our broad-based Indian equity indices continued their vigorous Q4 rally in November with the S&P BSE SENSEX rising 3.9% during the month.
- Although the bullish sentiment was widespread, smaller companies lagged their larger peers; the S&P BSE SmallCap clocked up a more modest 2.5% gain.
- All but one Indian strategy index ended the month in the black. The S&P BSE Enhanced Value topped the leaderboard with a 9.9% gain while the S&P BSE IPO was the outlier, down 2.2%.
- S&P BSE Metal, up 8.0%, and S&P BSE Oil & Gas, up 6.8%, were the best-performing sector and industry, respectively. Utilities and Power were the two laggards, off 2.5% and 3.1%, respectively.
