## Company Profile

Hindustan Mills Ltd was incorporated in 1873 under the leadership of Sheth Thackersey Moolji. It is a small cap company operating in the textiles sector. Mr. Raoul Thackersey and Mr. Chandahas Thackersey are the promoters of the company. Mr. Raoul Thackersey, the Chairman and Non-Executive Director, is a commerce graduate and is associated with the company for more than 10 years handling various operations in various capacities. Mr. Chandahas Thackersey, the Vice Chairman and Non-Executive Director, is a commerce graduate having wide experience in textile industry. He is associated with the Thackersey Group since 1975. The promoter group holds 59.8% of the total shareholding, while the rest of the shareholding lies with the institutional (0.1%) and non-institutional shareholders (40.1%).

Its registered office is in Mumbai, Maharashtra. It has three plants namely textile unit, engineering unit and composite unit located in Karad in Satara District of Maharashtra. The plant has machinery from textile machinery manufacturers like Trutzchler, Sulzer and Luwa among others. During FY 2015, the company employed 486 employees.

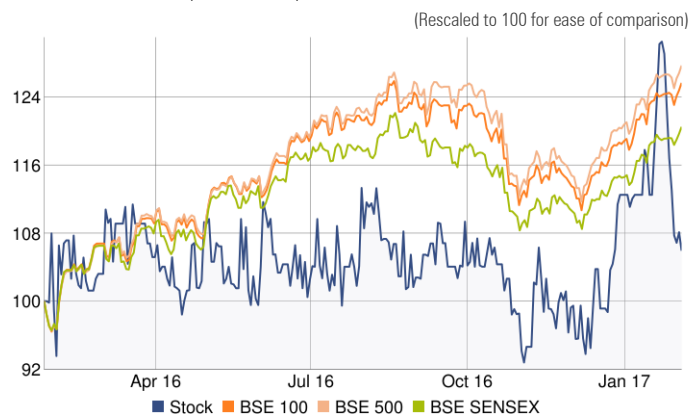

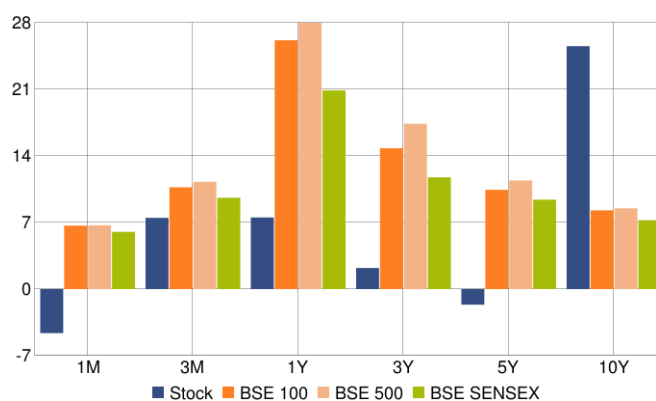
