Quarterly result review – March 2016

For the fourth quarter ended March 2016, TCM Ltd did not report any revenues. However for the prior year quarter, the company reported other income of \$ 0.21 million.

EBITDA came in at a negative ₹0.91 million during the quarter compared to a negative ₹0.97 million in the prior year quarter.

Net loss for the quarter was ₹1.07 million compared to a net loss of ₹1.15 million in the prior year quarter.









Financial Snapshot
