Quarter results overview

Result performance review

- Hipolin reported quarterly results for June 2014. The company's operating income declined by 9.4% on a year on year (YoY) basis during the quarter. Its expenses were down by 7% YoY during the same period.
- Fall in revenues led the company report an operating loss of Rs 1.5 m during the quarter as compared to profit of Rs 0.3 m during the same quarter of the previous year. Consequently, the operating margins got impacted and declined to -2.1% during the quarter.
- Other income increased by 47% YoY. While depreciation increased by 14% YoY, interest charges declined by 18% YoY for the June 2014 quarter.
- The company reported net loss of Rs 0.6 m during the quarter as compared to net profit of Rs 0.2 m in a year ago quarter led by fall in revenues.


