

The Company manufactures detergents, tooth pastes and shaving creams. It exports its products to Russia. In 1994-95, Hipolin Products and Hipolin Surfactants were amalgamated with the Company. Also, Hipolin took over the business of Ramit Traders and Fresh Laboratories. During the year 1995-96, the Company has started generation of electricity through wind farm technology.


