Givo is led by Mr. Karan Singh Thakral, the Chairman and Director; Mr. Praveen Saran, the Chief Executive Officer; and Mr. R. K. Sharma, the Chief Financial Officer, Secretary and Compliance Officer along with the other directors.

The promoter holding in the company constitutes 74.3% of the total share capital. Institutional investors hold a total of 3.7% and the non-institutional investors hold 22%.

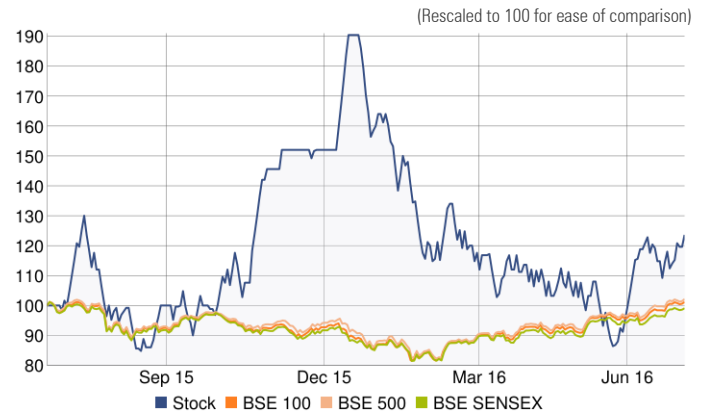

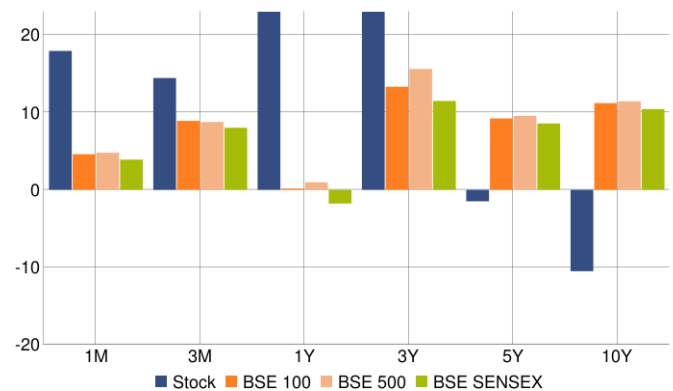
