In 2012, the company changed its name to Bharat Agri Fertiliser & Realty Ltd. to reflect a change in business. It is engaged in construction and development of residential and commercial complexes, and manufacture of fertilizers. Its registered and corporate offices are located in Mumbai, Maharashtra. Its plant is located in Wada, Palghar District in Maharashtra. The company has an under construction project at Thane and owns surplus land at Wada in Maharashtra. Yogendra D. Patel is the Chairman & Managing Director of the company. Shailendra D. Patel is the C.E.O – Fertiliser Division.

The promoter family holds about 67.7% of the total shareholding, while the rest of the shareholding lies with non-institutional shareholders.

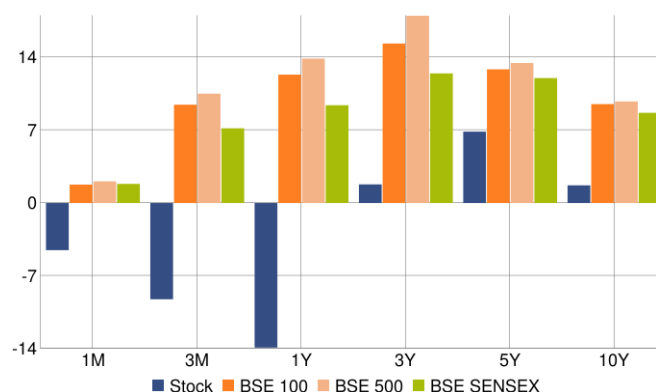
