

# Annual result review – March 2016

Pyxis Finvest Ltd reported a 62.9% YoY increase in total income to ₹29.0 million in FY16 from ₹17.8 million in FY15.

EBITDA margins however improved substantially in FY16, reaching 82.0% from 36.2% in FY'15.

The company reported a net profit of ₹14.8 million or ₹1.29 per share for FY'16 compared to a net profit of ₹4.45 million or ₹0.39 per share in the prior fiscal year.


