Annual result review - March 2016

Samruddhi Realty Ltd reported a 4.0% YoY decline in total income to ₹494.1 million in FY16 from ₹514.4 million in FY15.

EBITDA margins however improved substantially in FY16, reaching 27.4% from 18.8% in FY15.

The company reported a net profit of ₹17.9 million or ₹1.78 per share for FY16 compared to a net profit of ₹20.3 million or ₹2.19 per share in the prior fiscal year.


