Result performance review


- Chemtech Industries Valves Ltd has announced its results for September 2014. The company's net sales increased largely to Rs 217.1 m in 1HFY15 as compared to Rs 145.5 m in 2HFY14.
- The company's expenditure increased to Rs 215.7 m in September 2014 as compared to Rs 140.3 m in March 2014. Operating profit of the company stood at Rs 1.4 m for the first half of FY15 as compared to a Rs 5.2 m in 2HFY14. The decrease in profit was mainly due to a substantial decline in other income and higher expenditure.
- Depreciation increased to Rs 5.7 m. However, interest charges remained unchanged for the period ended September 2014.
- Tax charges decreased and the company's profit after tax was worse when compared to 2HFY14.
