

Chemtech Industrial Valves Ltd total income increased 20.3% on YoY basis to ₹471.31 million in FY'17 from ₹391.93 million in FY16.

EBITDA margins stood at 0.7% in FY'17 compared to 1.7% in FY'16.

The company reported a net profit of ₹1.16 million for FY'17 compared to a loss of ₹28.17 million in the prior fiscal year.








EBITDA margin (%)
