Siddhi Vinayak Shipping Corporation Ltd witnessed 6.4% decline in its total income to ₹27.8 million in FY'16 compared with ₹29.7 million in FY'15.

EBITDA margins deteriorated to 24.3% for the period from 36% in FY'15.

The company reported a net profit of ≤ 3.0 million or ≤ 0.52 per share for FY'16 compared to a net profit of ≤ 5.8 million or ≤ 1.00 per share in the prior fiscal year.








Revenue growth (%)






Net Profit Margin (%)
