# Annual result review – March 2017

Siddhi Vinayak Shipping Corporation Ltd witnessed an 18.4% decline in its total income to ₹22.65 million in FY'17 compared with ₹27.8 million in FY'16.

EBITDA margins deteriorated to 3.2% for the period from 24.3% in FY'16.

The company reported a net profit of  $\mathbf{R}$  0.48 million for FY'17 compared to a net profit of  $\mathbf{R}$  3.0 million in the prior fiscal year.


