## Annual result review - March 2016

For the fiscal year ended March 2016, Anisha Impex Limited reported a 1.7% YoY decline in total income to ₹418.8 million from ₹425.9 million in FY15.

EBITDA margins improved marginally to 2.6% in FY16 compared to 2.4% in FY15.

The company reported a net profit of ₹ 0.97 million for FY16 compared to a net profit of ₹ 1.2 million in FY15.







