

# Annual result review - March 2016

SPS Finquest Ltd total income declined 47.2% on YoY basis to ₹27.4 million in FY16 from ₹52.0 million in FY15.

EBITDA margins improved and stood at 88.8% in FY'16 compared to 51.0% in FY'15.

The company reported a net profit of ₹19.2 million or ₹4.26 per share for FY'16 compared to a loss of ₹0.8 million or ₹(0.18) per share in the prior fiscal year.


