With reference to your E-mail/letter No. (L/SURV/ONL/RV/ZS/(2018-19)/129 dtd: 09.11.2018 on the captioned subject, it is hereby stated that vide letter No. U-37012-2/93-FAC dated: 15.11.2018 (Copy attached), Department of Telecommunication, Govt. of India, has conveyed the approval of Cabinet Committee on Economic Affairs (CCEA) for taking the following measures for procurement quota to M/s ITI LTD in procurement made by BSNL, MTNL, & BBNL:-

- (a) To continue the reservation quota policy for M/s ITI Ltd. by reserving:-
  - (i) 30% of the procurement orders placed by BSNL, MTNL & BBNL for M/s ITI Ltd. for the products manufactured by it and for those outsourced items in which there is a minimum 12% value addition by M/s ITI during 2018-19, 16% value addition in 2019-20 and 20% value addition in 20-21 and
  - (ii) 20% of the orders for the turn key projects (like GSM network rollout, Wi-Fi etc.. of BSNL, MTNL & BharatNet project network rollout etc of BBNL).
- (b) ITI would accept orders under reservation quota only after the price is known and if the same is commercially viable.
- (c) ITI shall exercise its option under reservation quota within 15 days of bid opening.

(d) The aforesaid policy measures shall remain in force for a period of 3 (Three) years with effect from the date of approval of CCEA and shall again be reviewed considering the financial health of ITI as after the expiry of this period.
