From the above, you will observe that the there is no specific price movement except on 22^{nd} March, 2019 and 25^{th} March, 2019 where the price has touched the level of Rs. 40/- or above .It looks that people has made purchases in response to the Notification /intimation about the Board Meeting of the Board scheduled to be held today on 26.03.2019 at 4:00 P. M, to consider the proposal of Buy Back and other incidental matters .

Since the Buy Back of Shares amounts to a price sensitive Information, as per Regulation 29 of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015, we have given the adequate 2 working days' advance intimation to BSE about the above mentioned Board Meeting on 20.03.2019. Other than this, there is no other price sensitive information needed to be intimated to Exchange,.

The Company has made all the necessary disclosures pursuant to regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and has not withheld any material information/event that in our opinion would have bearing on the price behavior of the scrip. The Company shall continue to make applicable disclosures, within the stipulated time.

Therefore, the movement in the share price of the company is purely due to market conditions and absolutely market driven and the management of the company is in no way connected with any such movement in price.
