


Annexure 1 – DR Connection parameters of BOLT Plus Trading system for Equity Derivatives segment

Trading members can connect to the DR site of BOLT Plus trading system using either BOLT TWS

or 3rd party trading application of empanelled vendors or in-house developed systems through ETI APIs as follows –

1. BOLT TWS Users

Trading members shall have to change the technical connection parameters in the configuration settings window at the time of login. Configuration settings window can be invoked using the scrip profile icon or “Shift+F12” shortcut keys on BOLT TWS.
