I, Varuna Mittal, Proprietor of M/s. The Management of the Company is responsible to ensure the compliance with the requirements of the relevant provisions of (i) the Companies Act, 2013 and the rules made thereunder including circular no. 14/2020, 17/2020, 20/2020, 22/2020, 33/2020, 39/2020, 02/2021, 10/2021, 20/2021, 03/2022, 11/2022 and 09/2023 dated April 8, 2020, April 13, 2020, May 05, 2020, June 15, 2020, September 28, 2020, December 31, 2020, January 13, 2021, June 23, 2021, December 08, 2021, May 05, 2022, December 28, 2022 and September 25, 2023 respectively issued by the Ministry of Corporate Affairs ("MCA Circulars") and (ii) the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") with the BSE Limited ("Stock Exchange"), relating to postal ballot by way of e-voting means.
- 2. My responsibility as scrutinizer is restricted to prepare a scrutinizers' report of the votes cast by the members for the resolutions contained in the Notice, based on the data downloaded from website of Central Depository Services (India) Limited ("CDSL"), i.e. <a href="www.evotingindia.com">www.evotingindia.com</a>, authorised agency engaged by the Company to provide e-voting facilities till the time fixed for closing of the voting process i.e. Friday, May 10, 2024 at 5:00 P.M. (IST).

- 3. The Members of the Company as on the "cut-off date" i.e. Friday, April 05, 2024 were entitled to vote on the proposed resolutions to be passed through postal ballot by way of e-voting means as set-out in the Notice of Postal Ballot and their shareholding as on cut-off date has been reckoned for the purpose of arriving at the results of the postal ballot.
- 4. The e-voting period remained open from Thursday, April 11, 2024 at 9:00 A.M. (IST) and ended at the close of working hours i.e. 5:00 P.M. (IST) on Friday, May 10, 2024 on the designated website of CDSL i.e. <a href="https://www.evotingindia.com">www.evotingindia.com</a>.
- 5. On Wednesday, April 10, 2024, the Company had completed the dispatch of Postal Ballot notice to those Members whose name(s) appeared in the Register of Members/ List of beneficial owners as on the cut-off date i.e. April 05, 2024 received from Company/ Depositories/ Depository Participants/ Company's Registrars and Transfer Agents ('RTA') i.e., Alankit Assignments Limited. Pursuant to the MCA Circulars, the Company had dispatched the notice through e-mails only. The Company has not dispatched the postal ballot notice to those members whose e-mail IDs were not registered with the Company and/or Depositories.

However, the Company had also given an option in the Postal Ballot Notice, which was uploaded on the website of the Company (www.jaykayenterprises.com), CDSL i.e. <a href="www.evotingindia.com">www.evotingindia.com</a>, BSE Limited (<a href="www.bseindia.com">www.bseindia.com</a>) and also published by way of newspaper advertisements dated April 08, 2024, in all editions of "Business Standard" (English Edition), and Kanpur edition of "Aaj" (Hindi Edition) to the members to register their email id's with the Company and/ or their depository participants.

- 6. In view of relaxation given by Ministry of Corporate Affairs and Securities and Exchange Board of India, the Company has not dispatched physical ballot. Further, the Company has also not received any physical ballot form and accordingly, voting done through e-voting means only was considered for this report.
